With reference to above, it is to inform that, India Security Press, Nashik has placed Purchase Order No. 4590006834 dated 02.03.2018 for Servicing and Calibration of LV Air Circuit Breaker (ACB): 28 Nos.

2. In spite of Repeated reminders, M/s Sri Sai Power Controls, Hyderabad have not started the work for Servicing and Calibration of LV Circuit Breaker (ACB): 28 Nos. Therefore, ISP has issued a show cause Notice vide ISP letter under reference and informed that this is the violation of clause No. 23 of General Conditions of Contract and requested to submit the explanation within 07 days from the date of issue of letter as to why the Purchase Order No. 4590006834 dated 12.03.2018 should not be terminated and administrative action including ban and black-listing should not be taken against M/s Sri Sai Power Controls, Hyderabad.

3. M/s Sri Sai Power Controls, Hyderabad has not submitted their explanation, therefore, ISP has again issued a letter No. SY-15-13(105)/2016/3100 dated 08 Sep 2020 and requested to submit the explanation but M/s Sri Sai Power Controls, Hyderabad has not submitted their explanation.

4. In view of the above, ISP Purchase Order No. 4590006834 dated 02.03.2018, is hereby stands cancelled. Also the EMD amounting Rs. 11,200/- submitted by M/s Sri Sai Power Controls, Hyderabad against above referred tender will be forfeited to SPMCIL Account.
