The EMD should in the Indian Rupees only.

Since it is turnkey project, any BOM item fall shorts or not mentioned in the BOM but required to complete overall project has to be supplied by the bidder without any additional cost.



Annexure-I

Scope of Work

1. Scope

- a. The scope of work in this specification includes Design, supply, assembly, installation, testing, erection, integration and commissioning software integration, training and performance testing of the complete IP BASED CCTV SURVEILLANCE SYSTEM ON TURN KEY BASIS.
- b. The firm will have to carry out detail engineering, preparation and submission of all drawings as specified in this specification including preparation and submission of area wise bill of materials, layout and erection drawings showing location of all system equipment and components, power and data cables for IP network, cable tray/rack and conduit routing.
- c. It shall include SITC on Turn Key basis of all accessories including secondary power supplies for back up and fail safe operation i.e. hardware, software, supports, data cables, UPS, storage and retrieval media, viewing stations, servers, CAT 6 cables, O.F cable, markers, power cables & conduits, software and software integration, earthing to the equipment, mounts, structures, etc. as required for the satisfactory operation of the system.
- d. This will include fixing of camera using suitable camera mount (as per site requirement) complete with required civil and fabrication works, creating backbone for the system by laying the required data and power cables cable laying & termination/splicing of all cables, fixing of cable trays, conduits, installation and commissioning of all items supplied under CCTV system as required basis.
- e. Mounting & installation of Servers, Racks recording/storage devices, viewing stations and connecting to network
- f. Mounting and Installation of LED Screen and connecting them with operator workstation.
- g. Installation and configuration of Core Switch, Access Switch and all active, passive components.
- h. Integrating the whole system for optimum performance.
- i. The proposed Cameras will be installed on dedicated poles wherever required. The cameras at various sections are to be installed on walls or on Trusses where walls are not available, using proper mounting brackets and pipes duly painted and finished complete with Fasteners, clamps to support the required load. Supply & Erection of poles is under scope of Supplier.
- j. Erection and commissioning of networking e.g., cables (UTP/OFC thru' conduit/cable tray), network panels, switches, enclosure, switch media converter, LIU, patch cords etc.
- k. The firm shall bear full responsibility for all kinds of maintenance which include periodic maintenance as well as attending to all break-down and emergency calls at short notice whenever called during the Warranty & CAMC period.
- l. All the software's supplied shall be perpetual licensed software's.
- m. Providing Application software OEM copies along with license keys and passwords.
- n. The Warranty period for complete system shall start from the date of issue of Final Acceptance Certificate.
- o. The successful firm will have to give the escalation matrix.



- p. All flexible cables shall be laid in GI/PVC Casing Capping (Industrial) conduits/flexible PVC conduits with proper markings.
- q. Bidder shall supply and install the, necessary CAT6 interconnecting cables, patch cords, jacks, jack panels, trays, conduits and other accessories as required for the satisfactory operation of the system along with any other devices and components for completion of the systems.
- r. The firm will have to Supply install Test and commission Earthing system for the whole IP based Camera system. Earthing pit with all required items for proper earthing as per IS Standards.
- s. The supplier shall inform day-to-day progress of the work to the Engineer In Charge /authorized representative of ISP, Nashik.
- t. All the cabling of new IP based system shall have separate identification markers/cables tags of permanent nature with clear marking for easy identification of the individual camera/zone/cabling.
- u. All the cabling, conduit and installation shall be laid as per relevant standards or practice in vogue and shall have aesthetic look.
- v. Identification tags to be installed on each cable.
- w. Any additional equipment, components and/or changes in design of equipment to fulfil the operational requirements, even though not explicitly mentioned shall be under the scope of bidder.
- x. Electrical Works:
 - i. Electrical cabling of system components, UPS, Supply Installation & commissioning of Distribution Boards, UPS DB loaded with MCB all under scope of supplier.
 - ii. The power is to be tapped from source as per instruction of Electrical Section manager of ISP, Nashik.
 - iii. All electrical components to be supplied & installed shall have ISI marks and heavy duty to work in industrial environment.
- y. Civil Works: Any civil works to meet the system requirement would be under the scope of supplier such as but not limited to
 - i. Civil works involved in laying of cables underground
 - ii. Fabrication, fixing support for camera mounts, poles etc.
 - iii. Any damage to false ceiling/ civil structure etc. during the execution of work the firm has repair the same without any additional cost.
 - iv. Supply and erection of poles as per site requirement and demand.
- z. Cable(s) shall be laid in underground trenches, ducts, channels, tunnels, on racks, trays, in HDPE PLB pipes along structure or buildings as per the site conditions. The cable shall be laid in underground trenches through GI pipe specially when laid through rail crossing, road crossing, hard standing etc.
- aa. The SELLER shall do fabrication/ modification work, if any, involving erection of cable supporting structures, welding/ gas cutting, etc. at site as per the actual requirements.
- bb. All cables shall be tested for proper continuity and insulation as per the statutory standards/rules before laying.
- cc. Connecting of all the active, passive elements with the proposed network through laying of network cable including all network provisions for TCP / IP with I/O Boxes.



dd. LAN Management like Switch configuration, router configuration will be under the scope of supplier.

2. POC (Proof of Concept)

- a. Proof of Concept (POC): Bidder need to demonstrate below mentioned use cases with same quoted make and model as per their respective tender offer-
- b. ONVIF conformant, adding 3rd party CCTV camera to their VMS.
- c. Demonstration of IR features.
- d. Demonstration of limited Analytics as per tender specs.
- e. The purpose/objective of the POC shall be to determine that the solution proposed by the bidder meets the overall functional & technical requirement of the project. Failing POC means, the firm is technically unsuitable. For POC, advance notice of 15 days will be given.
- f. POC will be held at ISP, Nasik

3. System hardening:

The successful bidder should:

- 1. Implement data security, network security and physical security measures and best practices for securing the CCTV Server and its software against cyber-attacks. This includes security considerations for the hardware and software of servers, clients and network device components of new CCTV surveillance.
- 2. Incorporates standards-based and best-practice-based security and privacy controls and maps them to each hardening.
- 3. Apply appropriate measures from manufacturer's system hardening guide.
- 4. Remove all default, installer, or temporary user accounts and passwords used during installation that are not part of End-user's final operational requirements.
- 5. Assign new passwords that are substantially different from factory default passwords to user accounts that match factory-default user accounts.
- 6. "No Malicious Code" undertaking letter by OEM's Global HQ. The OEM must not be barred by any Global CERT organization for malicious code or security threats.
- 7. The quoted equipment should neither support any interconnection / communication protocol, (such as the GB/T 28181 protocol), that requires sharing of information or data with any foreign government or agency. Documentary certification from OEM needs to be given.
- 8. MAC address of devices must be registered in the same name of OEM supplying the devices.
- 9. The supplied relevant items should have ONVIF compliance.
- 10. **NO Chinese/Made in China product is acceptable at all**. The Bidder and OEM should provide undertaking for GFR Restrictions on procurement under rule 144 (xi) as per F No. 6/18/2019/PPD dated 23.07.2020.

4. Documentation:

Extensive documentation shall be provided on installation, operation, administration, programming details and maintenance of the various equipment. Three complete sets of hard copy & soft copy should be provided.

The documentation shall necessarily cover the following:



- 1. User, operation, administration and maintenance manuals (3 sets).
- 2. Installation drawings, wiring charts, layout of cables etc (3 sets).
- 3. Detailed Engineering Diagram, signal flow / cabling diagram indicating the complete cable routing and integration of the various equipment blocks, in the system (3 sets).
- 4. User and Technical manuals of the items (1 set).
- 5. System test plan, calibration reports, preventive maintenance charts etc.

5. Installation and commissioning:

- 1. The CCTV project is required to be completed on Turnkey basis. Accordingly, bidder is understood to have assessed and quoted for all the items required for successful completion of the Project. It will be the responsibility of the successful bidder to provide such items on free of cost basis which are not quoted in the bid but otherwise required at the time of installation for completion and successful commissioning of the project. The existing approx. 40 IP based CCTV camera must be integrated with this new project so that total IP camera should be 266 including existing approx. 40 camera in single control system.
- 2. The CCTV system should have designed by the successful bidder in such a way that in near future approx. another 150 nos of camera along with required capacity of storage (90 days) and other required accessories etc. can be integrated in the same architecture.
- 3. The successful Bidder shall offer the services of an installation Team which shall be responsible to install and commission the entire system. The whole project will be carried out directly under the supervision of OEM's / Authorized representative's technical team.
- 4. Installation & Commissioning shall be treated as complete after installation of all the systems and sub-systems and issuance of FAC certificate.
- 5. The successful bidder shall ensure themselves during their site visit about any special requirement and its total completeness. Any equipment and technical services which might not be elaborated and specifically not mentioned in the specifications relating to the unit under the scope of supply and not expressly included therein, but necessary for the best performance of the unit in accordance with the specifications for normal and efficient running and maintenance in the said conditions during its life, are to be provided for and rendered by the bidder and hence the bidder has to take care while quoting and specifying for the Technical Tender and to make specific mention on it explaining its necessity.
- 6. Bidders are strongly advised to site visit for better estimation of quantum of work involved.
- 7. There will be a common site visit schedule and all prospective bidders are advised to plan their schedule accordingly.

6. Training

- **1.** The successful bidder shall impart training to ISPN Staff / CISF Security personnel at ISP site for complete operation of the equipment and software.
- **2.** The successful bidder shall impart training to ISPN Staff at the ISP site for operation & maintenance of the equipment/system/server etc.

7. Safety:

1. The successful bidder to whom the project has been awarded by INDIA SECURITY PRESS, NASHIK will be primarily responsible for ensuring safety of all their employees working under them while they work inside Factory premises.



- 2. Electrical connection will be taken only with the written permission from the concerned engineer of ISP. Any unauthorized connection which is found to be of imminent danger to the safety of the employees will be disconnected immediately.
- 3. The successful bidder will ensure that their employees do NOT SMOKE inside the factory premises.
- 4. The successful bidder will ensure that the Hand Tools, other Equipment's, Ladders etc. are maintained in good working condition and will also ensure that they are safe and free from risk to the employees and their health.
- 5. All the machines brought by bidder for their work should be properly guarded/maintained in proper condition for their safe working.
- 6. For Working at Height, Welding Work, Gas Cutting work, Excavation Work, Working on Fragile Roof, Working on Electrical Lines or work of similar nature, the bidder and the Bidders will inform the Safety Department in advance. In each case the "PERMIT TO WORK" (Blank Format) will be obtained by the successful bidder from Safety Department of the ISPN.
- 7. The successful bidder will arrange for MEDICAL TREATMENT of their employees in case of serious injury.
- 8. All the lifting machines, lifting tackles, chains, ropes, pulleys etc. will not be allowed to be used inside the Factory unless they are thoroughly examined and certified by the Competent person (as per Factories Act,1948) once in every six months. Such certificate(s) should be produced to the safety department of ISPN before taking them inside the Factory.
- 9. In case of any accident, the successful bidder will arrange to inform it to Safety Department of ISPN immediately. They will also arrange to fill up the necessary forms and provide any information, as required by the ISPN for submitting the same to the Industrial Safety & Health Dept. (i.e. concerned Inspector of Factories).
- 10. Safe use of electricity will be responsibility of the successful bidder.
- 11. Proper "Earthing" should be provided to the Main Switch.
- 12. The source for tapping electrical supply will be shown to the bidder. The bidder has to arrange for separate main switch, wires, and cables of suitable capacity for welding set as per electrical load of the equipment. The wires/cable should be without joints.

8. Security:

- 1. The successful bidder should scrupulously conform to the safety and security norms as stipulated by ISPN while working in the security area.
- 2. The successful bidder shall take all the precaution while executing this work. Protective gear such as safety helmets, boots, belts etc. shall be provided by the bidder at his own cost to all his workers at site. It shall be the responsibility of the successful bidder to ensure that such protective gear is worn at all times by all personnel working at site. ISPN shall have the right to stop any person not wearing such protective gear from working on the site.
- 3. ISPN is a security organization and the Government declares the premise as Prohibited Area. Hence the bidder has to abide by the security rules of the Company. The bidder has to ensure the character and antecedent of the persons deployed. The bidder must be in a position to produce such documents whenever he is asked to do so. Details shall be furnished as per format when called for. The bidder has to issue printed photo identity card to its workers duly authenticated by the designated security officer of the Company. Bidder should apply for Gate Pass for labours, welding permission and material entry pass



- etc. as per approved format only, well in advance to avoid any delay in issue of Gate passes.
- 4. While applying for pass, bidder must enclose copy of address proof (Voters ID card or ration card or driving license or passport etc.), for all the workers for which gate pass has been requested. The details shall be submitted in the prescribed format available from ISPN.
- 5. On award of the contract the bidder shall sign the Non-Disclosure Agreement and abide with that.
- 6. Any worker of the bidder, if found by the Company as unsuitable or having doubtful integrity, shall be removed from the premises at the risk and cost of the bidder. The bidder shall vouch guarantee for the integrity of its workers.
- 7. All the products used in system needs to be malware/Bug free and declaration certificate needs to be provided by the firm at the time of supply.

9. Secrecy:

- 1. All maps, plans, drawings, specifications, schemes and the subject matter contained therein, and all other information given to the successful bidder by ISPN shall be held confidential by the BIDDER, and shall remain the property of ISPN and shall not be used or disclosed to third parties by the BIDDER for any purpose other than that for which they have been supplied or prepared. All such drawings and documents shall be returned to ISPN upon completion of the work under the contract.
- 2. No copies, duplication, Photostat shall be retained by the BIDDER without the written consent of ISPN.
- 3. Maps, Diagram and photographs of the plant including its surrounding regions showing the vital installation for national security of the ISPN's shall not be published or disclosed with the third parties, or taken out of the ISPN without prior written approval of secrecy agreement satisfactory to the ISPN with such third parties prior to disclosure.

10. Final acceptance test and certificates:

- 1. Complete Supply and Installation as per specification and scope of work.
- 2. Complete documentation and license and media handover.
- 3. Checking of all features under working condition.
- 4. Trouble-free operation for 1month.
- 5. Completion of work after following all standard safety and environment norms.
- 6. All the relevant certificates to specified standard is to be provided.
- 7. ONVIF compliance.

11. Comprehensive warranty& Comprehensive Annual Maintenance Contract:

Complete system and its all components will be under comprehensive warranty for 03 years and CAMC of 5 years from the date of issue of final acceptance certificate including all consumables such as Battery, CMOS, UPS, cables etc.

- 1. During Warranty& CAMC, bidder shall maintain the system so that it is operational and running round the clock. The entire 226 camera with live and recording should be 100% up.
- 2. The bidder shall provide Guarantee that every work executed under this contract shall be free from all defects and faults in materials, workmanship etc. and shall be of the highest grade and consistent with established and accepted standards for materials and workmanship of the type ordered and full conformity with the specifications and equipment shall satisfy its intended use.



- 3. Workmanship and operation of all the equipment, accessories etc. supplied by the bidder shall be under warranty for a period of minimum 36 months from the date of taking over the system / issue of acceptance certificate of the system by the ISPN at the site as mentioned in specifications. Bidder shall also provide the total maintenance of the equipment / systems during warranty& CAMC.
- 4. It shall be obligatory on the part of bidder to modify and/or replace any hardware and modify the operating, application and diagnostics software free of cost, in case of any malfunction is revealed during operation after taking over within the warranty period. Also, the bidder must do corrections and up gradation of the software during warranty.
- 5. During warranty& CAMC, the Bidder has to deploy minimum two resident service engineers in day shift only in ISPN from the date of handing over/final acceptance for smooth operation/maintenance/use of the system by various users and also for customizing configuration by way of proper selection existing software/hardware features of the system. The service engineer shall be required to check the health of the system on daily basis and does maintenance work of the System.
- 6. Successful bidder shall periodically carry out Routine Preventive maintenance (Preventive Maintenance after every 3 months) during the entire warranty& CAMC starting from date of final acceptance. The service engineer(s) so deputed shall be qualified and fully conversant with the operation and maintenance aspect of the system and sub-systems (e.g. switches, Workstations, UPS, Cameras, Racks etc.) supplied against this purchase order. Report of periodic maintenance is to be submitted to ISPN officials.
- 7. The wages / salary of the resident service Engineer shall be included in the cost of the project and the ISPN will not separately pay any wages / salary to this purpose.
- 8. Successful bidder shall have all the statutory and legal requirements for engaging manpower. ISPN reserves right to verify the same.
- 9. Successful bidder shall maintain vital spares at ISPN to restore the system immediately in case of breakdown during warranty & CAMC. During warranty & CAMC, all defective / faulty items shall have to be replaced / rectified by the successful bidder without any additional cost.
- 10. Any breakdown of the system or part of the system shall be attended immediately and resolved within a period of 2 hours for major equipment failure and minor equipment failure. Holiday shall not be taken into account for calculating the hours.
- 11. During warranty & CAMC Period, Defective HDD i.e. Hard Disk has to be changed with working one on non-replacement basis. Defective HDDs will be kept with ISPN.
- 12. The Bidder (in case of non-OEM) shall maintain back to back agreement with the OEM's for proper maintenance of Server, PC's, Hardware, software and UPS. The agreement shall remain valid during the warranty Period. Copy of Such Agreement to be provided to ISPN.
- 13. As India Security Press, Nashik has shift operation; the resident service engineers may have to perform shift duty. These engineers are also liable to work on holiday/Sunday/extended hours (if services are required) and no additional amount will be paid.
- 14. ISPN is a security organization; hence successful bidder should submit valid police verification of the deputed engineers. All security norms to be followed by the deputed resident engineers.
- 15. The engineers should be qualified Engineer with an experience of not less than 2 (two) years in Computer/Electronics Hardware, Software & computer network maintenance. The Firm is required to provide evidence in dealing/maintenance in respect of qualification and experience, which would be checked by this Office to verify the suitability/competency of the service engineer.



- 16. The resident service Engineers provided by the firm shall not be changed frequently. However, if found incompetent by the officers of ISPN, the Resident Service Engineer/s shall be changed by the bidder immediately.
- 17. Educational Qualification for resident service engineer Minimum ITI/Three Year Diploma (CSE, ECE, IT) or higher qualification such as B.Tech/B.E (CSE,ECE,IT)/BCA/ MCA/M.SC (IT,ECE, Computers)
- 18. The bidder will be responsible for following all labor laws and safety procedures in respect of manpower deployed by them in ISPN premises for the purpose of this project.
- 19. Bidder will have to provide necessary tool kits to its deployed resources to perform their duties effectively.
- 20. The deputed resident service Engineers shall be considered under SKILLED category and all central govt. rates and rules shall be applicable. The deputed resident service Engineers daily wages shall not be less than minimum wages of skilled category of central govt. during the period of contract.
- 21. Bidder shall comply all statutory/legal requirements such as Minimum wages PF, ESI, Bonus and all related labor laws required for engaging the staff in order to deliver the service.
- 22. Central Govt. labor laws shall be applicable for the contract.
- 23. The successful bidder shall be responsible for compliance of all statutory provisions relating to Minimum Wages, Provident Fund, ESIC, Bonus etc. in respect of the persons deployed by it in ISPN for the service delivery.
- 24. The remuneration of the deployed staff must be credited to their bank account by the successful agency/bidder latest by 10th of every month. A penalty of Rs. 200/- per day and per person shall be imposed on the bidder for failure to meet this deadline.
- 25. The resident service Engineers deputed to ISPN by the successful bidder should be polite, cordial, positive and efficient while handling the assigned work. In case, the person employed by the successful bidder commit any omission/commission that amounts to misconduct /indiscipline /incompetence, the successful bidder will be liable to take disciplinary action against such persons including their removal from the work, if required by the ISPN.
- 26. If any mis-happens during the contract period, contract delivery, the successful bidder shall be held responsible. They shall not claim any amount from ISPN.
- 27. CAMC order will be awarded separately as per quoted rate after the expiry of warranty based on performance.



Terms and conditions

1. L-1 Calculation:

This project is a Supply, Installation, Testing and Commissioning (SITC) of additional 226 nos. of IP based CCTV system with three years comprehensive Warranty with latest technology at India Security Press, Nashik on Turnkey basis. During comprehensive warranty and CAMC for next 5 years, this project handles servicing, repairing & replacement of all parts, components and consumables along with deputation of minimum two skilled resident Service engineer for 3 + 5 years in general shift from the date of successful handover of complete system to ISPN through FAC.

L-1 will be decided based on total price quoted by bidder including, SITC, three years comprehensive warranty and next 5 years CAMC. **Per year CAMC rate should not be less than minimum 5% of the CAPEX cost of material**. The cost of CAMC will be freezed during tender finalization for considering L-1 price. Further, separate PO will be issued to L-1 firm for CAMC as per freezed price as per PM version 2.0 after the expiry of comprehensive warranty if the performance of firm is satisfactory.

Note: Tenderer's attention is drawn to GIT clause 17 and GIT sub-clause 10.1.

The tenderer is to provide the required details, information, confirmations, etc accordingly, failing which it is tender is liable to be ignored. Prospective bidders shall comply with the feature specifications (including Warrantee Obligations) and submit a "Specification Compliance Certificate" with their Technical Bid.

- 4) Completion of work after following all standard safety and environment norms.
- 5) All the relevant certificates to specified standard is to be provided.
- **6)** ONVIF compliance.



SECTION IX: QUALIFICATION/ ELIGIBILITY CRITERIA

(1) Minimum Eligibility Criteria:

(a) Experience: The Bidder (manufacturer or principal of authorized representative) shall be a manufacturer that has regularly for at least the last three years manufactured, supplied, erected, commissioned IP Based CCTV System with Latest technology having at least 226 nos of CCTV with the same or Higher Specifications, during last five years ending on 31st March 2022. At least one number of the project offered for supply should be in successful operation for at least one year on the date of bid opening.

Note: Start-ups and Micro and small Enterprises are exempted from Experience and Past Performance criteria. In case any bidder is seeking exemption from Experience and Past Performance criteria, the supporting documents to prove his eligibility for exemption must be submitted for evaluation.

(b) Capability, equipment and manufacturing facilities:- The bidder must have an annual capacity to manufacture and supply IP Based CCTV System with Latest technology having at least 226 nos of CCTV with the same or Higher Specifications.

(c) Financial Standing:

(i) Average Annual Turnover of the bidder firm (manufacturer or principal of authorised dealer) during the last three years, ending on 31.03.2022, should be at least Rs. 1,38,32,000/- as per the annual report (audited balance sheet and profit & loss account) of the relevant period duly authenticated by a Chartered Accountant/Cost Accountant in India.

Note: The Average Annual Turnover criteria are exempted for Start-ups and Micro and Small Enterprises. In case any bidder is seeking exemption from Average Turnover criteria, the supporting documents to prove his eligibility for exemption must be submitted for evaluation.
