- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
- 2. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
- 3. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
- 4. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU / Public Listed Company for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.
- 5. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and small enterprises will be allowed to participate .In case Buyer has selected Purchase preference to Micro and Small Enterprises clause in the bid, the same will get precedence over this clause.
- 6. Procurement under this bid is reserved for purchase from Micro and Small Enterprises whose credentials are validated online through Udyog Aadhaar for that product category. If the bidder wants to avail the reservation benefit, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service.
- 7. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 40% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU / Public Listed Company. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

1. Forms of EMD and PBG

Successful Bidder can submit the Performance Security in the form of Account Payee Demand Draft also (besides PBG which is allowed as per GeM GTC). DD should be made in favour of

SPMCIL, Unit India Security Press, Nashik payable at Nashik

. After award of contract, Successful Bidder can upload scanned copy of the DD in place of PBG and has to ensure delivery of hard copy to the original DD to the Buyer within 15 days of award of contract.

2. Forms of EMD and PBG

Successful Bidder can submit the Performance Security in the form of Fixed Deposit Receipt also (besides PBG which is allowed as per GeM GTC). FDR should be made out or pledged in the name of

SPMCIL, Unit India Security Press, Nashik

A/C (Name of the Seller). The bank should certify on it that the deposit can be withdrawn only on the demand or with the sanction of the pledgee. For release of Security Deposit, the FDR will be released in favour of bidder by the Buyer after making endorsement on the back of the FDR duly signed and stamped along with covering letter. Successful Bidder has to upload scanned copy of the FDR document in place of PBG and has to ensure delivery of hard copy of Original FDR to the Buyer within 15 days of award of

contract.

3. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

A. MINIMUM QUALIFICATION CRITERIA

1. Experience and Past Performance: The bidder firm should have in Manufactured and supplied at least 8000 Nos. of similar type of Corrugated Boxes in any one year during last five years i.e. from 01st April 2017 to 31st March 2022.

Note: Start-ups and Micro and small Enterprises are exempted from Experience and Past Performance cr iteria. In case any bidder is seeking exemption from Experience and Past Performance criteria, the supporting documents to prove his eligibility for exemption must be submitted for evaluation.

2. Capability, equipment and manufacturing facilities:-The Bidder firm must have an annual cap acity to manufacture and supply at least 8000 Nos. of Corrugated Boxes. Undertaking regarding this re quirement shall be submitted by the bidder on their Letter Head.

3. Financial Standing:

- a) The average annual turnover of the bidder during the last three years, ending on 31.03.2022 shou ld be at least Rs.7,55,120/-as per the annual report (Audited Balance sheet and Profit & Loss Account shall be submitted for evaluation) of Financial Year 2019-2020, 2020-2021 & 2021-2022, duly auth enticated by a chartered Accountant/Cost Accountant in India or equivalent in relevant countries Note: The Average Annual Turnover criteria are exempted for Start-ups and Micro and Small Enterprises. In case any bidder is seeking exemption from Turnover criteria, the supporting documents to prove his eligibility for exemption must be submitted for evaluation.
- b) The bidder should not have suffered any financial loss for more than one year during the last three years, ending on '31.03.2022'.
- (i) The net worth of the Bidder should not be negative on '31.03.2022' and also
- (ii) Should not have eroded by more than 30% in the last three years, ending on '31.03.2022'.

4. Applicability in Special Cases

- **a) For Existing successful Past Suppliers:** In case the bidder who is a successful past supplier of 'The Product' in at least one of the recent past three procurements, who do not meet any or mo re of requirements above, would also be considered to be qualified in view of their proven credentials, for the maximum quantity supplied by him in such recent past. (This clause is not applicable for Security Items as notified by Government of India from time to time.)
- **b) Joint Ventures and Holding Companies:** Credentials of the partners of Joint ventures cannot (repeat cannot) be clubbed for the purpose of compliance of PQC in supply of Goods/Equipment, a nd each partner must comply with all the PQC criteria independently However, for the purpose of q ualifying the Financial Standing Criteria, the Financial Standing credentials of a Holding Company c an be clubbed with only one of the fully owned subsidiary bidding company, with appropriate legal documents proving such ownership.
- **c) Start-up Enterprises:** Requirements of prior experience and turnover would be relaxed for Sta rt-up enterprises as recognized by Department for Promotion of Industry and Internal Trade (DPIIT) , subject to their meeting the quality and technical specifications. Such Start-ups maybe either MSE or otherwise.
- **5. Certificate of MSE:** The firm must have a valid registration certificate as MSE issued by NSIC, DGS &D or any authorized body by Ministry of MSME for Manufacturing of the tendered item and the same s hall be submitted by the firm along with tender/bid.
- 6. The Bidder shall give following undertakings on their Letter Head regarding this require ment.
 - i) The firm should give a declaration that, We M/s.<Name of the bidder firm> have not been black-lis ted/debarred for dealing by Government of India/PSU/Reputed Organisation in the Past.
 - **ii) Agree to withdraw all deviations:** The declaration that "We M/s.<Name of the bidder firm> ag ree to withdraw all the deviations, if any, unconditionally and accept all the terms and conditions of the tender document including the technical specifications".

2. Characteristics of Corrugated Box

- 1) 5 Ply Broad flute. Flute direction should be vertical.
- 2) Paper to be used: 290 GSM Liner Kraft paper 'A' grade.
- 3) Bursting Strength of the Board: Min 35 Kg/CM².
- 4) Adhesive to be used: Very strong enough to hold 60 kgs with double stapling.
- 5) Compression strength: 500 Kgs. (Empty Box)
- 6) General Workmanship & Finish shall be good throughout.
- Test Report: The supplier shall submit Test reports along with each batch of supply, as per specification to ISP.

C. Pre-Dispatch Sample and Delivery Schedule & Quality Control Requirement (To be submitte d on firm's Letter Head as a token of acceptance):-

- 1) Pre-Dispatch Sample:- Two (02) Nos. of sample boxes as a Pre-Production to be supplied within 0 7 days from the date of issue of Supply Order/GeM Contract at free of cost. Sample suitability will be c onveyed within 07 days from the date of receipt of sample.
- 2) Delivery Schedule:- Bulk Supply: After sample suitability, the delivery schedule will be as under.
 - 5000 boxes within 44 days from date of issue of Supply Order/GeM Contract
 - 2. 5000 boxes within 90 days from the date of issue of Supply Order/GeM Contract
 - 3. 5000 boxes within 150 days from the date of issue of Supply Order/GeM Contract
 - 4. 5000 boxes within 210 days from the date of issue of Supply Order/GeM Contract

However, ISP can vary the delivery quantity by \pm 25% by informing the firm in advance.

3) Each of the above delivery shall be proportionally placed as per parallel contract/bid splitting condit ion.

4) Quality Control Requirement:-

- (i) The material supplied by the successful bidder will be accepted on all parameters as per specificati on provided in the Bid Document. The purchaser reserves the right to get the material supplied tested from in-house laboratory or any other laboratory of repute and in case the material is found not meetin g the specification, the purchaser shall be entitled to cancel the contract, and if so desired, purchase o r otherwise the purchase of the stores at the risk and cost of the contractor.
- (ii) After receipt of goods, the goods will be inspected/tested at ISP. If any defect/variation is noticed th en the same will be replaced free of cost by the supplier/seller up to India Security Press, Nashik Road, failing which equivalent amount of defective material will be deducted in the subsequent bills or from any amount due to them.

D. Special Conditions of Contract (SCC)

- **1) Transportation of Goods:** The transportation of goods to be procured will be done by the supplier on FOR ISP Basis. The total cost of the transportation should be indicated in the price bid of the item to be procured.
- **2) Insurance:** Since Indigenous bidder has to deliver the material on FOR ISP Nashik basis therefore t he cost of the insurance will also the part of the cost of the material borne by the supplier. A specific in surance cover for each consignment/supply is to be given by firm, as applicable.
- **3) Distribution of Dispatch Documents for Clearance/Receipt of Goods:** The supplier shall sen d all the relevant dispatch documents well in time to ISP Nashik to enable ISP Nashik to clear or receiv e (as thecase may be) the goods in terms of the contract.
- **4) Taxes and Duties:** Supplier shall be entirely responsible for all taxes, duties, fees, levies etc. incur red until delivery of the contracted goods to SPMCIL. If the tenderer fails to include taxes and duties as per law of the land in the tender, no claim thereof will be considered by purchaser at a later stage.
- **5) Terms and Mode of Payment:** 100% payment will be released within ten (10) days of issue of consignee receipt-cum-acceptance certificate (CRAC) and on-line submission of bills. The payment will be done through online mode only. Therefore, the suppliers have to produce all the Bank details such as Name of Bank, Account No., IFSC Code No., MICR No. along with the Tender document. TDS, if any, will be deducted as applicable.
- **6) Bid Splitting/Parallel Contract:** India Security Press, Nashik reserves its rights to conclude Bid Splitting/Parallel Contract with more than one bidder (maximum upto Three bidders for the same tende r) without any prejudice to the capacity of the L1 bidder. In case of splitting in three, the ratio of 70:30 will be used.

7) NOTE:

The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in

the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. Any clause(s) incorporated by the Buyer regarding following shall be treated as null and void and would not be considered as part of bid:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.

- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process.
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
