- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
- 2. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
- 3. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
- 4. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU / Public Listed Company for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.
- 5. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
- 6. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company

and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non - Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and small enterprises will be allowed to participate .In case Buyer has selected Purchase preference to Micro and Small Enterprises clause in the bid, the same will get precedence over this clause.

- 7. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer)of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25%(selected by Buyer) percentage of total OUANTITY.
- 8. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
- 9. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 40% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU / Public Listed Company. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

A. Minimum Qualification Criteria

1. Experience & Past Performance: The Bidder (manufacturer or principal of authorized r epresentative-hereinafter referred simply as 'The Bidder') shall be a manufacturer that has r egularly for at least the last Three (03) years manufactured and supplied Pallet Truck with the same or higher specifications of at least one (01) number in last five (05) years ending on

"31st March 2022". At least one (01) number of the product offered for supply should be in s uccessful operation for at least one (01) year on the date of bid opening.

Note: i) Copies of PO's and completion/experience certificates issued by customers to be p rovided in support of above.

- ii) Start-ups and Micro and small Enterprises are exempted from Experience and Past Performance criteria. In case any bidder is seeking exemption from Experience and Past Performance criteria, the supporting documents to prove his eligibility for exemption must be submitted for evaluation.
- **2. Capability, equipment and manufacturing facilities:-** The Bidder firm must have an annual capacity to manufacture and supply at least (07) Number of Pallet Truck. The self-att ested details shall be submitted along with bid.

Note: At the discretion of the purchaser, the Capacity / Capability Assessment / Verificatio n of bidder / manufacturer firm(s) might be undertaken by a Committee or through a third party Technical Consultancy / Inspection agencies to ensure that the firm is/are identified a nd capable to supply the machine/item/material/product as required.

3. Financial Standing:

a) The average annual financial turnover of the bidder during the last three years, endin g on '31.03.2022', should be at least Rs.9,27,952/- as per the annual report (audited ba lance sheet and profit & loss account of Financial Year 2019-2020, 2020-2021 & 2021-2022 shall be submitted for evaluation) of Financial Year 2019-2020, 2020-2021 & 2021-2022, duly authenticated by a Chartered Accountant/Cost Accountant in India or equiva lent in relevant countries.

Note: The Average Annual Turnover criteria are exempted for Start-ups and Micro and Small Enterprises. In case any bidder is seeking exemption from Turnover criteria, the s upporting documents to prove his eligibility for exemption must be submitted for evaluation.

- **b)** The bidder should not have suffered any financial loss for more than one year during the last three years, ending on '31.03.2022'.
 - i) The net worth of the Bidder should not be negative on '31.03.2022' and also
 - **ii)** Should not have eroded by more than 30% in the last three years, ending on '31.03. 2022'.

4. Applicability in Special Cases

- a) Applicability to 'Make in India': Bidders (manufacturer or principal of authorised rep resentative) If the product is being manufactured in India under a license from a foreign m anufacturer who holds intellectual property rights and where there is a technology collabor ation agreement/ transfer of technology agreement for indigenous manufacture of a produ ct developed abroad with clear phased increase in local content, and who while meeting all other criteria above, except for any or more of sub-criteria in Experience and Past Perform ance above, would also be considered to be qualified provided: i) their foreign manufacture r who holds intellectual property rights, meets all the criteria above without exemption, and ii) the Bidder submits appropriate documentary proof for technology collaboration agree ment/ transfer of technology agreement for indigenous manufacture of a product develope d abroad with clear phased increase in local content. iii) the bidder (manufacturer or princi pal of authorised representative) furnishes along with the bid a legally enforceable underta king jointly executed by himself and such foreign Manufacturer for satisfactory manufacture, Supply (and erection, commissioning if applicable) and performance of 'The Product' off ered including all warranty obligations as per the general and special conditions of contract
- b) Authorized Representatives: Bids of bidders quoting as authorised representative of a principal manufacturer would also be considered to be qualified, provided: i) their princip al manufacturer meets all the criteria above without exemption, and ii) the principal manufacturer furnishes a legally enforceable tender-specific authorisation in the prescribed form assuring full guarantee and warranty obligations as per the general and special conditions of contract; and iii) the bidder himself should have been associated, as authorised represe ntative of the same or other Principal Manufacturer for same set of services as in present b id (supply, installation, satisfactorily commissioning, after sales service as the case may be) for same or similar 'Product' for past three years ending on '31.01.2022.

- c) For Existing successful Past Suppliers: In case the bidder (manufacturer or principa I of authorised representative) who is a successful past supplier of 'The Product' in at least one of the recent past three procurements, who do not meet any or more of requirements above, would also be considered to be qualified in view of their proven credentials, for the maximum quantity supplied by him in such recent past. (This clause is not applicable for S ecurity Items as notified by Government of India from time to time.)
- **d) Joint Ventures and Holding Companies:** Credentials of the partners of Joint ventures cannot (repeat cannot) be clubbed for the purpose of compliance of PQC in supply of Good s/Equipment, and each partner must comply with all the PQC criteria independently Howev er, for the purpose of qualifying the Financial Standing Criteria, the Financial Standing cred entials of a Holding Company can be clubbed with only one of the fully owned subsidiary bi dding company, with appropriate legal documents proving such ownership.
- e) Development/ insufficient market capacity or Exceptional One- Off Cases: Thes e are those items which are either being newly developed where vendors are yet to be dev eloped or for new/ existing items where the capacity available in market is inadequate com pared to our annual requirements. Exceptional one-off cases are such items/ Plant & Machi nery which are procured infrequently (say once in 3 years or longer periods). In such cases PQC Should be Decided with the approval of CFA in individual cases.
- **f) Start-up Enterprises:** Requirements of prior experience and turnover would be relaxe d for Start-up enterprises as recognised by Department for Promotion of Industry and Inter nal Trade (DPIIT), subject to their meeting the quality and technical specifications. Such St art-ups maybe either MSE or otherwise.
- 5. The Bidder shall give following undertakings on their Letter Head regarding this requirement.
 - i) **Blacklisting**: The bidder firm should submit declaration that, We M/s.<Name of the bidd er firm> declaration that the firm has not been blacklisted/ debarred by any government a gency / Public Sector Unit/ Reputed organization.
 - **ii) Agree to withdraw all deviations:** The bidder firm should submit declaration that, W e M/s.<Name of the bidder firm> agree to withdraw all the deviations, if any, unconditional ly and accept all the terms and conditions of the tender document including the technical s pecifications".
- **6.** Manufacturer's Authorisation Letter: In case the bidder firm/ bidder offers to supply' **Pallet Truck'**, which is manufactured by some other firm, the bidder has to be duly a uthorized by the manufacturer of the stated material to quote for and supply the sam e to India Security Press, a unit of SPMCIL. The bidder shall submit the manufacturer's authorization letter to this effect as per the standard form provided in "buyer upload ed ATC Uploaded document".

Note: One manufacturer can participate through one authorized agent or one agent can participate on behalf of one Principal Manufacturer only.

C. Delivery Schedule & Quality Control Requirement(To be submitted on firm's Letter H ead as a token of acceptance):-

- 1) **Delivery Schedule:-** The Successful bidder has to Supply the **Pallet Truck** at ISP within 30 days from the date of issue of Contract/Purchase Order on FOR, ISP basis.
- 2) Quality Control Requirement:
 - i. The material supplied by the successful bidder will be accepted on manufacturer's conforming to all parameters as per Technical Specification. The machine will be accepted on manufacturers guarantee certificate to be sent to purchaser. If any defect

s observed or the machine is found unsuitable, then the same will be returned to the su pplier for free replacement upto India Security Press, Nashik or the purchaser shall be e ntitled to cancel the contract, and if so desired, purchase or authorize purchase of the s tores at the risk and cost of the contractor.

ii. After receipt of goods, the goods will be inspected/tested at ISP. If any defect/varia tion is noticed then the same will be replaced free of cost by the supplier/seller up to In dia Security Press, Nashik Road, failing which equivalent amount of defective material will be deducted in the subsequent bills or from any amount due to them.

<u>D. Special Conditions of Contract (SCC) (To be submitted on firm's Letter Head as a tok</u> en of acceptance)

- **1) Transportation of Goods:** The transportation of goods to be procured will be done by th e supplier on FOR ISP Basis. The total cost of the transportation should be indicated in the price bid of the item to be procured.
- **2) Insurance:** Since Indigenous bidder has to deliver the material on FOR ISP Nashik basis t herefore the cost of the insurance will also the part of the cost of the material borne by the s upplier. A specific insurance cover for each consignment/supply is to be given by firm, as applicable.
- **3) Distribution of Dispatch Documents for Clearance/Receipt of Goods:** The supplier shall send all the relevant dispatch documents well in time to ISP Nashik to enable ISP Nashik to clear or receive (as the case may be) the goods in terms of the contract.
- **4) Taxes and Duties:** Supplier shall be entirely responsible for all taxes, duties, fees, levies etc. incurred until delivery of the contracted goods to SPMCIL. If the tenderer fails to include t axes and duties as per law of the land in the tender, no claim thereof will be considered by p urchaser at a later stage.
- **5) Terms and Mode of Payment:** 100% payment will be released within ten (10) days of issue of c onsignee receipt-cum-acceptance certificate (CRAC) and on-line submission of bills. The payment will be done through online mode only. Therefore, the suppliers have to produce all the Bank details such as Name of Bank, Account No., IFSC Code No., MICR No. along with the Tender document. TDS, if a ny, will be deducted as applicable.

6) NOTE:
