- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
- 2. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
- 3. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
- 4. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU / Public Listed Company for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.
- 5. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
- 6. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating

to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non - Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and small enterprises will be allowed to participate .In case Buyer has selected Purchase preference to Micro and Small Enterprises clause in the bid, the same will get precedence over this clause.

- 7. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer)of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25%(selected by Buyer) percentage of total QUANTITY.
- 8. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 40% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU / Public Listed Company. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Forms of EMD and PBG

Bidders can also submit the EMD with Account Payee Demand Draft in favour of

Bidder has to upload scanned copy / proof of the DD along with bid and has to ensure delivery of hardcopy to the Buyer within 5 days of Bid End date / Bid Opening date.

3. Forms of EMD and PBG

1. QUALIFICATION/ ELIGIBILITY CRITERIA

a) <u>Experience and past performance:</u>

The bidder (manufacturer or principal of authorised representative –hereinafter referred simply as 'The Bidder') should have manufactured and supplied at least 4400 nos. Thermal inkjet cart ridge for variable data printing one year of the last five years ending on "31st March 2022".

<u>Note:</u> i) *Copies of PO's and completion/experience certificates issued by customers to be provi ded in support of above.

ii) Start-ups and Micro and small Enterprises are exempted from Experience and Past Performance criteria. In case any bidder is seeking exemption from Experience and Past Performance criteria, the supporting documents to prove his eligibility for exemption must be submitted for evaluation.

b) <u>Capability, equipment and manufacturing facilities:</u>

(i) The Bidder firm should have annual capacity of manufactured and supplied at least 4 400 nos. Thermal inkjet cartridge for variable data printing. The self attested details shall be s ubmitted along with bid.

Note: At the discretion of the purchaser, the Capacity / Capability Assessment / Verification of bidder / manufacturer firm(s) might be undertaken by Tender Evaluation Committee or through a third party Technical Consultancy / Inspection agencies to e nsure that the firm is/are identified and capable to supply the item/material/product as required.

c) <u>Financial standing:</u>

(i) **Average Annual Turnover** The average annual financial turnover of the bidder duri ng the last three years, ending on '31st March 2022', should be at least Rs. 1,53,73,600.00 as per the annual report (audited balance sheet and profit & loss account) of the relevant period, duly authenticated by a Chartered Accountant/Cost Accountant in India or equivalent in relevant countries.

Note: The Average Annual Turnover criteria are exempted for Start-ups and Micro and S

mall Enterprises. In case any bidder is seeking exemption from Turnover criteria, the sup porting documents to prove his eligibility for exemption must be submitted for evaluation

- (ii) The bidder should not have suffered any financial loss for more than one year during the last three years, ending on '31st March 2022'.
- (iii) a) The net worth of the Bidder should not be negative on '31st March 2022' and also b) should not have eroded by more than 30% in the last three years, ending on '31st M arch 2022'.
- d) The criteria for Capability, Equipment and Manufacturing facilities as well as financial loss and net worth under the financial standing eligibility criteria (above) shall be applicable to all the bidder firms including MSES & Startup Firms.

2. Applicability in Special Cases:

- (i) **Applicability to 'Make in India':** Bidders (manufacturer or principal of authorised representa tive) If the product is being manufactured in India under a license from a foreign manufacturer who holds intellectual property rights and where there is a technology collaboration agreement/ transfer of technology agreement for indigenous manufacture of a product developed abroad with clear phased increase in local content, and who while meeting all other criteria above, except for any or more of sub-criteria in Experience and Past Performance above, would also be considered to be qualified provided: i) their foreign manufacturer who holds intellectual property rights, meets all the criteria above without exemption, and ii) the Bidder submits appropriate documentary proof for technology collaboration agreement/ transfer of technology agreement for indigenous manufacture of a product developed abroad with clear phased increase in local content. iii) the bidder (manufacturer or principal of authorised representative) furnishes along with the bid a legally enfor ceable undertaking jointly executed by himself and such foreign Manufacturer for satisfactory manufacture, Supply (and erection, commissioning if applicable) and performance of 'The Product' of fered including all warranty obligations as per the general and special conditions of contract.
- (ii) **Authorized Representatives:** Bids of bidders quoting as authorised representative of a principal manufacturer would also be considered to be qualified, provided: i) their principal manufacturer meets all the criteria above without exemption, and ii) the principal manufacturer furnishes a legally enforceable tender-specific authorisation in the prescribed form assuring full guarantee and warranty obligations as per the general and special conditions of contract; and iii) the bidder himself should have been associated, as authorised representative of the same or other Principal Manufacturer same or similar 'Product' for past three years ending on '31.03.2022.
- (iii) **For Existing successful Past Suppliers:** In case the bidder (manufacturer or princ ipal of authorised representative) who is a successful past supplier of 'The Product' in at least one of the recent past three procurements, who do not meet any or more of requirements above, would also be considered to be qualified in view of their proven credentials, for the maximum quantity supplied by him in such recent past. (This clause is not applicable for Security Items as notified by Government of India from time to time).
- (iv) **Joint Ventures and Holding Companies:** Credentials of the partners of Joint vent ures cannot (repeat cannot) be clubbed for the purpose of compliance of PQC in supply of Goods/ Equipment, and each partner must comply with all the PQC criteria independently However, for the purpose of qualifying the Financial Standing Criteria, the Financial Standing credentials of a Hold ing Company can be clubbed with only one of the fully owned subsidiary bidding company, with a ppropriate legal documents proving such ownership.
- (v) **Start-up Enterprises:** Requirements of prior experience and turnover would be rel axed for Start-up enterprises as recognised by Department for Promotion of Industry and Internal Trade (DPIIT), subject to their meeting the quality and technical specifications. Such Start-ups maybe either MSE or otherwise.

3. <u>Undertaking(s):</u>

(i) The firm should give undertaking that, "We / the Principle Manufacturer have not been b lack-listed/ debarred for dealing with any Govt. Organization / Public Sector Undertaking (PSU) / Reputed Organization in the past".

- (ii) The firm should give undertaking that, "We agree to withdraw all the deviation s, if any, unconditionally and accept all the terms and conditions of the tender docume nt including the technical specifications".
- (iii) The information given in the documents are correct and the Bidder is aware that in c ase any information provided is found to be false at a later stage, ISP reserves the right to reject/disqualify the bidder at any stage of the tendering process without assigning any reason.
- **4. Option Clause :** The Purchaser reserves the right to increase the ordered quantity by 25% a t any time, till final delivery date of the contract, by giving reasonable notice even though the quantity ordered initially has been supplied in full before the last date of Delivery Period.

5. Other Eligibility requirements for the Bidders:

- **5.1** The bidder shall submit Local Content details as per clause No. 9; Verification of Loca I content, of Public procurement (Preference to make in India) order 2017 No. P-45021/2/2017-P P(BE-II) & as per section X; Tender form clause no. 2. Make in India Status; it is requested to pro vide a certificate from statutory auditor or cost auditor of your company.
- **5.2** The bidder shall provide names of Organization(s)/ Firm(s) with Addresses and Telep hone numbers, Fax numbers, E-mail addresses to which manufacturer/ bidder firm has supplied similar type of Thermal inkjet cartridge for variable data printing in past.
- **5.3** The bidder has to submit **Power of Attorney/ Authorization** indicating that author ized signatory is competent and legally authorized to submit the tender and / or enter into legally binding contract.
- **Manufacturer's Authorisation Letter:** In case the bidder firm/ bidder offers to su pply 'Thermal inkjet cartridge for variable data printing' which is manufactured by some other firm, the bidder has to be duly authorized by the manufacturer of the stated material to quote for and supply the same to India Security Press, a unit of SPMCIL. The bidder shall submit the manufacturer's authorization letter to this effect as per the standard form provided in buyer uploaded ATC Uploaded document.

One manufacturer can participate through one authorized agent or one agent can participate on behalf of one Principal Manufacturer only.

- **5.5** While evaluating the tender all credentials of the principal manufacturer only shall be considered. However authorized agent can participate / submit the tender on behalf of principal manufacturer.
- **5.6** All experience, past performance and capacity/ capability related/ data should be ce rtified by the authorized signatory of the bidder firm. The bidder should submit documentary e vidence regarding the past supply. The credentials regarding experience and past performance to the extent required as per eligibility criteria submitted by bidder should be verified from the parties for whom work has been done, hence copies of orders and corresponding experience ce rtificate are to be submitted along with offer.
- **5.7** The application should be submitted in English Language. The authenticated copies of the documents in support of the applicant's claims must be submitted in **English language**.
- **5.8** All financial standing data (Balance sheet and Profit & Loss Statements etc.) should be certified by certified accountants' e.g. Chartered Accountants (CA).
- **5.9** Decision on Finalization of tender will be taken based on the documents submitted a long with the tender. All documents must be submitted as per tender requirement failing which offers will be liable for rejection and no further correspondence will be made/ entertained for cla rification after opening of the tender.
- **5.10** All the pages submitted are to be required & sealed by Authorised Signatory failing which tender shall be treated as unresponsive.
- **5.11** Bidder firm shall submit the copy of PAN & GST Registration Certificate.

6. General Condition of Contract (GCC):

- 6.1 **Packing and Marking**: As per Technical Specifications of the tender document.
- 6.2 **Transportation of Goods:** The transportation of goods to be procured will be done by the s upplier on FOR ISP Basis. The total cost of the transportation should be indicated in the price bid of the item to be procured
- 6.3 **Inspection and Quality Control** In addition to clause No. 9 of GCC the following shall also be applicable:-
 - (i) The material supplied by the successful bidder will be accepted on manufacturer's c onforming to all parameters as per Technical Specification. The material will be accepted on manufacturers guarantee certificate to be sent to purchaser. If any defects observed or the m aterial is found unsuitable, then the same will be returned to the supplier for free replacement upto India Security Press, Nashik or the purchaser shall be entitled to cancel the contract, and if so desired, purchase or authorize purchase of the stores at the risk and cost of the contract or.
 - (ii) Quality Control Requirement:- As per Technical Specification.
 - (iii) **Pre-Production Samples :** The successful firm(s) will have to submit pre production samples 100 nos. of Thermal inkjet cartridge for variable data printing along with the Laborat ory Test Report within 15 days from the date of place of contract as pilot.

6.4 Bid Splitting/Parallel contracts:

India Security Press, Nashik reserves its right to conclude Bid Splitting/Parallel Contract with more than one bidder (maximum upto two bidders for the same tender) without any prejudice to the cap acity of the L1 bidder, as given below:

- a) Bidder firm should not quote for less than 25% of the tender quantity; otherwise their offer would be considered as unresponsive.
- b) Among all qualified bids, the lowest bid will be termed as L1. The rate quoted by L1 b idder will be counter offered to L2 bidder and, if agreed, orders shall be placed at a ratio L1 : L2 = 70:30 of the total tendered quantity.
- c) However, Purchaser also reserves the right to place Purchase Order for the 100% ten dered quantity on the lowest qualified bidder in case L2 bidder does not accept L1 rates.
