- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
- 2. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. - 3. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
- 4. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU / Public Listed Company for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.
- 5. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
- 6. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non Local suppliers as per MII order dated 04.06.2020 are

not eligible to participate. However, eligible micro and small enterprises will be allowed to participate .In case Buyer has selected Purchase preference to Micro and Small Enterprises clause in the bid, the same will get precedence over this clause.

- 7. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer)of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 100%(selected by Buyer) percentage of total QUANTITY.
- 8. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 80% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU / Public Listed Company. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

1. Buyer Added Bid Specific ATC

A. MINIMUM QUALIFICATION CRITERIA:

1. Experience: The Bidder (manufacture or principal of authorised representative) shall be a manufacturer that has regularly for at least the last three years manufactured, supplied erect ed, commissioned Digital Micrometer for Measuring Thickness of Paper and Paper Board with the same or higher specifications of at least one number in last five years ending on 31st March 2022. At least one number of the product offered for supply should be in successful operation for at least one year on the date of bid opening.

Note: i) *Copies of PO's and completion/experience certificates issued by customers to be provided in support of above.

ii) Start-ups and Micro and small Enterprises are exempted from Experience and Past Perform ance criteria. In case any bidder is seeking exemption from Experience and Past Performance criteria, the supporting documents to prove his eligibility for exemption must be submitted for evaluation.

2. Capability, equipment and manufacturing facilities:-

(i) The bidder must have an annual capacity to manufacture and supply at least one (01) number of Digital Micrometer for Measuring Thickness of Paper and Paper Board.

Note: At the discretion of the purchaser, the Capacity / Capability Assessment / Ve rification of bidder / manufacturer firm(s) might be undertaken by a Committee or through a third party Technical Consultancy / Inspection agencies to ensure that the firm is/are identified and capable to supply the machine/item/material/product as required.

3. Financial Standing:

a) The average annual turnover of the bidder during the last three years, ending on 31.03 .2022 should be at least Rs. 475100/- as per the annual report (Audited Balance sheet and Pr ofit & Loss Account) of Financial Year 2019-2020, 2020-2021 & 2021-2022 duly authenticated by a chartered Accountant/Cost Accountant in India or equivalent.

Note: The Average Annual Turnover criteria are exempted for Start-ups and Micro and Small Enterprises. In case any bidder is seeking exemption from Turnover criteria, the supporting do cuments to prove his eligibility for exemption must be submitted for evaluation.

- b) The bidder should not have suffered any financial loss for more than one year during the last three years, ending on '31.03.2022'.
- The net worth of the firm should
- (i) not be negative on '31.03.2022' and also
- (ii) Should not have eroded by more than 30% in the last three years, ending on '31.03.2022'.

4. The Bidder shall give following undertakings on their Letter Head regarding this requirement.

- **a**) The firm should give a declaration that they have not been black-listed/debarred for dealing by Government of India/PSU/Reputed Organization in the Past.
- **b)** Agree to withdraw all deviations: The declaration that "We agree to withdraw all the d eviations, if any, unconditionally and accept all the terms and conditions of the tender docum ent including the technical specifications".

B. Pre-Dispatch Sample and Delivery Schedule & Quality Control Requirement:(To be submitted on firm's Letter Head as a token of acceptance)

- 1) Inspection and Quality Control In addition to clause No. 9 of GCC the following shall al so be applicable:-
- i) The material supplied by the successful bidder will be accepted on manufacturer's conform

ing to all parameters as per Technical Specification. The machine will be accepted on manufa cturers guarantee certificate to be sent to purchaser. If any defects observed or the machine is found unsuitable, then the same will be returned to the supplier for free replacement upto I ndia Security Press, Nashik or the purchaser shall be entitled to cancel the contract, and if so desired, purchase or authorize purchase of the stores at the risk and cost of the contractor.

- ii) During inspection, the complete operation of the machine will be checked.
- **iii)** The inspection procedure and the arrangement will be according to the contract agreed m utually between the supplier and the purchaser.
- **2) Delivery Schedule:-** he Successful bidder has to carry out Supply, Install, Testing, Commi ssioning & Training of Machine at ISP within 90 days from the date of issue of Notification Award of Contract on FOR, ISP basis.

3) Quality Control Requirement:-

The material supplied by the successful bidder will be accepted on all parameters as per specification. In case the material is found not meeting the specification, the purchaser s hall be entitled to cancel the contract and if so desired, purchase or otherwise the purchase of the stores at the risk and cost of the contractor.

After receipt of goods, the goods will be inspected / tested at ISP. If any defect/ variati on is noticed then the same will be replaced free of cost by the supplier / seller up to India Se curity Press, Nashik Road, failing which equivalent amount of defective material will be deducted in the subsequent bills or from any amount due on them.

4) Manufacturer's Authorisation Letter: In case the bidder firm/ bidder offers to supply "Digital Micrometer for measuring thickness of paper and paper board", which is manufactured by some other firm, the bidder has to be duly authorized by the manufacturer of the stated material to quote for and supply the same to India Security Press, a unit of SPMCIL. The bidder shall submit the manufacturer's authorization letter to this effect as per the standard form provided under Section XIV in this document.

C. Special Conditions of Contract (SCC)

(To be submitted on firm's Letter Head as a token of acceptance)

- **1) Transportation of Goods:** The transportation of goods to be procured will be done by th e supplier on FOR ISP Basis. The total cost of the transportation should be indicated in the pric e bid of the item to be procured.
- **2) Insurance:** Since Indigenous bidder has to deliver the material on FOR ISP Nashik basis th erefore the cost of the insurance will also the part of the cost of the material borne by the sup plier. A specific insurance cover for each consignment / supply is to be given by the firm, as a pplicable.
- **3) Distribution of Dispatch Documents for Clearance/Receipt of Goods:** The supplier s hall send all the relevant dispatch documents well in time to ISP Nashik to enable ISP Nashik t o clear or receive (as the case may be) the goods in terms of the contract.
- **4) Taxes and Duties:** Supplier shall be entirely responsible for all taxes, duties, fees, levies etc. incurred until delivery of the contracted goods to SPMCIL. If the tenderer fails to include t axes and duties as per law of the land in the tender, no claim thereof will be considered by pu rchaser at a later stage.
- **5) Terms and Mode of Payment:** 100% payment will be released within ten (10) days of issue of consignee receipt-cum-acceptance certificate (CRAC) and on-line submission of bills. The payment will be done through online mode only. Therefore, the suppliers have to produce all the Bank details such as Name of Bank, Account No., IFSC Code No., MICR No. along with the Tender document. TDS, if any, will be deducted on installation, testing, commissioning and training work.

- 2. All experience, past performance and capacity/ capability related/ data should be certified by the authorized signatory of the bidder firm.
- 3. Decision on Finalization of tender will be taken based on the documents submitted along w ith the tender. All documents must be submitted as per tender requirement failing which offers will be liable for rejection.
- 4. All the pages submitted are to be sealed & signed by Authorised Signatory failing which te nder shall be treated as unresponsive.

D. Applicability in Special Cases:

- (i) Applicability to 'Make in India': Bidders (manufacturer or principal of authorised re presentative) If the product is being manufactured in India under a license from a foreign man ufacturer who holds intellectual property rights and where there is a technology collaboration agreement/ transfer of technology agreement for indigenous manufacture of a product develo ped abroad with clear phased increase in local content, and who while meeting all other crite ria above, except for any or more of sub-criteria in Experience and Past Performance above, would also be considered to be qualified provided: i) their foreign manufacturer who holds int ellectual property rights, meets all the criteria above without exemption, and ii) the Bidder su bmits appropriate documentary proof for technology collaboration agreement/ transfer of technology agreement for indigenous manufacture of a product developed abroad with clear pha sed increase in local content. iii) the bidder (manufacturer or principal of authorised represent ative) furnishes along with the bid a legally enforceable undertaking jointly executed by hims elf and such foreign Manufacturer for satisfactory manufacture, Supply (and erection, commis sioning if applicable) and performance of 'The Product' offered including all warranty obligations as per the general and special conditions of contract.
- (ii) Authorized Representatives: Bids of bidders quoting as authorised representative of a principal manufacturer would also be considered to be qualified, provided: i) their principal manufacturer meets all the criteria above without exemption, and ii) the principal manufactur er furnishes a legally enforceable tender-specific authorisation in the prescribed form assurin g full guarantee and warranty obligations as per the general and special conditions of contract; and iii) the bidder himself should have been associated, as authorised representative of the same or other Principal Manufacturer same or similar 'Product' for past three years ending on '31.03.2022.
- (iii) For Existing successful Past Suppliers: In case the bidder (manufacturer or principa I of authorised representative) who is a successful past supplier of 'The Product' in at least on e of the recent past three procurements, who do not meet any or more of requirements above, would also be considered to be qualified in view of their proven credentials, for the maximum quantity supplied by him in such recent past. (This clause is not applicable for Security Items as notified by Government of India from time to time.)
- (iv) Joint Ventures and Holding Companies: Credentials of the partners of Joint venture s cannot (repeat cannot) be clubbed for the purpose of compliance of PQC in supply of Goods/ Equipment, and each partner must comply with all the PQC criteria independently However, f or the purpose of qualifying the Financial Standing Criteria, the Financial Standing credentials of a Holding Company can be clubbed with only one of the fully owned subsidiary bidding company, with appropriate legal documents proving such ownership.
- (v) Start-up Enterprises: Requirements of prior experience and turnover would be relax ed for Start-up enterprises as recognised by Department for Promotion of Industry and Interna I Trade (DPIIT), subject to their meeting the quality and technical specifications. - d) An entity whose beneficial owner is situated in such a country; or
- e) An Indian (or other) agent of such an entity; or
- f) A natural person who is a citizen of such a country; or
- g) A consortium or joint venture where any member of the consortium or joint venture falls under any of the above.
- (v) The beneficial owner for the purpose of (III) above will be as under:
- a) In case of a company or Limited Liability Partnership, the beneficial owner is the natural person(s), who, whether acting alone or together, or through one or more ju

dicial person, has a controlling ownership interest or who exercise control through o ther means.

b) Explanation:

- (1) "Controlling ownership interest" means ownership of or entitlement to more than twenty-five per cent of shares or capital or profits of the company.
- (2) In case of a partnership firm, the beneficial owner is the natural person(s) who, whether acting alone or together, or through one or more juridical person, has owne rship of entitlement to more than fifteen percent of Capital or profits of the partners hip.
- (3) In case of an unincorporated association or body of individuals, the beneficial ow ner is the natural person(s), who, whether acting alone or together, or through one or more juridical person, has ownership of or entitlement to more than fifteen perce nt of the property or capital or profits of such association or body of individuals;
- (4) Where no natural person is identified under (1) or (2) or (3) above, the beneficia I owner is the relevant natural person who holds the position of senior managing off icial.
- (5) In case of a trust, the identification of beneficial owner(s) shall include identificat ion of the author of the trust, the trustee, the beneficiaries with fifteen percent or m ore interest in the trust and any other natural person exercising ultimate effective c ontrol over the trust through a chain of control or ownership.
- (vi) An Agent is a person employed to do any act for another, or to represent anoth er in dealings with third person.
