- 1. 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

- a) The average annual financial turnover of the bidder during the last three years, endin g on 31st March 2022, should be at least Rs. 8,20,435/- (or equivalent in foreign currency at exchange rate prevalent on 31st March 2022) as per the annual report (audited balance sheet and profit & loss account) of the relevant period, duly authenticated by a Chartered Accountant/ Cost Accountant in India or equivalent in relevant countries.

Note: The 'Average Annual Turnover criteria' is exempted for Startups and Micro and Small Enter prises.

- b) The bidder should not have suffered any financial loss for more than one year during the last three years, ending on 31st March 2022.
- c) (i) The net worth of the Bidder should not be negative on 31^{st} March 2022 and also s hould not have eroded by more than 30% in the last three years, ending on 31^{st} March 2022..

Applicability in Special Cases

- i) Authorized Representatives: Bids of bidders quoting as authorised representative of a princi pal manufacturer would also be considered to be qualified, provided: i) their principal manufacture r meets all the criteria above without exemption, and ii) the principal manufacturer furnishes a leg ally enforceable tender-specific authorisation in the prescribed form assuring full guarantee and w arranty obligations as per the general and special conditions of contract; and iii) the bidder himsel f should have been associated, as authorised representative of the same or other Principal Manufa cturer for same set of services as in present bid (supply, installation, satisfactorily commissioning, after sales service as the case may be) for same or similar 'Product' for past three years ending on '31.03.2022'.
- **ii)** For Existing successful Past Suppliers: In case the bidder (manufacturer or principal of aut horised representative) who is a successful past supplier of 'The Product' in at least one of the rec ent past three procurements, who do not meet any or more of requirements above, would also be considered to be qualified in view of their proven credentials, for the maximum quantity supplied by him in such recent past. - **iii) Joint Ventures and Holding Companies:** Credentials of the partners of Joint ventures cannot (repeat cannot) be clubbed for the purpose of compliance of PQC in supply of Goods/Equip ment, and each partner must comply with all the PQC criteria independently However, for the purp

ose of qualifying the Financial Standing Criteria, the Financial Standing credentials of a Holding Company can be clubbed with only one of the fully owned subsidiary bidding company, with appropriate legal documents proving such ownership.

3. Certificates

. After award of contract, Successful Bidder can upload scanned copy of the DD in place of PBG and has to ensure delivery of hard copy to the original DD to the Buyer within 15 days of award of contract.

9. Forms of EMD and PBG

Successful Bidder can submit the Performance Security in the form of Fixed Deposit Receipt also (besides PBG which is allowed as per GeM GTC). FDR should be made out or pledged in the name of

A/C (Name of the Seller). The bank should certify on it that the deposit can be withdrawn only on the demand or with the sanction of the pledgee. For release of Security Deposit, the FDR will be released in favour of bidder by the Buyer after making endorsement on the back of the FDR duly signed and stamped along with covering letter.
