- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. - 5. - 6. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. Bidders are bound to accept the orders accordingly.

(c) <u>Financial standing:</u>

2. Undertaking:

- (i)Blacklisting: We, solemnly declare that neither we nor any of our affiliates or subsidiaries including s ubcontractors or suppliers for any part of the contract do not stand declared ineligible/ blacklisted/ bann ed/ debarred by any Government Agency in India.

6. Applicability in Special Cases

i) Authorized Representatives:

Bids of bidders quoting as authorised representative of a principal manufacturer would also be consid ered to be qualified, provided: i) their principal manufacturer meets all the criteria above without exe mption, and ii) the principal manufacturer furnishes a legally enforceable tender-specific authorisation

in the prescribed form assuring full guarantee and warranty obligations as per the general and special conditions of contract; and iii) the bidder himself should have been associated, as authorised represen tative of the same or other Principal Manufacturer for same set of services as in present bid (supply, in stallation, satisfactorily commissioning, after sales service as the case may be) for same or similar 'Pr oduct' for past three years ending on '31.03.2022'.

ii) For Existing successful Past Suppliers:

In case the bidder (manufacturer or principal of authorised representative) who is a successful past su pplier of 'The Product' in at least one of the recent past three procurements, who do not meet any or more of requirements above, would also be considered to be qualified in view of their proven credentials, for the maximum quantity supplied by him in such recent past. (This clause is not applicable for S ecurity Items as notified by Government of India from time to time.)

iii) Joint Ventures and Holding Companies:

Credentials of the partners of Joint ventures 5 / 8 cannot (repeat cannot) be clubbed for the purpose of compliance of PQC in supply of Goods/Equipment, and each partner must comply with all the PQC criteria independently However, for the purpose of qualifying the Financial Standing Criteria, the Financial Standing credentials of a Holding Company can be clubbed with only one of the fully owned subsidiary bidding company, with appropriate legal documents proving such ownership.

7. Payment Authority and Payment Terms:
