- SCC-1: Performance Bond/ Security: (Clause No. 6.1) Within twenty-one days after the issue of notification of ward by ISP, the supplier shall furnish performance security to ISP for an amount equal to three (3) percent of the total value of the contract valid up to Sixty (60) days after the date of completion of all contractual obligations by the supplier, including the warranty obligations.

### SPECIFICATIONS FOR RE-PINNING OF PERFORATING PIN CYLINDERS

### **Description:**

The perforating Pin Cylinder consists of stepped shaft mounted with 7.2 mm thick shell in which steel perforating pins are fitted. The Pin Cylinder is used for on-line perforation of Stamps on Rotogravure Stamp printing Machine for 4 X 50 Stamps, 4 X 100 Stamps and 4 X 70 Stamps.

This pin cylinder bears Mini. 9997 pins and Max. 12276 steel perforating pins. The perforation of the Stamps is carried out by grinding away of paper by means of Rotary Cutter set to have contact with pins of pin cylinder. The pins should, therefore, be firmly fixed in the shell and should not have any tendency to get pressed while running under grinding pressure.

The complete pin cylinder should be supplied after necessary grinding of the pins to be used on the machine straightway. Re-pinning of these cylinders will cover replacement of all worn out/damaged pins and proper fitting of new pins on shell of the cylinder.

### Description of the work/ job:

To remove all pins from the shell of the cylinder, properly clean the shell and holes, place/fit new pins in the shell in such a way that no pin should come out during the actual use of the cylinder on perforating unit of the machine.

The steel perforating pins used for repining must be of good quality steel, which should not break or damage when coming in contact with the high speed steel rotary cutters at the time of perforation on machine. Moreover, the material of the pins should be so good that even after perforating Min 3 Lakh sheets, the pins should not get blunt and should retain their original shape.


