- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
- 2. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
- 3. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
- 4. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU / Public Listed Company for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.
- 5. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and small enterprises will be allowed to participate .In case Buyer has selected Purchase preference to Micro and Small Enterprises clause in the bid, the same will get precedence over this clause.
- 6. Procurement under this bid is reserved for purchase from Micro and Small Enterprises whose credentials are validated online through Udyog Aadhaar for that product category. If the bidder wants to avail the reservation benefit, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service.
- 7. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
- 8. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 40% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU / Public Listed Company. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

1. Buyer Added Bid Specific ATC

A. MINIMUM QUALIFICATION CRITERIA

1. Experience and Past Performance: The bidder firm should have manufactured and supplied at le ast 12000 Nos. of similar type of Corrugated Boxes in any one year during last five years i.e. from 01st April 2017 to 31st March 2022.

Note: Start-ups and Micro and small Enterprises are exempted from Experience and Past Performance cr iteria. In case any bidder is seeking exemption from Experience and Past Performance criteria, the supp orting documents to prove his eligibility for exemption must be submitted for evaluation.

2. Capability, equipment and manufacturing facilities:-The Bidder firm must have an annual cap acity to manufacture and supply at least 12000 Nos. of Corrugated Boxes. Undertaking regarding this r equirement shall be submitted by the bidder on their Letter Head.

3. Financial Standing:

- a) The average annual turnover of the bidder during the last three years, ending on 31.03.2022 shou ld be at least Rs.23,06,640/-as per the annual report (Audited Balance sheet and Profit & Loss Account shall be submitted for evaluation) of Financial Year 2019-2020, 2020-2021 & 2021-2022, duly aut henticated by a chartered Accountant/Cost Accountant in India or equivalent in relevant countries Note: The Average Annual Turnover criteria are exempted for Start-ups and Micro and Small Enterprises. In case any bidder is seeking exemption from Turnover criteria, the supporting documents to prove his eligibility for exemption must be submitted for evaluation.
- b) The bidder should not have suffered any financial loss for more than one year during the last three years, ending on '31.03.2022'.
- (i) The net worth of the Bidder should not be negative on '31.03.2022' and also
- (ii) Should not have eroded by more than 30% in the last three years, ending on '31.03.2022'.

4. Applicability in Special Cases

- **a) For Existing successful Past Suppliers:** In case the bidder who is a successful past supplier of 'The Product' in at least one of the recent past three procurements, who do not meet any or mo re of requirements above, would also be considered to be qualified in view of their proven credentials, for the maximum quantity supplied by him in such recent past. (This clause is not applicable for Security Items as notified by Government of India from time to time.)
- **b)** Joint Ventures and Holding Companies: Credentials of the partners of Joint ventures cannot (repeat cannot) be clubbed for the purpose of compliance of PQC in supply of Goods/Equipment, a nd each partner must comply with all the PQC criteria independently However, for the purpose of q ualifying the Financial Standing Criteria, the Financial Standing credentials of a Holding Company c an be clubbed with only one of the fully owned subsidiary bidding company, with appropriate legal documents proving such ownership.
- c) Start-up Enterprises: Requirements of prior experience and turnover would be relaxed for Start-up enterprises as recognized by Department for Promotion of Industry and Internal Trade (DPIIT), subject to their meeting the quality and technical specifications. Such Start-ups maybe either MSE or otherwise.
- **5. Certificate of MSE:** The firm must have a valid registration certificate as MSE issued by NSIC, DGS &D or any authorized body by Ministry of MSME for Manufacturing of the tendered item and the same s hall be submitted by the firm along with tender/bid.
- 6. The Bidder shall give following undertakings on their Letter Head regarding this require ment.
 - i) The firm should give a declaration that, We M/s.<Name of the bidder firm> have not been black-lis ted/debarred for dealing by Government of India/PSU/Reputed Organisation in the Past.
 - **ii) Agree to withdraw all deviations:** The declaration that "We M/s.<Name of the bidder firm> agree to withdraw all the deviations, if any, unconditionally and accept all the terms and conditions of the tender document including the technical specifications".

- 3. CHARACTERISTICS OF CORRUGATED BOX:-
 - 3.1 The Corrugated Box shall be five (05) ply Broad flute and flute direction should be vertica
 - 3.2 Top layer to be covered with bituminized tar water proof paper of 220 GSM and reinforce d with jute cloth of minimum 180 GSM.
 - 3.3 Minimum 300 GSM of liner Kraft paper "A" grade shall be used for the manufacturing of the Corrugated Box.
 - 3.4 The adhesive used shall be strong enough to bond with the paper and of low moisture ab sorbency, so that the ply will not be distorted when come in the contact of moisture.
 - 3.5 The outer and inner surface of the box shall be water resistant, nevertheless the outer su rface shall be capable of holding Turpentine Solvent based Stencil Ink.
 - 3.6 To be printed with Code Mark identification (Code Mark XXX will be provided to the succe ssful tenderer).
 - 3.7 Two slots at each side i.e. front and back side of box having $\frac{1}{4}$ " distance from both ends and one slot at center on left and right side of box. The slot size required to be of 15 MM fo r holding of steel/nylon strips.
 - 3.8 Both the corners of flap should be curved so that flap can be inserted easily.
- **4.** The supplier shall submit Test reports along with each batch of supply, as per the specification , to ISP.

C. Pre-Dispatch Sample and Delivery Schedule & Quality Control Requirement (To be submitte d on firm's Letter Head as a token of acceptance):-

However, ISP can vary the delivery quantity by +/- 30% by informing the firm in advance.

3) Each of the above delivery shall be proportionally placed as per parallel contract/bid splitting condit ion.

4) Quality Control Requirement:-

(i) The material supplied by the successful bidder will be accepted on all parameters as per specificati on provided in the Bid Document. The purchaser reserves the right to get the material supplied tested

from in-house laboratory or any other laboratory of repute and in case the material is found not meeting the specification, the purchaser shall be entitled to cancel the contract, and if so desired, purchase or otherwise the purchase of the stores at the risk and cost of the contractor.

(ii) After receipt of goods, the goods will be inspected/tested at ISP. If any defect/variation is noticed th en the same will be replaced free of cost by the supplier/seller up to India Security Press, Nashik Road, failing which equivalent amount of defective material will be deducted in the subsequent bills or from any amount due to them.

D. Special Conditions of Contract (SCC)

- **1) Transportation of Goods:** The transportation of goods to be procured will be done by the supplie r on FOR ISP Basis. The total cost of the transportation should be indicated in the price bid of the item t o be procured.
- **2) Insurance:** Since Indigenous bidder has to deliver the material on FOR ISP Nashik basis therefore t he cost of the insurance will also the part of the cost of the material borne by the supplier. A specific in surance cover for each consignment/supply is to be given by firm, as applicable.
- **3) Distribution of Dispatch Documents for Clearance/Receipt of Goods:** The supplier shall sen d all the relevant dispatch documents well in time to ISP Nashik to enable ISP Nashik to clear or receiv e (as the case may be) the goods in terms of the contract.
- **4) Taxes and Duties:** Supplier shall be entirely responsible for all taxes, duties, fees, levies etc. incur red until delivery of the contracted goods to SPMCIL. If the tenderer fails to include taxes and duties as per law of the land in the tender, no claim thereof will be considered by purchaser at a later stage.
- **5) Terms and Mode of Payment:** 100% payment will be released within ten (10) days of issue of co nsignee receipt-cum-acceptance certificate (CRAC) and on-line submission of bills. The payment will be done through online mode only. Therefore, the suppliers have to produce all the Bank details such as Name of Bank, Account No., IFSC Code No., MICR No. along with the Tender document. TDS, if any, will be deducted as applicable.
- **6) Bid Splitting/Parallel Contract:** India Security Press, Nashik reserves its rights to conclude Bid Splitting/Parallel Contract with more than one bidder (maximum upto two bidders for the same tender) without any prejudice to the capacity of the L1 bidder. In case of splitting in two, the ratio of 70:30 will be used.
- **7) Termination/Short Close of Contract:** India Security Press, Nashik reserves the right to terminat e the contract, in whole or in part for ISP's convenience, by serving written notice on the supplier at an y time during the currency of contract.

2. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

3. Forms of EMD and PBG

5. **Sample Clause**

After award of contract – Successful Bidder shall have to get advance sample approved from buyer before bulk manufacturing / starting bulk supplies. Successful Bidder shall submit

samples for Buyer's approval, within 15 days of award of contract. Buyer shall, as per contract specifications framework, either approve the advance sample or will provide complete list of modification required in the sample within 10 days of receipt of advance sample. Seller shall be required to ensure supply as per approved sample with modifications as communicated by Buyer. If there is delay from buyer side in approval of advance sample – the delivery period shall be refixed without LD for the period of delay in sample approval. In case, the sample is found to have major deviations / not conforming to the Contract specifications, the buyer at its discretion may call for fresh samples for approval before allowing bulk supplies or may terminate the contract after notifying the deviations to the seller.

Unless otherwise provided in the contract, all samples required for test shall be supplied by the contractor free of cost. Where under the contract, the contractor is required to submit an advance sample, any expenses incurred by the contractor on or in connection with the production of stores in bulk, before the

sample has been approved unconditionally shall be borne by the Seller and he shall not claim any compensation in the event of such sample being found unacceptable by the Buyer / Consignee.

6. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract.
