1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.

2. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer. 3. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

4. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU / Public Listed Company for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.

5. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

6. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non - Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and small enterprises will be allowed to participate .In case

Buyer has selected Purchase preference to Micro and Small Enterprises clause in the bid, the same will get precedence over this clause.

7. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer)of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for %(selected by Buyer) percentage of total QUANTITY.

8. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

9. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 40% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU / Public Listed Company. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

A. MINIMUM QUALIFICATION CRITERIA

1. Experience & Past Performance: The bidder (Manufacturer or Principal of authorized represe ntative- hereinafter referred simply as 'The Bidder') should have manufactured and/or supplie d at least 20,000 Kg of similar type of "Synthetic Resin Adhesive" in any one of the last five ye ars ending on '31 March 2022'.

Note: The 'Experience and Past experience criteria' is exempted for Startups and Micro and Small Enterpri ses. In case any bidder is seeking exemption from Experience and Past Performance criteria, the supportin g documents to prove his eligibility for exemption must be submitted for evaluation.

2. Capability, equipment and manufacturing facilities:-

- a) The bidder must have an annual capacity to manufacture and supply at least 20,000 Kg of "Sy nthetic Resin Adhesive".
- **b)** The bidder has to submit the following details along with the bid:
 - i) Name of the machine utilized to supply the quoted product.
 - ii) The number of machines being utilized for the production and the capacity of each machine.
 - iii) Total Annual capacity of Manufacturer
 - iv) Supply orders in hand and proportionate capacity to supply quoted amount

Note:

i. At the discretion of the purchaser, the Capacity / Capability Assessment / Verification of bidder / manufa cturer firm(s) might be undertaken by a Committee or through a third party Technical Consultancy / Inspe ction agencies to ensure that the firm is/are identified and capable to supply the machine/item/material/pr oduct as required.

ii. During capacity/capability assessment, firm has to manufacture sample as per ISP's Bid Specification. T he sample (at least 10 Kg) shall be collected by the nominated committee and machine trial shall be cond ucted at ISP, Nashik and capability assessment shall be finalized after machine trial.

3. Financial Standing:

a) The average annual financial turnover of the bidder during the last three years, ending on '31.0 3.2022', should be at least Rs.53,10,000/- as per the annual (audited balance sheet and profit & loss account of relevant Financial Year shall be submitted for evaluation) of Financial Year 20 19-2020, 2020-2021 & 2021-2022, duly authenticated by a Chartered Accountant/Cost Account ant in India or equivalent in relevant countries.

Note: The Average Annual Turnover criteria are exempted for Start-ups and Micro and Small En terprises. In case any bidder is seeking exemption from Turnover criteria, the supporting docum ents to prove his eligibility for exemption must be submitted for evaluation.

- **b)** The bidder should not have suffered any financial loss for more than one year during the last th ree years, ending on '31.03.2022'.
 - (i) The net worth of the Bidder should not be negative on '31.03.2022' and also
 - (ii) Should not have eroded by more than 30% in the last three years, ending on '31.03.2022'.

4. Applicability in Special Cases

a) Applicability to 'Make in India': Bidders (manufacturer or principal of authorized represent ative) If the product is being manufactured in India under a license from a foreign manufacturer who holds intellectual property rights and where there is a technology collaboration agreement/ transfer of technology agreement for indigenous manufacture of a product developed abroad wit h clear phased increase in local content, and who while meeting all other criteria above, except f or any or more of sub-criteria in Experience and Past Performance above, would also be consider ed to be qualified provided: i) their foreign manufacturer who holds intellectual property rights, meets all the criteria above without exemption, and ii) the Bidder submits appropriate document ary proof for technology collaboration agreement/ transfer of technology agreement for indigeno us manufacture of a product developed abroad with clear phased increase in local content. iii) th e bidder (manufacturer or principal of authorized representative) furnishes along with the bid a le gally enforceable undertaking jointly executed by himself and such foreign Manufacturer for sati sfactory manufacture, Supply (and erection, commissioning if applicable) and performance of 'T he Product' offered including all warranty obligations as per the general and special conditions of contract.

b) Authorized Representatives: Bids of bidders quoting as authorized representative of a prin cipal manufacturer would also be considered to be qualified, provided: i) their principal manufact urer meets all the criteria above without exemption, and ii) the principal manufacturer furnishes a legally enforceable tender-specific authorization in the prescribed form assuring full guarantee and warranty obligations as per the general and special conditions of contract; and iii) the bidder himself should have been associated, as authorized representative of the same or other Principal Manufacturer for same set of services as in present bid (supply, installation, satisfactorily commi ssioning, after sales service as the case may be) for same or similar 'Product' for past three years ending on '31.01.2022'.

c) For Existing successful Past Suppliers: In case the bidder (manufacturer or principal of au thorized representative) who is a successful past supplier of 'The Product' in at least one of the r ecent past three procurements, who do not meet any or more of requirements above, would also be considered to be qualified in view of their proven credentials, for the maximum quantity supplied by him in such recent past. (This clause is not applicable for Security Items as notified b y Government of India from time to time.)

d) Joint Ventures and Holding Companies: Credentials of the partners of Joint ventures cann ot (repeat cannot) be clubbed for the purpose of compliance of PQC in supply of Goods/Equipme nt, and each partner must comply with all the PQC criteria independently However, for the purpo se of qualifying the Financial Standing Criteria, the Financial Standing credentials of a Holding Co mpany can be clubbed with only one of the fully owned subsidiary bidding company, with approp riate legal documents proving such ownership.

e) Development/ insufficient market capacity or Exceptional One- Off Cases: These are those items which are either being newly developed where vendors are yet to be developed or f or new/ existing items where the capacity available in market is inadequate compared to our an nual requirements. Exceptional one-off cases are such items/ Plant & Machinery which are procu red infrequently (say once in 3 years or longer periods). In such cases PQC Should be Decided wi th the approval of CFA in individual cases.

f) Start-up Enterprises: Requirements of prior experience and turnover would be relaxed for S tart-up enterprises as recognized by Department for Promotion of Industry and Internal Trade (D PIIT), subject to their meeting the quality and technical specifications. Such Start-ups maybe eith er MSE or otherwise.

5. The Bidder shall give following undertakings on their Letter Head regarding this requirement.

- i) Non Blacklisting: We M/s.<Name of the bidder firm> has not been blacklisted/ debarre d by any government agency / Public Sector Unit/ Reputed organization.
- **ii)** Agree to withdraw all deviations: We M/s.<Name of the bidder firm> agree to withdra w all the deviations, if any, unconditionally and accept all the terms and conditions of the t ender document including the technical specifications".

Manufacturer's Authorization Letter:** In case the bidder firm/ bidder offers to supply 'Synthetic Resin Adhesive', which are manufactured by some other firm, the bidder has to be duly authorized by the manuf acturer of the stated material to quote for and supply the same to India Security Press, a unit of SPMCIL. Th e bidder shall submit the manufacturer's authorization letter to this effect as per the standard form provid ed in "buyer uploaded ATC Uploaded document".

Note: One manufacturer can participate through one authorized agent or one agent can particip ate on behalf of one Principal Manufacturer only.

1) Pre-Production Sample:-50 Kg may be delivered within 15 days from the date of award of GeM C ontract.

2) Delivery Schedule:-Detailed delivery schedule is as follows:

- i. 1st lot of 3000 Kg within 23 days to 40 days of award of GeM Contract
- ii. 2nd lot of 3000 Kg within 41 days to 60 days of award of GeM Contract
- iii. 3rd lot of 5000 Kg within 61 days to 90 days of award of GeM Contract
- iv. 4th lot of 7000 Kg within 91 days to 120 days of award of GeM Contract

3) Each of the above delivery shall be proportionally placed as per parallel contract/bid splitting condit ion.

4) Quality Control Requirement:-

The material supplied by the successful bidder will be accepted on the basis of trial carried out on the machine and other technical requirement mentioned in section VII along with Test Certificate to be sen t to purchaser along with each consignment from a recognized Govt. Laboratory/ NABL Accredited Lab. If any defects observed or the material found unsuitable, then the same will be returned to the suppli

er for free replacement upto India Security Press, Nashik.

D. Special Conditions of Contract (SCC) :-(To be submitted on firm's Letter Head as a token of acceptance)

1) Bid Splitting/Parallel Contract: India Security Press, Nashik reserves its rights to conclude Bid Splitting/Parallel Contract with more than one bidder (maximum upto Two bidders for the same tender) without any prejudice to the capacity of the L1 bidder. In case of splitting in Two, the ratio of 70:30 will be used.

2) Transportation of Goods: The transportation of goods to be procured will be done by the supplie r on FOR ISP Basis. The total cost of the transportation should be indicated in the price bid of the item t o be procured.

3) Insurance: Since Indigenous bidder has to deliver the material on FOR ISP Nashik basis therefore t he cost of the insurance will also the part of the cost of the material borne by the supplier. A specific in surance cover for each consignment/supply is to be given by firm, as applicable.

4) Distribution of Dispatch Documents for Clearance/Receipt of Goods: The supplier shall sen d all the relevant dispatch documents well in time to ISP Nashik to enable ISP Nashik to clear or receiv e (as the case may be) the goods in terms of the contract.

5) Taxes and Duties: Supplier shall be entirely responsible for all taxes, duties, fees, levies etc. incur red until delivery of the contracted goods to SPMCIL. If the tenderer fails to include taxes and duties as per law of the land in the tender, no claim thereof will be considered by purchaser at a later stage.

6) Terms and Mode of Payment: 100% payment will be released within ten (10) days of issue of co nsignee receipt-cum-acceptance certificate (CRAC) and on-line submission of bills. The payment will be done through online mode only. Therefore, the suppliers have to produce all the Bank details such as Name of Bank, Account No., IFSC Code No., MICR No. along with the Tender document. TDS, if any, will be deducted as applicable.

7) NOTE:
