- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
- 2. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. - 3. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
- 4. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU / Public Listed Company for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.
- 5. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and small enterprises will be allowed to participate .In case Buyer has selected Purchase preference to Micro and Small Enterprises clause in the bid, the same will get precedence over this clause.
- 6. Procurement under this bid is reserved for purchase from Micro and Small Enterprises whose credentials are validated online through Udyog Aadhaar for that product category. If the bidder wants to avail the reservation benefit, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service.
- 7. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
- 8. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 40% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU / Public Listed Company. 1. Forms of EMD and PBG

2. Forms of EMD and PBG

A/C (Name of the Seller). The bank should certify on it that the deposit can be withdrawn only on the demand or with the sanction of the pledgee. For release of Security Deposit, the FDR will be released in favour of bidder by the Buyer after making endorsement on the back of the FDR duly signed and stamped along with covering letter. A. MINIMUM QUALIFICATION CRITERIA

1. Experience and Past Performance: The bidder firm should have in Manufactured and supplied at least 6800 Nos. of similar type of Corrugated Boxes in any one year during last five years i.e. from 01st April 2017 to 31st March 2022.

Note: Start-ups and Micro and small Enterprises are exempted from Experience and Past Performance c riteria. In case any bidder is seeking exemption from Experience and Past Performance criteria, the sup porting documents to prove his eligibility for exemption must be submitted for evaluation.

2. Capability, equipment and manufacturing facilities:-The Bidder firm must have an annual cap acity to manufacture and supply at 6800 Nos. of similar type of Corrugated Boxes. Undertaking regarding this requirement shall be submitted by the bidder on their Letter Head.

3. Financial Standing:

- a) The average annual turnover of the bidder during the last three years, ending on 31.03.2022 should be at least Rs.11,22,000/-as per the annual report (Audited Balance sheet and Profit & Loss Account shall be submitted for evaluation) of Financial Year 2019-2020, 2020-2021 & 2021-2022, duly authenticated by a chartered Accountant/Cost Accountant in India or equivalent in relevant countries

 Note: The Average Annual Turnover criteria are exempted for Start-ups and Micro and Small Enterprises. In case any bidder is seeking exemption from Turnover criteria, the supporting documents to prove his eligibility for exemption must be submitted for evaluation.
- **b)** The bidder should not have suffered any financial loss for more than one year during the last thre e years, ending on '31.03.2022'.
 - (i) The net worth of the Bidder should not be negative on '31.03.2022' and also
 - (ii) Should not have eroded by more than 30% in the last three years, ending on '31.03.2022'.

4. Applicability in Special Cases

- **a) For Existing successful Past Suppliers:** In case the bidder who is a successful past supplier of 'The Product' in at least one of the recent past three procurements, who do not meet any or mo re of requirements above, would also be considered to be qualified in view of their proven credentials, for the maximum quantity supplied by him in such recent past. (This clause is not applicable for Security Items as notified by Government of India from time to time.)
- **b) Joint Ventures and Holding Companies:** Credentials of the partners of Joint ventures cannot (repeat cannot) be clubbed for the purpose of compliance of PQC in supply of Goods/Equipment, a nd each partner must comply with all the PQC criteria independently However, for the purpose of q ualifying the Financial Standing Criteria, the Financial Standing credentials of a Holding Company c an be clubbed with only one of the fully owned subsidiary bidding company, with appropriate legal documents proving such ownership.
- **c) Start-up Enterprises:** Requirements of prior experience and turnover would be relaxed for Sta rt-up enterprises as recognized by Department for Promotion of Industry and Internal Trade (DPIIT), subject to their meeting the quality and technical specifications. Such Start-ups maybe either MSE or otherwise.
- **5. Certificate of MSE:** The firm must have a valid registration certificate as MSE issued by NSIC, DGS &D or any authorized body by Ministry of MSME for Manufacturing of the tendered item and the same s hall be submitted by the firm along with tender/bid.

- 3. CHARACTERISTICS OF CORRUGATED BOX:-
 - 3.1 The Corrugated Box shall be five (05) ply Broad flute and flute direction should be vertical.
 - 3.2 Top layer to be covered with bituminized tar water proof paper of 220 GSM and reinforced with j ute cloth of minimum 180 GSM.
 - 3.3 Minimum 300 GSM of liner Kraft paper "A" grade shall be used for the manufacturing of the Corrugated Box.
 - 3.4 The adhesive used shall be strong enough to bond with the paper and of low moisture absorben cy, so that the ply will not be distorted when come in the contact of moisture.
 - 3.5 The outer and inner surface of the box shall be water resistant, nevertheless the outer surface s hall be capable of holding Turpentine Solvent based Stencil Ink.
 - 3.6 To be printed with Code Mark identification (Code Mark XXX will be provided to the successful te nderer).
 - 3.7 Two slots at each side i.e. front and back side of box having ¼" distance from both ends and on e slot at center on left and right side of box. The slot size required to be of 15 MM for holding of st eel/nylon strips.
 - 3.8 Both the corners of flap should be curved so that flap can be inserted easily.
- **4.** The supplier shall submit Test Reports along with each batch of supply, as per the specification, to I SP.

C. Pre-Dispatch Sample and Delivery Schedule & Quality Control Requirement (To be submitte d on firm's Letter Head as a token of acceptance):-

4) Quality Control Requirement:-

(i) The material supplied by the successful bidder will be accepted on all parameters as per specificati

onprovided in the Bid Document. The purchaser reserves the right to get the material supplied tested f romin-house laboratory or any other laboratory of repute and in case the material is found not meeting thespecification, the purchaser shall be entitled to cancel the contract, and if so desired, purchase orot herwise the purchase of the stores at the risk and cost of the contractor.

(ii) After receipt of goods, the goods will be inspected/tested at ISP. If any defect/variation is noticed th enthe same will be replaced free of cost by the supplier/seller up to India Security Press, Nashik Road, failing which equivalent amount of defective material will be deducted in the subsequent bills or from anyamount due to them.

D. Special Conditions of Contract (SCC)

- **1) Transportation of Goods:** The transportation of goods to be procured will be done by the supplie r on FOR ISP Basis. The total cost of the transportation should be indicated in the price bid of the item t o beprocured.
- **2) Insurance:** Since Indigenous bidder has to deliver the material on FOR ISP Nashik basis therefore t he cost of the insurance will also the part of the cost of the material borne by the supplier. A specificins urance cover for each consignment/supply is to be given by firm, as applicable.

- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
