- 1. - 5. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band defined in relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.
- 6. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

#### 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

#### 2. Buyer Added Bid Specific ATC

The prospec tive interested to participate in this tender are requested to attend the pre-bid conference for clarifications on technical issues, at India Security Press, Nashik. The queries of Pre-bid conference if any, shall reach to CGM, ISP, Nashik on or before 10.06.2023

#### 2. QUALIFICATION/ ELIGIBILITY CRITERIA:

**a)** Experience and past performance: The bidder must have experience of having successfully complet ed similar kind of services for the value of at least Rs. 5,57,904/-, in any of the last five years ending on 3 1 st March 2022.

\*Copies of PO's and completion/experience certificates issued by customers to be provided in support of a bove for each items separately.

**<u>Note:</u>** 'Startups, Micro and Small Enterprises' are exempted from 'Experience and Past Performance Criteria'

**b) Capability, equipment and manufacturing facilities:** The bidder must have capability to provide the relevant services.

#### c) Financial standing:

(i) Average Annual Turnover of the Bidder firm (manufacturer or principal of authorised dealer) during the I ast three years, ending on "31 st March 2022" should be Rs. 5,57,904/- as per the annual report (audited balance sheet and profit & loss account) of the relevant period duly authenticated by a Chartered Account ant / Cost Accountant in India.'

# <u>Note:</u> 'Startups, Micro and Small Enterprises' are exempted from 'Average Annual Turnover Criteria'.

- (ii) The Bidder should not have suffered any financial loss for more than one year during the last three years ending on "31 st March 2022".
- (iii) The net worth of the bidder should not be negative on "31 st March 2022" and should not have eroded by more than 30% in the last three years, ending on "31 st March 2022".

#### 3. Undertaking:

- (i) **Blacklisting:** We, solemnly declare that neither we nor any of our affiliates or subsidiaries including s ubcontractors or suppliers for any part of the contract do not stand declared ineligible/ blacklisted/ banne d/ debarred by any Government Agency in India.

- **4.** Ministry of Finance, Department of Expenditure, Public Procurement Division, Orders (Public Procurement 1,2 and 3) F. No. 6/18/2019-PPD dated 23rd/ 24th July 2020 (or any further amendments thereof) regarding eligibility of bidders from specified countries shall be applicable to this tender. Bidders are required sub mit the appropriate undertaking in this regard. Salient features of this are:
- (i) Any bidder from a country which shares a land border with India (excluding countries as listed in the we bsite of Ministry of External Affairs, to which the Government of India has extended lines of credit or in whi ch the Government of India is engaged in development projects) will be eligible to bid in this tender only if the bidder is registered with the Registration Committee constituted by the Department for promotion of In dustry and Internal Trade (DPIIT). The bidders shall enclose following certificate in this regard. "We have re ad the clause regarding restrictions on procurement from a bidder of a country which shares a land border with India; and solemnly certify that we are not from such a country or, if from such a country, we are regis tered with the Competent Authority (copy enclosed). We hereby certify that we fulfill all requirements in th is regard and are eligible to be considered."
- (ii) In tenders for Turnkey contracts including works contracts, the successful bidder shall not be allowed to sub-contract works to any contractor from a country which shares a land border with India unless such contractor is similarly registered with the Registration Committee constituted by the Department for Promot ion of Industry and Internal Trade (DPIIT). association of several persons, or firms or companies), every artificial juridical person not falling in any of the descriptions of bidders stated hereinbefore, including any agency branch or office controlled by such person, participating in a procurement process.

(iv) "Bidder from a country which shares a land border with India" for the purpose of this Order means:- a) An entity incorporated, established or registered in such a country; or b) A subsidiary of an entity incorpor ated, established or registered in such a country; or c) An entity substantially controlled through entities in corporated, established or registered in such a country; or d) An entity whose beneficial owner is situated in such a country; or e) An Indian (or other) agent of such an entity; or f) A natural person who is a citizen of such a country; or g) A consortium or joint venture where any member of the consortium or joint venture e falls under any of the above.

#### 5. Applicability in Special Cases:

- i) Authorized Representatives: Bids of bidders quoting as authorised representative of a principal manufact urer would also be considered to be qualified, provided: i) their principal manufacturer meets all the criteri a above without exemption, and ii) the principal manufacturer furnishes a legally enforceable tender-specific authorisation in the prescribed form assuring full guarantee and warranty obligations as per the general and special conditions of contract; and iii) the bidder himself should have been associated, as authorised representative of the same or other Principal Manufacturer for same set of services as in present bid (supply, installation, satisfactorily commissioning, after sales service as the case may be) for same or similar 'Product' for pastthree years ending on '31.03.2022'.
