- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
- 2. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
- 3. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU / Public Listed Company for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.
- 4. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum

local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non - Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and small enterprises will be allowed to participate .In case Buyer has selected Purchase preference to Micro and Small Enterprises clause in the bid, the same will get precedence over this clause.

- 5. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer)of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25%(selected by Buyer) percentage of total QUANTITY.
- 6. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 40% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU / Public Listed Company. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

Buyer Added Bid Specific Terms and Conditions/क्रेता द्वारा जोड़ी गई बिड की विशेष शर्तें

1. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

A. Minimum Qualification Criteria

1. Experience & Past Performance: The bidder should have manufactured and/or supplied at lea st 200 KG of similar type of "Nylon Rubber Band" in any one of the last five years ending on "31 Mar ch 2022".

Note: The 'Experience and Past experience criteria' is exempted for Startups and Micro and Small Enterprises. In case any bidder is seeking exemption from Experience and Past Performance criteria, the supporting documents to prove his eligibility for exemption must be submitted for evaluation.

2. Capability, equipment and manufacturing facilities:- The bidder must have an annual capa city to manufacture and/or supply at least 200 KG of similar type of "Nylon Rubber Band". Undertaking regarding this requirement shall be submitted by the bidder on their Letter Head.

Note: At the discretion of the purchaser, the Capacity / Capability Assessment / Verification of bidde r / manufacturer firm(s) might be undertaken by a Committee or through a third party Technical Con sultancy / Inspection agencies to ensure that the firm is/are identified and capable to supply the mac hine/item/material/product as required.

4. Applicability in Special Cases

- a) Applicability to 'Make in India': Bidders (manufacturer or principal of authorised representat ive) If the product is being manufactured in India under a license from a foreign manufacturer who holds intellectual property rights and where there is a technology collaboration agreement/ transfe r of technology agreement for indigenous manufacture of a product developed abroad with clear p hased increase in local content, and who while meeting all other criteria above, except for any or more of sub-criteria in Experience and Past Performance above, would also be considered to be qu alified provided: i) their foreign manufacturer who holds intellectual property rights, meets all the criteria above without exemption, and ii) the Bidder submits appropriate documentary proof for te chnology collaboration agreement/ transfer of technology agreement for indigenous manufacture of a product developed abroad with clear phased increase in local content. iii) the bidder (manufact urer or principal of authorised representative) furnishes along with the bid a legally enforceable un dertaking jointly executed by himself and such foreign Manufacturer for satisfactory manufacture, Supply (and erection, commissioning if applicable) and performance of 'The Product' offered including all warranty obligations as per the general and special conditions of contract.
- **b) Authorized Representatives:** Bids of bidders quoting as authorised representative of a princi pal manufacturer would also be considered to be qualified, provided: i) their principal manufacture r meets all the criteria above without exemption, and ii) the principal manufacturer furnishes a leg ally enforceable tender-specific authorisation in the prescribed form assuring full guarantee and w arranty obligations as per the general and special conditions of contract; and iii) the bidder himself should have been associated, as authorised representative of the same or other Principal Manufact urer for same set of services as in present bid (supply, installation, satisfactorily commissioning, af ter sales service as the case may be) for same or similar 'Product' for past three years ending on '3 1 01 2022
- c) For Existing successful Past Suppliers: In case the bidder (manufacturer or principal of auth orised representative) who is a successful past supplier of 'The Product' in at least one of the rece nt past three procurements, who do not meet any or more of requirements above, would also be considered to be qualified in view of their proven credentials, for the maximum quantity supplied by him in such recent past. (This clause is not applicable for Security Items as notified by Government of India from time to time.)
- **d)** Joint Ventures and Holding Companies: Credentials of the partners of Joint ventures cannot (repeat cannot) be clubbed for the purpose of compliance of PQC in supply of Goods/Equipment, a nd each partner must comply with all the PQC criteria independently However, for the purpose of q ualifying the Financial Standing Criteria, the Financial Standing credentials of a Holding Company c an be clubbed with only one of the fully owned subsidiary bidding company, with appropriate legal documents proving such ownership.
- **e) Start-up Enterprises:** Requirements of prior experience and turnover would be relaxed for Sta rt-up enterprises as recognised by Department for Promotion of Industry and Internal Trade (DPIIT), subject to their meeting the quality and technical specifications. Such Start-ups maybe either MSE or otherwise.

5. The Bidder shall give following undertakings on their Letter Head regarding this requirement.

i) Blacklisting: We <name of the firm> has not been blacklisted/ debarred by any government a

gency / Public Sector Unit/ Reputed organization.

ii) Agree to withdraw all deviations: "We <name of the firm> agree to withdraw all the deviations, if any, unconditionally and accept all the terms and conditions of the tender document including the technical specifications".

B. Technical Specifications (To be submitted on firm's Letter Head as a token of acceptance):

- 1. Material Name: Pure Nylon Rubber Band
- 2. Virgin quality, Pure CENTRIFUGED LATEX without muddy granules in it.
- 3. Length: 3 inches.
- 4. Thickness: 2 MM
- 5. Expandable size: up to 8 inches (should retain its elasticity)
- 6. Colours: Fluorescent
- 7. It should stand temperature up to 200° C
- 8. It should be free from ragged and nicked edges and have no objectionable ODOUR.
- 9. Should not melt/break/stick to each other while in storage for long period.

C. Delivery Schedule & Quality Control Requirement (To be submitted on firm's Letter Head as a token of acceptance):-

1) Delivery Schedule:- The firm has to supply entire quantity within 45 days from the date of issu e of GeM Contract.

2) Quality Control Requirement:-

- i. The material supplied by the successful bidder will be accepted on manufacturers t est certificate from its own laboratory or a laboratory of repute conforming to all param eters as per specification as stated above. The purchaser reserves the right to get the material supplied tested from in-house laboratory or any other laboratory of repute and in case the material is found not meeting the specification, the purchaser shall be entitl ed to cancel the contract, and if so desired, purchase or otherwise the purchase of the s tores at the risk and cost of the contractor.
- ii. After receipt of goods, the goods will be inspected/tested at ISP. If any defect/variation is noticed then the same will be replaced free of cost by the supplier/seller up to India Security Pr ess, Nashik Road, failing which equivalent amount of defective material will be deducted in the subsequent bills or from any amount due to them.

<u>D. Special Conditions of Contract (SCC) (To be submitted on firm's Letter Head as a token of ac ceptance)</u>

- **1) Transportation of Goods:** The transportation of goods to be procured will be done by the suppl ier on FOR ISP Basis. The total cost of the transportation should be indicated in the price bid of the it em to be procured.
- **2) Insurance:** Since Indigenous bidder has to deliver the material on FOR ISP Nashik basis therefore the cost of the insurance will also the part of the cost of the material borne by the supplier. A specific insurance cover for each consignment/supply is to be given by firm, as applicable.
- **3) Distribution of Dispatch Documents for Clearance/Receipt of Goods:** The supplier shall se nd all the relevant dispatch documents well in time to ISP Nashik to enable ISP Nashik to clear or receive (as the case may be) the goods in terms of the contract.
- **4) Taxes and Duties:** Supplier shall be entirely responsible for all taxes, duties, fees, levies etc. inc urred until delivery of the contracted goods to SPMCIL. If the tenderer fails to include taxes and dutie s as per law of the land in the tender, no claim thereof will be considered by purchaser at a later sta ge.
- **5) Terms and Mode of Payment:** 100% payment will be released within ten (10) days of i ssue of consignee receipt-cum-acceptance certificate (CRAC) and on-line submission of bills. The payment will be done through online mode only. Therefore, the suppliers have to produc e all the Bank details such as Name of Bank, Account No., IFSC Code No., MICR No. along with the Tender document. TDS, if any, will be deducted as applicable.

6) NOTE:

1. The terms and conditions, guidelines of SPMCIL Procurement Manual Version 2.0 will be applicab

- 2. All experience, past performance and capacity/ capability related/ data should be certified by the authorized signatory of the bidder firm.

- 4. All the pages submitted are to be sealed & signed by Authorised Signatory failing which t ender shall be treated as unresponsive.

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. Any clause(s) incorporated by the Buyer regarding following shall be treated as null and void and would not be considered as part of bid:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process.
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority.
