5. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. 6. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. Experience & Past Performance: The Bidder (manufacturer or principal of authorized r epresentative-hereinafter referred simply as 'The Bidder') shall be a manufacturer that has r egularly for at least the last Three (03) years manufactured and supplied "Multipurpose Fire Tender Vehicle" with the same or higher specifications of at least one (01) number in last fiv e (05) years ending on "31st March 2022". At least one (01) number of the product offered f or supply should be in successful operation for at least one (01) year on the date of bid openi ng.

Note: i) Copies of PO's and completion/experience certificates issued by customers to be p rovided in support of above.

ii) Start-ups and Micro and small Enterprises are exempted from Experience and Past Performance criteria. In case any bidder is seeking exemption from Experience and Pas t Performance criteria, the supporting documents to prove his eligibility for exemption must be submitted for evaluation. **2. Capability, equipment and manufacturing facilities:-** The Bidder firm must have an annual capacity to manufacture and supply at least (01) Number of "Multipurpose Fire Tender Vehicle". The self-attested details shall be submitted along with bid.

Note: At the discretion of the purchaser, the Capacity / Capability Assessment / Verificatio n of bidder / manufacturer firm(s) might be undertaken by a Committee or through a third party Technical Consultancy / Inspection agencies to ensure that the firm is/are identified a nd capable to supply the machine/item/material/product as required.

3. Financial Standing:

a) The average annual financial turnover of the bidder during the last three years, endin g on '31.03.2022', should be at least Rs.28,80,000/- as per the annual report (audited b alance sheet and profit & loss account of Financial Year 2019-2020, 2020-2021 & 2021-2022 shall be submitted for evaluation) of Financial Year 2019-2020, 2020-2021 & 2021-2022, duly authenticated by a Chartered Accountant/Cost Accountant in India or e quivalent in relevant countries.

4. Applicability in Special Cases

a) Applicability to 'Make in India': Bidders (manufacturer or principal of authorised rep resentative) If the product is being manufactured in India under a license from a foreign m anufacturer who holds intellectual property rights and where there is a technology collabor ation agreement/ transfer of technology agreement for indigenous manufacture of a produ ct developed abroad with clear phased increase in local content, and who while meeting all other criteria above, except for any or more of sub-criteria in Experience and Past Perform ance above, would also be considered to be qualified provided: i) their foreign manufacture r who holds intellectual property rights, meets all the criteria above without exemption, an d ii) the Bidder submits appropriate documentary proof for technology collaboration agree ment/ transfer of technology agreement for indigenous manufacture of a product develope d abroad with clear phased increase in local content. iii) the bidder (manufacturer or princi pal of authorised representative) furnishes along with the bid a legally enforceable underta king jointly executed by himself and such foreign Manufacturer for satisfactory manufacture e, Supply (and erection, commissioning if applicable) and performance of 'The Product' off ered including all warranty obligations as per the general and special conditions of contract

b) Authorized Representatives: Bids of bidders quoting as authorised representative of a principal manufacturer would also be considered to be qualified, provided: i) their princip al manufacturer meets all the criteria above without exemption, and ii) the principal manuf acturer furnishes a legally enforceable tender-specific authorisation in the prescribed form assuring full guarantee and warranty obligations as per the general and special conditions of contract; and iii) the bidder himself should have been associated, as authorised represe ntative of the same or other Principal Manufacturer for same set of services as in present b id (supply, installation, satisfactorily commissioning, after sales service as the case may be) for same or similar 'Product' for past three years ending on '31.01.2021.

c) For Existing successful Past Suppliers: In case the bidder (manufacturer or principa I of authorised representative) who is a successful past supplier of 'The Product' in at least one of the recent past three procurements, who do not meet any or more of requirements above, would also be considered to be qualified in view of their proven credentials, for the maximum quantity supplied by him in such recent past. (This clause is not applicable for S ecurity Items as notified by Government of India from time to time.)

d) Joint Ventures and Holding Companies: Credentials of the partners of Joint ventures cannot (repeat cannot) be clubbed for the purpose of compliance of PQC in supply of Good

s/Equipment, and each partner must comply with all the PQC criteria independently Howev er, for the purpose of qualifying the Financial Standing Criteria, the Financial Standing cred entials of a Holding Company can be clubbed with only one of the fully owned subsidiary bi dding company, with appropriate legal documents proving such ownership.

e) Development/ insufficient market capacity or Exceptional One- Off Cases: Thes e are those items which are either being newly developed where vendors are yet to be dev eloped or for new/ existing items where the capacity available in market is inadequate com pared to our annual requirements. Exceptional one-off cases are such items/ Plant & Machi nery which are procured infrequently (say once in 3 years or longer periods). In such cases PQC Should be Decided with the approval of CFA in individual cases.

f) Start-up Enterprises: Requirements of prior experience and turnover would be relaxe d for Start-up enterprises as recognised by Department for Promotion of Industry and Inter nal Trade (DPIIT), subject to their meeting the quality and technical specifications. Such St art-ups maybe either MSE or otherwise.

5. The Bidder shall give following undertakings on their Letter Head regarding thi s requirement.

i) Blacklisting: The bidder firm should submit declaration that, We M/s.<Name of the bidd er firm> declaration that the firm has not been blacklisted/ debarred by any government a gency / Public Sector Unit/ Reputed organization.

ii) Agree to withdraw all deviations: The bidder firm should submit declaration that, W e M/s.<Name of the bidder firm> agree to withdraw all the deviations, if any, unconditional ly and accept all the terms and conditions of the tender document including the technical s pecifications".

6. 2) Delivery Schedule:- The firm has to deliver Multipurpose Fire Tender Vehicle within 90 days from the date of issue of 'GeM Contract' (i.e., Firm has to complete the Pre-dispatch ins pection & has to supply Multipurpose Fire Tender Vehicle within 90 days).

3) Quality Control Requirement:-

i. The material supplied by the successful bidder will be accepted on manufacturer's conforming to all parameters as per Technical Specification. The machine will be accepted on manufacturers guarantee certificate to be sent to purchaser. 3) Distribution of Dispatch Documents for Clearance/Receipt of Goods: The supplier shall send all the relevant dispatch documents well in time to ISP Nashik to enable ISP Nashik to clear or receive (as the case may be) the goods in terms of the contract.

4) Taxes and Duties: Supplier shall be entirely responsible for all taxes, duties, fees, levies etc. incurred until delivery of the contracted goods to SPMCIL. If the tenderer fails to include t axes and duties as per law of the land in the tender, no claim thereof will be considered by p urchaser at a later stage.

5) Terms and Mode of Payment: 100% payment will be released within ten (10) days of issue of c onsignee receipt-cum-acceptance certificate (CRAC) and on-line submission of bills.
