1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.

2. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
3. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant /

Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

4. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU / Public Listed Company for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.

5. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non - Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and small enterprises will be allowed to participate. The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023 <u>OM_No.1_4_2021_PPD_dated 18.05.2023</u> for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017.

6. Procurement under this bid is reserved for purchase from Micro and Small Enterprises whose credentials are validated online through Udyog Aadhaar for that product category. If the bidder wants to avail the reservation benefit, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service.

7. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 40% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU / Public Listed Company. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

1. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

A. MINIMUM QUALIFICATION CRITERIA

1. Experience and Past Performance: The bidder should have manufactured and supplied at least 9 600 Nos. similar type of Polythene Bags in any one of the last five years ending on "31 March 2022". **Note:** Start-ups and Micro and small Enterprises are exempted from Experience and Past Performance c riteria. In case any bidder is seeking exemption from Experience and Past Performance criteria, the sup porting documents to prove his eligibility for exemption must be submitted for evaluation.

2. Capability, equipment and manufacturing facilities:-The Bidder firm must have an annual cap acity to manufacture and supply at least 9600 Nos. similar type of Polythene Bags. Undertaking regarding this requirement shall be submitted by the bidder on their Letter Head.

3. Financial Standing:

a) The average annual turnover of the bidder during the last three years, ending on 31.03.2022 shou ld be at least 1,27,009/-as per the annual report (Audited Balance sheet and Profit & Loss Account s hall be submitted for evaluation) of Financial Year 2019-2020, 2020-2021 & 2021-2022, duly authen ticated by a chartered Accountant/Cost Accountant in India or equivalent in relevant countries

Note: The Average Annual Turnover criteria are exempted for Start-ups and Micro and Small Enterpri ses. In case any bidder is seeking exemption from Turnover criteria, the supporting documents to pr ove his eligibility for exemption must be submitted for evaluation.

b) The bidder should not have suffered any financial loss for more than one year during the last thre e years, ending on '31.03.2022'.

(i) The net worth of the Bidder should not be negative on '31.03.2022' and also

(ii) Should not have eroded by more than 30% in the last three years, ending on '31.03.2022'.

4. Applicability in Special Cases

a) For Existing successful Past Suppliers: In case the bidder who is a successful past supplier of 'The Product' in at least one of the recent past three procurements, who do not meet any or more of requirements above, would also be considered to be qualified in view of their proven credentials, for the maximum quantity supplied by him in such recent past. (This clause is not applicable for Securit y Items as notified by Government of India from time to time.)

b) Joint Ventures and Holding Companies: Credentials of the partners of Joint ventures cannot (r epeat cannot) be clubbed for the purpose of compliance of PQC in supply of Goods/Equipment, and e ach partner must comply with all the PQC criteria independently However, for the purpose of qualifyi ng the Financial Standing Criteria, the Financial Standing credentials of a Holding Company can be clubbed with only one of the fully owned subsidiary bidding company, with appropriate legal documen

ts proving such ownership.

c) Start-up Enterprises: Requirements of prior experience and turnover would be relaxed for Start -up enterprises as recognized by Department for Promotion of Industry and Internal Trade (DPIIT), su bject to their meeting the quality and technical specifications. Such Start-ups maybe either MSE or ot herwise.

5. Certificate of MSE: The firm must have a valid registration certificate as MSE issued by NSIC, DGS &D or any authorized body by Ministry of MSME for Manufacturing of the tendered item and the same s hall be submitted by the firm along with tender/bid.

6. The Bidder shall give following undertakings/Declaration on their Letter Head regarding t his requirement.

i) Non Blacklisting: The firm should give a declaration that, We, M/s. <Name of the bidder firm> have not been black-listed/debarred for dealing by Government of India/PSU/Reputed Organisation in the Past.

ii) Agree to withdraw all deviations: The declaration that "We, M/s. <Name of the bidder firm> agree to withdraw all the deviations, if any, unconditionally and accept all the terms and condition s of the tender document including the technical specifications".

- 1) Pre-Dispatch Sample:- A sample of 10 Polythene Bags free of cost are to be submitted for approv
- al, before bulk supply. Sample must be submitted within 15 days from the date of issue of GeM Contra
- ct. Sample suitability will be conveyed within 15 days from the date of receipt of sample.
- 2) Delivery Schedule:-The total quantity is to be supplied in 04 equal installments.
 - a. First lot of 6000 Polythene Bags within 60 days from the date of issue of GeM Contract.
 - b. Second lot of 6000 Polythene Bags within 90 days from the date of issue of GeM Contract.
 - c. Third lot of 6000 Polythene Bags within 120 days from the date of issue of GeM Contract.
 - d. Fourth lot of 6000 Polythene Bags within 150 days from the date of issue of GeM Contract.

3) Quality Control Requirement:-

(i) The material supplied by the successful bidder will be accepted on all parameters as per specifi cation provided in the Bid Document. The purchaser reserves the right to get the material supplied tested from in-house laboratory or any other laboratory of repute and in case the material is found not meeting the specification, the purchaser shall be entitled to cancel the contract, and if so desir ed, purchase or otherwise the purchase of the stores at the risk and cost of the contractor.

(ii) After receipt of goods, the goods will be inspected/tested at ISP. If any defect/variation is notice d then the same will be replaced free of cost by the supplier/seller up to India Security Press, Nashi k Road, failing which equivalent amount of defective material will be deducted in the subsequent b ills or from any amount due to them.

D. Special Conditions of Contract (SCC) (To be submitted on firm's Letter Head as a token of ac ceptance):-

1) Transportation of Goods: The transportation of goods to be procured will be done by the supplie r on FOR ISP Basis. The total cost of the transportation should be indicated in the price bid of the item t o be procured.

2) Insurance: Since Indigenous bidder has to deliver the material on FOR ISP Nashik basis therefore t he cost of the insurance will also the part of the cost of the material borne by the supplier. A specific in surance cover for each consignment/supply is to be given by firm, as applicable.

3) Distribution of Dispatch Documents for Clearance/Receipt of Goods: The supplier shall sen d all the relevant dispatch documents well in time to ISP Nashik to enable ISP Nashik to clear or receiv e (as the case may be) the goods in terms of the contract.

4) Taxes and Duties: Supplier shall be entirely responsible for all taxes, duties, fees, levies etc. incur red until delivery of the contracted goods to SPMCIL. If the tenderer fails to include taxes and duties as per law of the land in the tender, no claim thereof will be considered by purchaser at a later stage.

5) Terms and Mode of Payment: 100% payment will be released within ten (10) days of issue of co nsignee receipt-cum-acceptance certificate (CRAC) and on-line submission of bills. The payment will be done through online mode only. Therefore, the suppliers have to produce all the Bank details such as

Name of Bank, Account No., IFSC Code No., MICR No. along with the Tender document. TDS, if any, will be deducted as applicable.

6) NOTE:

i. The terms and conditions, guidelines of SPMCIL Procurement Manual Version 2.0 will be applicable to this bid at any stage to avoid any conflict at later stage. iv. All the pages submitted are to be sealed & signed by Authorized Signatory failing which t ender shall be treated as unresponsive.

The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. Any clause(s) incorporated by the Buyer regarding following shall be treated as null and void and would not be considered as part of bid:-
