The purchaser reserves the right to get the material su pplied tested from in-house laboratory or any other laboratory of repute and in case the m aterial is found not meeting the specification, the purchaser shall be entitled to cancel the c ontract, and if so desired, purchase or otherwise the purchase of the stores at the risk and cost of the contractor.
- ii. After receipt of goods, the goods will be inspected/tested at ISP. If any defect/variatio n is noticed then the same will be replaced free of cost by the supplier/seller up to India Se curity Press, Nashik Road, failing which equivalent amount of defective material will be ded ucted in the subsequent bills or from any amount due to them.
