SCC 1: Performance Bond/ Security: The successful bidder has to submit Performance Bond/ Security equivalent to 3% of the order(s) value, valid for a period of 60 days beyond the completion of all contractual obligations, within 21 days from the date of issue of Letter of Intent.

The Performance security shall be denominated in Indian Rupees in one of the following forms:

- a) Account Payee Demand Draft or Fixed Deposit Receipt drawn on any commercial bank in India, in favour of India Security Press, Unit SPMCIL.
- b) Bank Guarantee issued by a commercial bank in India, in the prescribed form as provided in section XV of this document.



- **SCC 2: Transportation of Domestic Goods**: The transportation of goods to be procured will be done by the supplier on FOR ISP Basis. The total cost of the transportation should be indicated in the price bid of the item to be procured.

SECTION VII: TECHNICAL SPECIFICATIONS

Scope of work for SITCS(Supply, Installation, Testing, Commissioning & Support) of LAN (Local Area Network) for Internet in India Security Press, Nashik

India Security Press, Nashik has specific technical requirements to build dedicate separate LAN for Internet Distribution. The bidder should SITCS (Supply, Install, Test, Commission & Support) Local Area Network (LAN) at India Security Press, Nashik on turnkey basis.. In detail, the bidder has to comply with the following scope:

- 1. The bidder shall provide all required equipment on turnkey basis which may not be specifically stated herein but are required to meet the intent of ensuring operational, completeness, robustness, maintainability and reliability of the total system covered under this specification.
- 2. All safety and security norms to be followed during the execution of work.
- 3. Scope of work includes supply of material, installation, commissioning, Trial, Testing, engaging of labours, support, comprehensive warrantyand any other material and civil work required to complete the work in all respect on turnkey basis.
- 4. Vendor has to configure all active network components as per direction of ISP representative. Training regarding configuration of switch configuration to be provided to ISP personnels.
- 5. The Internet LAN is to be installed among different section/building which is apart from each other. Hence to understand the complete scope of work, bidders are strongly advised to visit the site before quoting.
- 6. All UTP&power cable should be laid through **CasingCapping /PVC pipe**. All cabling must be in structured manner. Labelling of cables, I/O, Jack panel, switches.



PROPOSED RING 1





Red Connecting Line – Fiber Connectivity (6 Core SM)
