#### 1. Introduction:

Security Printing and Minting Corporation of India Ltd. (SPMCIL) is a Miniratna Category-I Central Public Sector Enterprise (CPSE), and wholly owned Schedule 'A' company under Department of Economic Affairs, Ministry of Finance, Government of India.

SPMCIL is engaged in the manufacturing/ production of Bank Notes, Circulation & Commemorative Coins, Security Paper, Non-Judicial Stamp Papers, Postal Stamps & Stationary, Travel Documents viz. Passport and Visa, Security certificates, Cheques, Bonds, Warrant, Special Certificates with security features, Security Inks, Medallions, Refining of Gold & Silver and Assay of Precious Metals.

#### 2. Objective and Scope of the Expression of Interest:

- i. Expression of Interest (EOI) is for empanelment of potential technology partner/professional technology solution provider for consortium for an automated track and trace mechanism for manufacturing, transport, distribution & consumption of various products including liquor.
- ii. After evaluation of EoI, empanelment will be done with the eligible firms. SPMCIL will ask the price quotation from the eligible bidders as per the requirement of the particular state. SPMCIL will form the consortium with the L1 empanelled firm for participation in the state tender. SPMCIL will be the prime bidder in this consortium.
- iii. The objective of forming a consortium is to integrate applicant's material and digital technology for an end to end Track and Trace mechanism to facilitate the manufacturing, transport, distribution, and consumption of Spirits, Wine, Liquors, Beer or any domestic or imported products such as tobacco.

#### 3. Requirements from the bidders:

- i. The EOI is for empanelment of potential technology partner/professional technology solution provider for consortium for an automated track and trace mechanism for manufacturing, transport, distribution & consumption of various products including liquor.
- ii. Please submit duly filled and signed Annexure-I (STATEMENT OF CREDENTIAL OF INTERESTED FIRM) along with all relevant supporting documents attested by the authorized signatory.

#### 4. Role and Scope of Work of the bidder in proposed consortium:

During the participation in the State Government tender for supply of Excise Adhesive Labels with an automated Track and Trace mechanism, SPMCIL intends to engage with an organisation / agency to form a consortium for the scope of work state below:

The main objective of the project is to track and trace & to monitor liquor at each production and transaction stage of Indian Made Foreign Liquor, Country Liquor, Bulk Spirit etc. which in turn helps the Excise department and their stakeholders in monitoring the entire supply chain. Key focus areas are as follows:

#### i. Supply Chain Management:

- To regulate the revenue generation for the State Governments.
- To monitor movement of spirits, beer and Liquor (Indian Made Foreign liquor or Country Spirit, Foreign Liquor, Bulk spirit etc.)

- To capture production data of both Foreign and Country Liquor in the state by real time verification.
- To maintain and access key information from a centralised system & to facilitate data driven decision making.
- Act as deterrence to non-compliances during the entire manufacturing as well as dispatching process.
- To record and regulate the dispatch of Country Spirit and Foreign Liquor and prevent illegal dispatch of liquors.
- Real Time status of all the Licensee activities with respect to manufacturing and supply chain.

### **Integration with other Government Systems:**

 Integration of GRIPS/IFMS, legacy NIC application and Excise Directorate applications. (if any)

#### ii. SPMCIL's Excise Adhesive Labels

At present SPMCIL with its units at India Security Press, Nasik & Security Printing Press, Hyderabad produces EALs for few states. There is huge potential for the production of Excise Adhesive Labels (EALs) in India. SPMCIL produces paper based EALs which are highly secure and environment friendly with various security features. The labels are specific to different types of liquor and distilleries.

SPMCIL invites the technology providers to offer the following technologies to produce and offer most secured Excise Adhesive Labels to various State Excise departments which are easy to authenticate but at the same time difficult to clone, and allowing end to end traceability.

a. Technology for EAL Marking: Material based security is first and out most important building block in securing the tax stamp. It cannot be reproduced with digital printing equipment available in the market. Moreover, T&T provide multiple features to meet the demand of various stakeholders in the entire ecosystem i.e. consumer, inspector, tax authorities, enabling the generation of court admissible evidence.

#### b. Technology for secure Coding (Data matrix)

Digital security is another building block which gives each EAL a unique identity. On top of that, digital security technology shall protect from cloning of identity of EAL.

## c. Detectors and equipments to authenticate and track & trace the supply chain

Portable devices are used to detect and authenticate material and digital signature without any ambiguity and within seconds, in addition to track and trace of the supply chain.

#### d. Software and Mobile App/Web portal for Track and Trace

Real-time data collection and reporting to central database of SKU, date, time, manufacturing line & site. Full visibility of product during the entire supply chain on real time basis. Conduct simple, fast and reliable field inspections via dedicated connected portable devices. Reporting module enabling data driven decision making.

The main objective of Track & Trace System is to utilize Information Technology as means to get in touch with the general public and enable stakeholders (internal & external);

to develop a user friendly & interactive web portal. Along with the Web portal development, the technology should allow State Excise departments to develop a mobile app for internal & external stakeholders to facilitate business processes and track & trace end user.

#### iii. Necessity of Track & Trace System:

The Track & Trace System is needed to be in synchronisation of the EALs printed and affixed on liquor bottles. The system is required to monitor the movement of liquor & spirits at various stages.

The system is required to eliminate the counterfeits and protect the consumer from the ill-effects of illicit & spurious liquor. This will also help in keeping check on the tax evasion. Based on the sales analysis, the strong business model can be made and offered to manufacturers for their business enhancement.

#### iv. The stages of Track & Trace are as follows:

#### **Stage 1: Printing of EALs:**

The EALs are printed with alpha numeric numbering & 2D barcode, state wise, variety of liquor and distillery wise. The data of the EALs printed should be captured and digitally stored.

### Stage 2: Supply of EALs to State governments Excise department:

Once the EALs are printed and despatched to the Excise department, the data of the EALs should be transmitted to the Excise Department. The data should be compatible for uploading on to the Excise Department Server.

# Stage 3: Distribution of EALs to Distilleries:

Once the EALs reach the Excise Department Warehouse, the EALs are distributed to the various parts of the state based on the variety of liquor, distillery, and the type of packing etc., as per the requirement of Excise Department. The EALs distributed to each distillery should be recorded.

#### Stage 4: Manufacturing of Liquor bottles / Bottling:

At the production line, the application of the EALs on the liquor bottles needs to be tracked. The number of bottles produced and the EALs used should be monitored.

#### Stage 5: Transfer of labelled bottles to warehouse:

After the labelling, the bottles are packed into cases and the parent-child relationship between cases and bottles is recorded. Boxes are then moved to the manufacturer warehouse.

#### Stage 6: Distribution to Retail warehouses:

As per the indent received from retailers through Excise Department, the liquor consignment is moved to the Retailers warehouse. This movement needs to be traced and monitored.

#### **Stage 7: Customer Authentication:**

The system should have a customer friendly interface / application through which the consumer can verify the authenticity / genuineness of the bottle purchased.

#### Stage 8: Inspection & verification:

Dedicated authentication devices will be provided to Excise department allowing verification and authentication by Excise department inspectors.

The system should also allow consumers to check the authenticity of EALs by naked eye and via a smartphone app.

#### Stage 9: Reporting

All data stored in the central database should be visible and accessible to the Excise department via data intelligence reports.

#### v. Other Essentialities:

- a. Track and Trace of the entire process from Printer to Consumer should be included in the dashboard.
- b. The system should be able to integrate the requirements of various stake holders like Printer, Excise Department, Distillery, Wholesale dealer, Retailer and consumers.
- c. The system should be robust and user friendly & should be able to sustain huge data storage.
- d. The retention of the data will be for 3 years and further if required data shall be transferred to SPMCIL/State Authority.
- e. The system should be able to handle seasonal sales surge without any glitches.
- f. The system should have proper data security with backup server at SPMCIL premises & Excise department premises.
- g. Bidder shall provide the consent for providing STQC audit after award of contract.
- h. Bidder shall submit the Non-Disclosure Agreement (NDA) after the empanelment.

#### vi. Hardware Requirements & Technical specifications

- a. The bidder shall provide the hardware components as per the requirements of the state excise department.
- b. The Hardware includes central data server and storage, desktop computer, LAN Server & smart phones as scanners and networking system required by all the stakeholders of the project (Distillers/Bottlers/Importers of Liquor/BWHs/Wholesalers).
- c. It will be the entire responsibility of the Bidder to provide the Hardware and other equipment's required to run the Track &Trace system of the state.
- d. The bidders are expected to come up with the best possible cost effective solution that demonstrates the optimal usage. Bidders have to suggest the technology architecture & solution design.

# vii. Integration of Track and Trace System with all Other IT/ITES Projects of Excise department:

The Track & Trace system should be flexible enough and compatible to integrate with other IT/ITES projects of SPMCIL. It should be compatible for customization as per the requirement of SPMCIL / State Excise Department.

### viii. Approvals and Support of the department:

The successful bidder should at his own cost arrange to get the necessary approvals and support from various departments for the smooth implementation of the Project.

#### ix. Hardware Installation:

The successful bidder will make all necessary arrangements for the installation of all hardware and connect them to the server wherever required.

# x. Training & Capacity Building:

The successful bidder will arrange for complete training and capacity building for all the staff concerned with the utilization of Track and Trace system.

#### 5. DESIGN PRINCIPLES OF APPLICATION SOFTWARE:

#### 6. Short Listing of the Bidders:

- 1) Manufacturer or principal of Subsidiary hereinafter referred simply as 'Bidder'.
- 2) **Applicability to 'Make in India'**: Bidders (manufacturer or principal of Subsidiary) If the product is being manufactured in India under a license from a foreign manufacturer who holds intellectual property rights and where there is a technology collaboration agreement/ transfer of technology agreement for indigenous manufacture of a product developed abroad with clear phased increase in local content, would also be considered, provided:
- i) their foreign manufacturer who holds intellectual property rights, meets all the criteria above, and ii) the Bidder submits appropriate documentary proof for technology collaboration agreement/ transfer of technology agreement for indigenous manufacture of a product developed abroad with clear phased increase in local content. iii) the bidder furnishes along with the bid a legally enforceable undertaking jointly executed by himself and such foreign Manufacturer for satisfactory manufacture, Supply (and erection, commissioning if applicable) and performance of 'The Product' offered including all warranty obligations as per the general and special conditions of contract.
- 3) **Holding Companies:** For the purpose of qualifying the Financial Standing Criteria, the Financial Standing credentials of a Holding Company can be clubbed with only one of the fully owned subsidiary bidding company, with appropriate legal documents proving such ownership.

# 7. Tenure of empanelment for the firm(s):

The empanelment for the firm(s) shall be binding initially for a period of 3 years which can be extended for further period of two years with mutual agreed terms & conditions subject to discretion of SPMCIL.

# 8. <u>Consortium formation & tentative timelines for the bidder firm(s) to respond to SPMCIL query against any State Government opportunity:</u>

After the empanelment of firms as a result of this Expression of Interest, the empanelled firms will be asked to quote their prices (for above mentioned scope of work) for State Government tenders (as and when such tenders are floated by various State Governments for their EALs, Tax Stamps & other similar products) within 05 working days of (Two bid) limited express tender enquiry sent by SPMCIL (with reference to the cited

State Governments tender). The consortium for the cited State Government tender will be formed with L1 bidder (i.e. the firm quoting lowest prices for the referred scope of work).

<u>Note:</u> Irrespective of which empanelled firm brings the information pertaining to State Government tender for supply of EALs, Tax Stamps & other similar products along with Track & Trace technology, the lowest bidder as detailed above shall be eligible to form consortiumforthecitedtenderenquiry.

#### 9. Condition(s) of termination of the empanelment:

Any empaneled firm can be blacklisted if it is found violating /deviating from the cited scope of work and/or trying to manipulate the execution of contract in its own favour.

As regards to any dispute arising with the firm with which consortium has been formed (i.e. after selection as a L1 bidder as explained in point no. 8 above, SPMCIL reserves the right to terminate such consortium and form a new consortium (if needed) by again calling tenders from rest of the empanelled firms.

Such termination of consortium would negatively impact the performance rating of the cited firm and can also lead to Holiday listing (Deemed non-eligible from participation infuture tenders called by SPMCIL for 1 opportunity for a specific period as decided by competent authority of SPMCIL) or even lead to termination of empanelment resulting out of this EOI.
