2. 4. In case of bunch bids, the category of primary product having highest value should meet this criterion.
5. Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

I. Special conditions of Contract (SCC):

1) Transportation of Domestic Goods: The transportation of goods to be procured will be done by the supplier on FOR ISP Basis. The total cost of the transportation should also be indicated in the price bid of the item to be procured.

2) Taxes and Duties: If the tenderer fails to include taxes and duties as per law of the land in the tender, no claim thereof will be considered by purchaser at a later stage.

II. Delivery Schedule :

Within 120 days from the date of placement of Contract/order.

III. Quality Control Requirements :

The vehicles to be supplied by the successful bidder will be accepted on conforming to all parameters as per technical specification given in the bid document. The purchaser shall be entitled to cancel the contract, and if so desired, purchase or otherwise the purchase of the stores at the risk and cost of the contractor.

IV. Qualification/ Eligibility Criteria:

- (1) **Experience & Past Performance:** The bidder (manufacturer or principal of authorised representative) shall be a manufacturer that has regularly for at least the last three years manufactured, supplied, erected, commissioned "Garbage Collection Vehicle (Hopper Tipper Dumper)" with the same or higher specifications (Tipper Container capacity) of at least one number in last five years ending on "31st March 2023". At least one number of the product offered for supply should be in successful operation for at least one year on the date of bid opening.
- (2) **Capability-Equipment & manufacturing Facilities:** The bidder must have an annual capacity to manufacture and supply at least 50 per cent of the requirement (i.e. at least 6 number of Garbage Collection Vehicles).

Note:- At the discretion of the purchaser, the Capacity/Capability Assessment/Verification of bidder/manufacturer firm (s) might be undertaken by Committee or through a third party Technical Consultancy/Inspection agencies to ensure that the firm is/are identified and capable to supply the item/material/ product as required.

(3) Financial Standing:

- a) The average annual financial turnover of the bidder firm (manufacturer or principal of authorized dealer) during the last three years, ending on '31st March 2023', should be at least Rs .43,20,000/- as per the annual report (audited balance sheet and profit & loss account) of the relevant period duly authenticated by a Chartered Accountant/ Cost Accountant in India or equivalent in relevant countries.
- b) Bidder Firm should not have suffered any financial loss for more than one year during the last three years, ending on the '31st March 2023'.
- c) The net worth of the firm should not be negative on '31st March 2023' and not have eroded by more than 30% in the last three years, ending on '31st March 2023'

Note 1-The criteria for Capability, Equipment and Manufacturing facilities as well as financial loss and net worth under the financial standing eligibility criteria (above) shall be applicable to all the bidder firms including MSEs & Startups Firms. Bidder to furnish stipulated documents in support of fulfillment of qualifying criteria. Nonsubmission or incomplete submission of documents may lead to rejection of offer.

V. Important Instructions to bidders before participation: Bidder should quote prices of Vehicles inclusive of RTO registration charges, Insurance of Vehicle for period of one year, Logo charges, GST and all other cost components such as Other

Taxes, Packing & Forwarding details, Freight & transportation Insurance charges upto destination etc. on FOR India Security Press, Nashik Road (Maharashtra), basis only. After award of contract, the contract price will be final and no additional charges will be considered by ISP-Nashik at later stage.

Further, at the time of delivery, firm should ensure to submit all documents like Invoices, Warranty Certificates, RTO Registration documents, RC books, Insurance of vehicles, Technical Literature/Brochure of Vehicles without fail. Otherwise, payment will not be made till the completion of delivery in all respects.

VI. Bidder must submit its offered specifications along with the bid for Garbage collection on vehicle without which offer of the firm will be rejected. Further, firm should submit the acceptance of the detailed specifications as per Buyer uploaded ATC document along with the sealed & signed copy of same along with bid document. Before submitting the bid, bidder should ensure that offered specifications should be as per the Buyer uploaded ATC document (within the range specified).

VIII. Ministry of Finance, Department of Expenditure, Public Procurement Division, Orders (Public Procurement 1,2,3 and 4) F. No. 7/10/2021-PPD(1) dated 23.02.2023 (or any further amendments thereof) regarding eligibility of bidders from specified countries shall be applicable to this tender. Bidders are required submit the appropriate undertaking in this regard. Salient features of this are:

I. Any bidder from a country which shares a land border with India will be eligible to bid in any procurement whether of goods, services (including consultancy services and non-consultancy services) or work (including turnkey projects) only if the bidder is registered with the Competent Authority. *Further, any bidder (including bidder from India) having specified Transfer of Technology (ToT) arrangement with an entity from a country which shares a land border with India, shall also require to be registered with the same competent authority.*

II. "Bidders" (including the term 'tenderer', 'consultant' or 'service provider' in certain contexts) means any person or firm or company, including any member of a consortium or joint venture (that is an association of several persons, or firms or companies), every artificial juridical person not falling in any of the descriptions of bidders stated hereinbefore, including any agency branch or office controlled by such person, participating in a procurement process.

III. "Bidder (or entity) from a country which shares a land border with India" for the purpose of this Order means:-

- (a) An entity incorporated, established or registered in such a country ; or
- (b) A subsidiary of an entity incorporated, established or registered in such country ; or
- (c) An entity substantially controlled through entities incorporated, established or registered in such a country; or
- (d) An entity whose beneficial owner is situated in such a country ; or
- (e) An Indian (or other) agent or such an entity; or
- (f) A natural person who is citizen of such a country; or
- (g) A consortium or joint venture where any member of the consortium or joint venture fall under any of the above.

IV. The beneficial owner for the purpose of (iii) above will be as under:

1. In case of a company or Limited Liability Partnership, the beneficial owner is the natural person(s), who, whether action alone or together, or through one or more juridical person, has a controlling ownership interest or who exercises control through means.

Explanation-

a. "Controlling ownership interest" means ownership of or entitlement to more than twenty-five per cent. Of shares or capital or profits of the company;

b. "Control" shall include the right to appoint majority of the directors or to control the management or policy decisions including by virtue of their shareholding or management rights or shareholders agreements or voting agreements;

2. In case of a partnership firm, the beneficial owner is the natural person(s) who, whether acting alone or together, or through one or more juridical person, has ownership of entitlement to more than fifteen percent of capital or profits of the partnership;

3. In case of an unincorporated association or body of individuals, the beneficial owner is the natural person(s), who, whether acting alone or together, or through one or more juridical person, has ownership of or entitlement to more than fifteen percent of the property or capital or profits of such association or body of individuals;

4. Where no natural person is identified under (1) or (2) or (3) above, the beneficial owner is the relevant natural person who holds the position of senior managing official;

5. In case of a trust, the identification of beneficial owner(s) shall include identification of the author of the trust, the trustee, the beneficiaries with fifteen percent or more interest in the trust and any other natural person exercising ultimate effective control over the trust through chain of control or ownership.

V. An agent is a person employed to do any act for another, or to represent another in dealings with third person.

VI. [To be inserted in tenders for Work contracts, including Turnkey contracts] The successful bidder shall not be allowed to sub-contract works to any contractor from a country which shares a land border with India unless such contractor is registered with the Competent Au

thority.

VII. The registration shall be valid at the time of submission of bid and at the time of acceptance of bid.

VIII. If the bidder was validly registered at the time of acceptance/placement of order, registration shall be a relevant consideration during contract execution.

Model Certificate for Tenderers:

“I have read the clause regarding restrictions on procurement from a bidder of a country which share a land border with India; I certify that this bidder is not from such a country or, if from such a country, has been registered with the Competent Authority. I hereby certify that the bidder fulfills all requirements in this regard and is eligible to be considered. IX. Payment Terms: - Payment will be released within ten (10) days of issue of Consignee Receipt-cum Acceptance Certificate (CRAC) and submission of bills. **Further, at the time of delivery, firm should ensure to submit all documents like Invoices, Warranty Certificates, RTO Registration documents, RC books, Insurance of vehicles, Technical Literature/Brochure of Vehicles without fail. Otherwise, payment will not be made till the completion of delivery in all respects.**

X. Quantum of LD :- If the Seller/Service Provider fails to deliver any or all of the Goods/Services within the original/re-fixed delivery period(s) specified in the contract, the Buyer will be entitled to deduct/recover the Liquidated Damages for the delay, unless covered under Force Majeure conditions aforesaid, @ 0.5% of the contract value of delayed quantity per week or part of the week of delayed period as pre-estimated damages not exceeding 10% of the contract value of delayed quantity without any controversy/dispute of any sort whatsoever.

XI. OEM Authorization Certificate :- Only OEMs and Authorized dealers should participate in the said-GeM bid.

XIII. Applicability in Special Cases:

A) Authorized Representatives: Bids of bidders quoting as authorised representative of a principal manufacturer would also be considered to be qualified, provided: i) their principal manufacturer meets all the criteria above without exemption, and ii) the principal manufacturer furnishes a legally enforceable tender-specific authorisation in the prescribed form assuring full guarantee and warranty obligations as per the general and special conditions of contract; and iii) the bidder himself should have been associated, as authorised representative of the same or other Principal Manufacturer for same set of services as in present bid (supply, installation, satisfactorily commissioning, after sales service as the case may be) for same or similar 'Product' for past three years ending on '31.03.2023'.

B) For Existing successful Past Suppliers: In case the bidder (manufacturer or principal of authorised representative) who is a successful past supplier of 'The Product' in at least one of the recent past three procurements, who do not meet any or more of requirements above, would also be considered to be qualified in view of their proven credentials, for the maximum quantity supplied by him in such recent past. XIV. Pre-dispatch Inspection: Before dispatch, the goods will be inspected by CSR Project Committee of ISP at Seller premises (or at designated place for inspection as declared / communicated by the seller) for their compliance to the contract specifications. For in-house testing, the Sellers will provide necessary facilities free of cost. Seller shall notify the Buyer through e-mail about readiness of goods for pre-dispatch inspection and Buyer will notify the Seller about the details of CSR Project Committee and the date for testing/ Pre-dispatch inspection. The goods would be dispatched to consignee only after clearance in pre-dispatch inspection by CSR Project Committee of ISP. Consignee's right of rejection as per GTC in respect of the goods finally received at his location shall in no way be limited or waived by reason of the goods having previously been inspected, tested and

passed by CSR Project Committee prior to the goods' shipment. While bidding, the sellers should take into account at least 7 days for inspection from the date of email offering the goods for inspection. Any delay in inspection beyond 7 days shall be on the part of the buyer and shall be regularised without Liquidated Damages.

Seller shall notify the Buyer through e-mail about readiness of goods for pre-dispatch inspection and Buyer will notify the Seller about the Authorized Representative/ Nominated External Inspection Agency and the date for testing. The goods would be dispatched to consignee only after clearance in pre-dispatch inspection. Consignee's right of rejection as per GTC in respect of the goods finally received at his location shall in no way be limited or waived by reason of the goods having previously been inspected, tested and passed by Buyer/ Consignee or its Nominated External Inspection Agency prior to the goods' shipment.
