If the bidder wants to avail the Purchase preference for services, the bidder must be the Service

provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band defined in relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.

1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1. Qualification and eligibility criteria of Bid

i) Experience & Past performance:- The Bidder should have experience of having successfully completed similar kind of services i.e. Cutting of machine for the value at least Rs. 6.75 Lakhs in any one of the last fi ve years ending on 31st March 2023

Note: The 'Experience and Past experience criteria' is exempted for Startups and Micro and Small Enterpri ses.

ii) **Capability:-** The bidder must have capability to provide the relevant services.

iii) Financial standing:-

a) The average annual financial turnover of the bidder during the last three years, ending on 31 ^s ^t March 2023, should be at least Rs. 6.75 Lakhs (or equivalent in foreign currency at exchange rate preval ent on 31st March 2023) as per the annual report (audited balance sheet and profit & loss account) of the r elevant period, duly authenticated by a Chartered Accountant/ Cost Accountant in India or equivalent in rel evant countries.

Note: The 'Average Annual Turnover criteria' is exempted for Startups and Micro and Small Enterprises.

b) The bidder should not have suffered any financial loss for more than one year during the last three years, ending on 31st March 2023.

c) (i) The net worth of the Bidder should not be negative on 31 st March 2023 and also should n ot have eroded by more than 30% in the last three years, ending on 31st March 2023..

Applicability in Special Cases

i) Authorized Representatives: Bids of bidders quoting as authorised representative of a principal man ufacturer would also be considered to be qualified, provided: i) their principal manufacturer meets all the c riteria above without exemption, and ii) the principal manufacturer furnishes a legally enforceable tender-s pecific authorisation in the prescribed form assuring full guarantee and warranty obligations as per the ge neral and special conditions of contract; and iii) the bidder himself should have been associated, as authori sed representative of the same or other Principal Manufacturer for same set of services as in present bid (s upply, installation, satisfactorily commissioning, after sales service as the case may be) for same or similar 'Product' for past three years ending on '31.03.2023'.

ii) For Existing successful Past Suppliers: In case the bidder (manufacturer or principal of authorised r epresentative) who is a successful past supplier of 'The Product' in at least one of the recent past three pr ocurements, who do not meet any or more of requirements above, would also be considered to be qualifie d in view of their proven credentials, for the maximum quantity supplied by him in such recent past. (This clause is not applicable for Security Items as notified by Government of India from time to time.)

iii) Joint Ventures and Holding Companies: Credentials of the partners of Joint ventures cannot (repeat cannot) be clubbed for the purpose of compliance of PQC in supply of Goods/Equipment, and each partner must comply with all the PQC criteria independently However, for the purpose of qualifying the Financial Standing Criteria, the Financial Standing credentials of a Holding Company can be clubbed with only one of the fully owned subsidiary bidding company, with appropriate legal documents proving such ownership.

3. **Quantum of LD**:- If the Seller/Service Provider fails to deliver any or all of the Goods/Services within th e original/re-fixed delivery period(s) specified in the contract, the Buyer will be entitled to deduct/recover t he Liquidated Damages for the delay, unless covered under Force Majeure conditions aforesaid, @ 0.5% of the contract value of delayed quantity per week or part of the week of delayed period as pre-estimated da mages not exceeding 10% of the contract value of delayed quantity without any controversy/dispute of an y sort whatsoever.

4. **Payment Terms**: - The payment will be released on running bill basis after completion of each 100MT o f work. The firm should submit bill after completing work as per Scope of work for each 100MT quantity wh ich shall be duly certified by ISPN official and 90% payment of the certified bill shall be made within 30 day s. The payment will be done through online only. Therefore, the supplier has to produce all the Bank detail s such as Name of Bank, Account No., IFSC Code No., MICR No. along with Bid Document. TDS will be dedu cted as per rules in force.

5. **Delivery Period**: - The firm should start work within one month from the date of issue of contract and s hould be completed within three months from the date of commencement of contract.

3. Generic

1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.

2. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.

3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

4. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
