Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum

local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. 7. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 40% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU / Public Listed Company. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Buyer Added Bid Specific ATC

Buyer Added Bid Specific ATC

The Bidder firm should meet following eligibility criteria to qualify in the Techno Commercial Bid:-

I) Experience and Past Performance:- The bidder should have manufactured / supplied Displacement Sensor of at least 1 nos in any one of the last five years ending on 31.03.2023.

Note: The Experience and Past Experience Criteria is exempted for startups and Micro and Sm all Enterprises.

II) Capability:- The bidder must have an annual capacity to manufacture / supply at least 1 nos of Displac ement Sensor.

III) For Existing successful Past Suppliers: In case the bidder who is a successful past supplier of 'Th e Product' in at least one of the recent past three procurements, who do not meet any or more of require ments above, would also be considered to be qualified in view of their proven credentials, for the maximu m quantity supplied by him in such recent past. (This clause is not applicable for Security Items as notified by Government of India from time to time.)

IV) Joint Ventures and Holding Companies: Credentials of the partners of Joint ventures cannot (repe at cannot) be clubbed for the purpose of compliance of PQC in supply of Goods/Equipment, and each partn er must comply with all the PQC criteria independently However, for the purpose of qualifying the Financial Standing Criteria, the Financial Standing credentials of a Holding Company can be clubbed with only one of the fully owned subsidiary bidding company, with appropriate legal documents proving such ownership.

V) PAN: The Bidder should be registered with the Income tax. Relevant proof in support shall be submitte d.

VI) Goods & Service Tax Registration (GST): The Bidder should be registered with Goods & Service Ta x (GST). Relevant proof of registration Certificate shall be submitted.

VII) Undertaking:-

a) "We M/s ______ have not been blacklisted by Government of India in the past."

b) "We M/s ______ agree to withdraw all the deviations, if any, unconditionally and accept all the Terms and conditions of the document including the technical specifications."

c) The bidder has to provide the undertaking that "We have read and accept all the terms & conditions of G IT & GCC of the Bid document".

VIII) Note:

a) Interested firms are requested to submit the above required documents sealed and signed on all pages along with Bid.

b) No further correspondence will be made with the bidders for shortfall of documents, if any; such offers with partial submission of documents will be summarily rejected.

c) The Bid should be completed in all the respect including submission of all the required documents so th at further clarification may not be called for.

IX) Delivery Schedule: - Within 150 days from the date of issue of Contract.

X) Warranty: - Firm should give 1 year warranty for the offered product.

XI) Quantum of LD:- If the Seller/Service Provider fails to deliver any or all of the Goods/Services within t he original/re-fixed delivery period(s) specified in the contract, the Buyer will be entitled to deduct/recover the Liquidated Damages for the delay, unless covered under Force Majeure conditions aforesaid, @ 0.5% o f the contract value of delayed quantity per week or part of the week of delayed period as pre-estimated d amages not exceeding 10% of the contract value of delayed quantity without any controversy/dispute of a ny sort whatsoever.

XII) Payment Terms: - Payment will be released within ten (10) days of issue of Consignee Receipt-cum Acceptance Certificate (CRAC) and submission of bills.

XIII) Ministry of Finance, Department of Expenditure, Public Procurement Division, Orders (Pu blic Procurement 1,2 and 3) F. No. 6/18/2019-PPD dated 23rd/ 24th July 2020 (or any further a mendments thereof) regarding eligibility of bidders from specified countries shall be applicabl e to this tender. Bidders are required submit the appropriate undertaking in this regard. Salie nt features of this are:

a) Any bidder from a country which shares a land border with India (excluding countries as listed in the we bsite of Ministry of External Affairs, to which the Government of India has extended lines of credit or in whi ch the Government of India is engaged in development projects) will be eligible to bid in this tender only if the bidder is registered with the Registration Committee constituted by the Department for promotion of In dustry and Internal Trade (DPIIT). The bidders shall enclose following certificate in this regard.

"We have read the clause regarding restrictions on procurement from a bidder of a country which shares a land border with India; and solemnly certify that we are not from such a country or, if from such a countr y, we are registered with the Competent Authority (copy enclosed). We hereby certify that we fulfill all req uirements in this regard and are eligible to be considered."

b) In tenders for Turnkey contracts including works contracts, the successful bidder shall not be allo wed t o sub-contract works to any contractor from a country which shares a land border with India unless such c ontractor is similarly registered with the Registration Committee constituted by the Department for Promot ion of Industry and Internal Trade (DPIIT). In such cases the bidders shall enclose following certificate:

"We have read the clause regarding restrictions on procurement from a bidder of a country which shares a land border with India and on sub-contracting to contractors from such countries,; and solemnly certify tha t we are not from such a country or, if from such a country, we are registered with Competent Authority (c opy enclosed) and we will not subcontract any work to a contractor from such countries unless such contra ctor is registered with the Competent Authority. We hereby certify that we fulfill all requirements in this re gards and are eligible to be considered."

c) "Bidder" including the terms 'tenderer', 'consultant' or 'service provider' in certain contexts) means any person or firm or company, including any member of a consortium or joint venture (that is an association o f several persons, or firms or companies), every artificial juridical person not falling in any of the descriptio ns of bidders stated here in before, including any agency branch or office controlled by such person, partic ipating in a procurement process.

d) "Bidder from a country which shares a land border with India" for the purpose of this Order means:- a) A n entity incorporated, established or registered in such a country; or

i) A subsidiary of an entity incorporated, established or registered in such a country; or

ii) An entity substantially controlled through entities incorporated, established or registered in such a coun try; or

iii) An entity whose beneficial owner is situated in such a country; or

iv) An Indian (or other) agent of such an entity; or

v) A natural person who is a citizen of such a country; or

vi) A consortium or joint venture where any member of the consortium or joint venture falls under any of th e above.

e) The beneficial owner for the purpose of (III) above will be as under:

i) In case of a company or Limited Liability Partnership, the beneficial owner is the natural person(s), who, whether acting alone or together, or through one or more judicial person, has a controlling ownership inter est or who exercise control through other means.

ii) Explanation:

(1) "Controlling ownership interest" means ownership of or entitlement to more than twenty-five per cent of shares or capital or profits of the company.

(2) In case of a partnership firm, the beneficial owner is the natural person(s) who, whether acting alone or together, or through one or more juridical person, has ownership of entitlement to more than fifteen perce nt of Capital or profits of the partnership.

(3) In case of an unincorporated association or body of individuals, the beneficial owner is the natural pers on(s), who, whether acting alone or together, or through one or more juridical person, has ownership of or entitlement to more than fifteen percent of the property or capital or profits of such association or body of i ndividuals;

(4) Where no natural person is identified under (1) or (2) or (3) above, the beneficial owner is the relevant natural person who holds the position of senior managing official.

(5) In case of a trust, the identification of beneficial owner(s) shall include identification of the author of the trust, the trustee, the beneficiaries with fifteen percent or more interest in the trust and any other natural person exercising ultimate effective control over the trust through a chain of control or ownership

(vi)An Agent is a person employed to do any act for another, or to represent another in dealings with third person.

- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process.
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
