1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Buyer Added Bid Specific ATC

- 1. Firm must submit ESIC, EPF Certificate in the name of the firm.
- 2. Firm must submit documentary evidence of having registered office in the state of Maha rashtra and should have experience of providing similar services in any one year during last five y

ears from the said office in state of Maharashtra.

- 3. Qualification and eligibility criteria of Bid
- i) Experience & Past performance:- The Bidder should have experience of having successfully sup plied the manpower services of 125 man-days in any one of the last five years ending on 31st Mar ch 2023

Note: The 'Experience and Past experience criteria' is exempted for Startups and Micro and Small Enterprises.

- ii) **Capability:-** The bidder must have capability to provide the relevant services.
- iii) Financial standing:-
- a) The average annual financial turnover of the bidder during the last three years, endin g on 31st March 2023, should be at least Rs. 1,02,400 (or equivalent in foreign currency at exchan ge rate prevalent on 31st March 2023) as per the annual report (audited balance sheet and profit & loss account) of the relevant period, duly authenticated by a Chartered Accountant/ Cost Accountant in India or equivalent in relevant countries.

Note: The 'Average Annual Turnover criteria' is exempted for Startups and Micro and Small Enter prises.

- b) The bidder should not have suffered any financial loss for more than one year during the last three years, ending on 31st March 2023.
- c) (i) The net worth of the Bidder should not be negative on 31st March 2023 and also s hould not have eroded by more than 30% in the last three years, ending on 31st March 2023..

Applicability in Special Cases

- i) Authorized Representatives: Bids of bidders quoting as authorised representative of a principal manufacturer would also be considered to be qualified, provided: i) their principal manufacture r meets all the criteria above without exemption, and ii) the principal manufacturer furnishes a legally enforceable tender-specific authorisation in the prescribed form assuring full guarantee and warranty obligations as per the general and special conditions of contract; and iii) the bidder himsel f should have been associated, as authorised representative of the same or other Principal Manufacturer for same set of services as in present bid (supply, installation, satisfactorily commissioning, after sales service as the case may be) for same or similar 'Product' for past three years ending on '31.03.2023'.
- **ii)** For Existing successful Past Suppliers: In case the bidder (manufacturer or principal of aut horised representative) who is a successful past supplier of 'The Product' in at least one of the rec ent past three procurements, who do not meet any or more of requirements above, would also be considered to be qualified in view of their proven credentials, for the maximum quantity supplied by him in such recent past. (This clause is not applicable for Security Items as notified by Govern ment of India from time to time.)
- **iii) Joint Ventures and Holding Companies:** Credentials of the partners of Joint ventures cannot (repeat cannot) be clubbed for the purpose of compliance of PQC in supply of Goods/Equip ment, and each partner must comply with all the PQC criteria independently However, for the purp ose of qualifying the Financial Standing Criteria, the Financial Standing credentials of a Holding Co

mpany can be clubbed with only one of the fully owned subsidiary bidding company, with appropri ate legal documents proving such ownership.

- 4. **Quantum of LD**:- If the Seller/Service Provider fails to deliver any or all of the Goods/Services within the original/re-fixed delivery period(s) specified in the contract, the Buyer will be entitled to deduct/recover the Liquidated Damages for the delay, unless covered under Force Majeure conditi ons aforesaid, @ 0.5% of the contract value of delayed quantity per week or part of the week of d elayed period as pre-estimated damages not exceeding 10% of the contract value of delayed quantity without any controversy/dispute of any sort whatsoever.
- 6. **Payment Terms**: Payment will be released on monthly basis after issue of Consignee Receipt -cum Acceptance Certificate (CRAC) and submission of bills.

- (3) In case of an unincorporated association or body of individuals, the beneficial owner is the natural person(s), who, whether acting alone or together, or through one or more juridical person, has ownership of or entitlement to more than fifteen percent of the property or capital or profits of such association or body of individuals;
- (4) Where no natural person is identified under (1) or (2) or (3) above, the beneficial owner is the r elevant natural person who holds the position of senior managing official.

- (5) In case of a trust, the identification of beneficial owner(s) shall include identification of the auth or of the trust, the trustee, the beneficiaries with fifteen percent or more interest in the trust and any other natural person exercising ultimate effective control over the trust through a chain of control or ownership.
- (vi) An Agent is a person employed to do any act for another, or to represent another in dealings with third person.
