- 1. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

(3) Financial Standing:

- a) The average annual financial turnover of the bidder firm during the last three years, ending on '31st Mar ch 2023', should be at least Rs.4.48 Lakh as per the annual report (audited balance sheet and profit & loss account) of the relevant period duly authenticated by a Chartered Accountant/ Cost Accountant in India or equivalent in relevant countries.
- b) Bidder Firm should not have suffered any financial loss for more than one year during the last three years, ending on the '31st March 2023'.
- c) The net worth of the firm should not be negative on '31st March 2023' and not have eroded by more th an 30% in the last three years, ending on '31st March 2023'.

- 11. Creating bid for items from irrelevant categories.
