The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. **Required Delivery Schedule for all Schedules:** The successful bidder shall suppl y 01 No. Stitching Machine Head within 60 days from the date of issue of GeM Contra ct and remaining 01 No. within 120 days from the date of issue of GeM Contract.

## **III. Quality Control Requirements:**

The material supplied by the successful bidder will be accepted on the basis of trial carried out on the machine and other technical requirement mentioned in Technical Specification and conforming to all p arameters as per technical specifications. If any defects observed or the material found unsuitable, then t he same will be returned to the supplier for free replacement upto India Security press.
