If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. 2. 4. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU / Public Listed Company for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.

5. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

6. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. 7. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer)of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25%(selected by Buyer) percentage of total QUANTITY. The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017.

Part Quantity Bidding

Buyer has allowed part quantity bidding, bidders can offer maximum quantity that they can deliver keeping in mind their capacity and delivery period requirements. The offer quantity has to be more than minimum bid quantity as specified by the Buyer in the bid. Offers with quantity less than Minimum are liable to be rejected. It may however be noted that there is no guarantee that full offer quantity will be ordered by the buyer. Quantity to be ordered by the buyer will depend on various factors including the Ranking of the bidder, Offered quantity, Splitting criteria indicated by the buyer in the bid and the requirement of the buyer to have multiple sources of supply for ensuring supply chain etc. Sellers would be notified about likely order quantity or range of possible order quantity at the time of price match request made by the buyer. ward of contract will be subject to acceptance of price match request along with min / max offer quantity as decided by the Buyer.

8. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. 9. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Forms of EMD and PBG

Bidders can also submit the EMD with Account Payee Demand Draft in favour of

Bidder has to upload scanned copy / proof of the DD along with bid and has to ensure delivery of hardcopy to the Buyer within 5 days of Bid End date / Bid Opening date.

(a) **Experience and past performance:**

The bidder (manufacturer or principal of authorised representative –hereinafter referre d simply as 'The Bidder') should have manufactured and supplied of at least 280 Rolls of simil ar type of Thermal Carbon Ribbon for Gothic numbering in any one year during the last five y ears ending on 31.03.2023.

(b) <u>Capability, equipment and manufacturing facilities:</u> (i) The Bidder firm should have annual capacity of manufacturing facilities.

- The Bidder firm should have annual capacity of manufactured and supplied at least 280 R olls of similar type of Thermal Carbon Ribbon for Gothic numbering. The self attested detail s shall be submitted along with bid.
- (ii) The bidder firm shall provide the following details with the bid documents :

(c) Financial standing:

- (iii) a) The net worth of the Bidder should not be negative on '31st March 2023' and also

b) should not have eroded by more than 30% in the last three years, ending on '31st Mar ch 2023'.

(d) The criteria for Capability, Equipment and Manufacturing facilities as well as financ ial loss and net worth under the financial standing eligibility criteria (above) shall b e applicable to all the bidder firms including MSES & Startup Firms.

(e) For Existing successful Past Suppliers: In case the bidder (manufacturer or principal of authorised representative) who is a successful past supplier of 'The Product' in at least one of the recent past three p rocurements, who do not meet any or more of requirements above, would also be considered to be qualified in view of their proven credentials, for the maximum quantity supplied by him in such recent past . (This clause is not applicable for Security Items as notified by Government of India from time to time.)

2. <u>Undertaking(s)</u>:

- (i) The firm should give undertaking that, "We / the Principle Manufacturer have not bee n black-listed/ debarred for dealing with any Govt. Organization / Public Sector Un dertaking (PSU) / Reputed Organization in the past".
- (ii) The firm should give undertaking that, "We agree to withdraw all the deviations, if a ny, unconditionally and accept all the terms and conditions of the tender docume nt including the technical specifications".
- (iii) The information given in the documents are correct and the Bidder is aware that in case a ny information provided is found to be false at a later stage, ISP reserves the right to reject/ disqualify the bidder at any stage of the tendering process without assigning any reason.

3. Other Eligibility requirements for the Bidders:

- **3.1** The bidder shall submit Local Content details as per clause No. 9; Verification of Local co ntent, of Public procurement (Preference to make in India) order 2017 No. P-45021/2/2017-PP(BE-II).
- **3.2** The bidder has to submit **Power of Attorney/ Authorization** indicating that authorized signatory is competent and legally authorized to submit the tender and / or enter into legal ly binding contract on firm's letter head.

3.3 Manufacturer's Authorisation Letter:

i) Wherever Authorised Distributors/service providers are submitting the bid, Authorisation Form /Certificate with OEM/Original Service Provider details such as name, designation, add ress, e-mail Id and Phone No. required to be furnished along with the bid. ii) The bidder shall submit the manufacturer's authorization letter to this effect as per the st andard form provided in buyer uploaded ATC Uploaded document.

iii) One manufacturer can participate through one authorized agent or one agent can partic ipate on behalf of one Principal Manufacturer only.

- **3.4** All experience, past performance and capacity/ capability related/ data should be certifie d by the authorized signatory of the bidder firm. The bidder should submit documentary e vidence regarding the past supply. The credentials regarding experience and past perform ance to the extent required as per eligibility criteria submitted by bidder should be verified from the parties for whom work has been done, hence copies of orders and corresponding experience certificate are to be submitted along with offer.
- **3.5** The application should be submitted in English Language. The authenticated copies of the documents in support of the applicant's claims must be submitted in **English language**.
- **3.6** All financial standing data (Balance sheet and Profit & Loss Statements etc.) should be ce rtified by certified accountants' e.g. Chartered Accountants (CA).
- **3.7** Decision on Finalization of tender will be taken based on the documents submitted along with the tender. All documents must be submitted as per tender requirement failing which offers will be liable for rejection and no further correspondence will be made/ entertained f or clarification after opening of the tender.
- **3.8** All the pages submitted are to be required & sealed by Authorised Signatory failing which tender shall be treated as unresponsive.
- **3.9** Bidder firm shall submit the copy of PAN & GST Registration Certificate.

5. General Condition Of Contract (GCC):

5.1 Packing and Marking: As per Technical Specifications of the tender document.

- **5.2 Transportation of Goods:** The transportation of goods to be procured will be done by the supp lier on FOR ISP Basis. The total cost of the transportation should be indicated in the price bid of the item to be procured.
- **5.3** Inspection and Quality Control In addition to clause No. 9 of GCC the following shall also be applicable:-
 - (i) The material supplied by the successful bidder will be accepted on manufacturer's conf orming to all parameters as per Technical Specification. The material will be accepted o n manufacturers guarantee certificate to be sent to purchaser. If any defects observed or the material is found unsuitable, then the same will be returned to the supplier for fr ee replacement upto India Security Press, Nashik or the purchaser shall be entitled to c ancel the contract, and if so desired, purchase or authorize purchase of the stores at th e risk and cost of the contractor.

- **5.4 Insurance:** A specific insurance cover for each consignment / supply is to be given by the firm, as applicable.
- **5.5 Warranty Clause:** Supplier should submit Test Certificate and provide the warranty with free r eplacement for a period of 12 months from the date of acceptance of Material at ISP & as per Tec hnical Specification.
- **5.6 Taxes and Duties**: If the tenderer fails to include taxes and duties as per law of the land in the tender, no claim thereof will be considered by purchaser at a later stage.
