2. Generic

1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.

2. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.

3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

A) The Scope of Service:

- a) The Advertising agency has to publish the "Notice for Inviting Tenders" or other advertisements, if any, as specified by India Security Press, Nashik as and when required in the News-papers as s pecified by India Security Press, Nashik.

i) Experience & Past performance :- The Bidder should have experience of having successfully completed similar kind of services for the value at least Rs. 4 Lakhs in any one of the last five year s ending on 31st March 2023

Note: The 'Experience and Past experience criteria' is exempted for Startups and Micro and Small Enterprises.

ii) **Capability:-** The bidder must have capability to provide the relevant services.

iii) Financial standing:-

a) The average annual financial turnover of the bidder during the last three years, endin g on 31st March 2023, should be at least Rs. 4 Lakhs (or equivalent in foreign currency at exchang e rate prevalent on 31st March 2023) as per the annual report (audited balance sheet and profit & loss account) of the relevant period, duly authenticated by a Chartered Accountant/ Cost Accounta nt in India or equivalent in relevant countries.

Note: The 'Average Annual Turnover criteria' is exempted for Startups and Micro and Small Enter prises.

b) The bidder should not have suffered any financial loss for more than one year during the last three years, ending on 31st March 2023.

c) (i) The net worth of the Bidder should not be negative on 31st March 2023 and also s hould not have eroded by more than 30% in the last three years, ending on 31st March 2023..

Applicability in Special Cases :- **For Existing successful Past Suppliers:** In case the bidder (manufacturer or principal of authorised representative) who is a successful past supplier of 'The Pr oduct' in at least one of the recent past three procurements, who do not meet any or more of requ irements above, would also be considered to be qualified in view of their proven credentials, for th e maximum quantity supplied by him in such recent past. 4. **Payment Terms**: - The payment will be released at actual Numbers of Tender Notices Publishe d and receipt of satisfactory report of services from the User Department and on production of all

required documents and submission of Bills on monthly basis. The payment will be done through o nline only. Therefore, the supplier has to produce all the Bank details such as Name of Bank, Acco unt No., IFSC Code No., MICR No. along with Bid Document. TDS will be deducted as per rules in fo rce.
