- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. Part Quantity Bidding

Buyer has allowed part quantity bidding, bidders can offer maximum quantity that they can deliver keeping in mind their capacity and delivery period requirements. The offer quantity has to be more than minimum bid quantity as specified by the Buyer in the bid. Offers with quantity less than Minimum are liable to be rejected. It may however be noted that there is no guarantee that full offer quantity will be ordered by the buyer. Quantity to be ordered by the buyer will depend on various factors including the Ranking of the bidder, Offered quantity, Splitting criteria indicated by the buyer in the bid and the requirement of the buyer to have multiple sources of supply for ensuring supply chain etc. Sellers would be notified about likely order quantity or range of possible order quantity at the time of price match request made by the buyer, ward of contract will be subject to acceptance of price match request along with min / max offer quantity as decided by the Buyer.

1. QUALIFICATION/ ELIGIBILITY CRITERIA

**Experience and past performance: The experience and Past performance Criteria is exempt ed.

Note: This tender is for development of venders for "Multicolour Ultra Violet Thread", he nce Already developed firms or firms who have already received development order s for the item (with whatever results) should not be considered in such tenders..

(a) Capability, equipment and manufacturing facilities:

(i) The Bidder firm should have annual capacity of manufactured and supplied at least 800 Reel s Multicolour Ultra Violet Thread. The self attested details shall be submitted along with bid.

Note: At the discretion of the purchaser, the Capacity / Capability Assessment / Verification of bidder / manufacturer firm(s) might be undertaken by Tender Evaluation C ommittee or through a third party Technical Consultancy / Inspection agencies to ensure that the firm is/are identified and capable to supply the item/material/product as required.

The bidder firm shall provide the following details with the bid documents :

(i) Name of the machine(s) utilized to supply the quoted product.

- (ii) The number of machines being utilized for the production and the capacity of each machine.
- (iii) Total Annual Capacity of the Machine.
- (iv) Supply orders in hand and proportionate capacity to supply the quoted product.

(b) Financial standing:

(i) Average Annual Turnover The average annual financial turnover of the bidder during the last three years, ending on '31st March 2023', should be at least Rs. 12,16,000/- as per the annual report (audited balance sheet and profit & loss account) of the relevant period, duly authent icated by a Chartered Accountant/Cost Accountant in India.

- (ii) The bidder should not have suffered any financial loss for more than one year during the last three years, ending on '31st March 2023'.

2. <u>Undertaking(s):</u>

- (i) The firm should give undertaking that, "We / the Principle Manufacturer have not be en black-listed/ debarred for dealing with any Govt. Organization / Public Sector Undertaking (PSU) / Reputed Organization in the past".
- (ii) The firm should give undertaking that, "We agree to withdraw all the deviations, if any, unconditionally and accept all the terms and conditions of the tender document including the technical specifications".
- (iii) The information given in the documents are correct and the Bidder is aware that in case a ny information provided is found to be false at a later stage, ISP reserves the right to reject/ dis qualify the bidder at any stage of the tendering process without assigning any reason.

3. Other Eligibility requirements for the Bidders:

- 3.1 The bidder shall submit Local Content details as per clause No. 9; Verification of Local cont ent, of Public procurement (Preference to make in India) order 2017 No. P-45021/2/2017-PP(BE-II); it is requested to provide a certificate from statutory auditor or cost auditor of your company.
- **3.2** The bidder has to submit **Power of Attorney/ Authorization** indicating that authorized signa tory is competent and legally authorized to submit the tender and / or enter into legally binding cont ract. Also provide two contact numbers, email ld.

3.3 Manufacturer's Authorisation Letter:

- **a)** Wherever Authorised Distributors/service providers are submitting the bid, Authorisation Form /Certificate with OEM/Original Service Provider details such as name, designation, address, e-mail Id an d Phone No. required to be furnished along with the bid.
- The bidder shall submit the manufacturer's authorization letter to this effect as per the standard form provided in buyer uploaded ATC Uploaded document.
- **c)** One manufacturer can participate through one authorized agent or one agent can participate on behalf of one Principal Manufacturer only.
- **3.4** All capacity/ capability related/ data should be certified by the authorized signatory of the bidd er firm. All the pages submitted are to be required & sealed by Authorised Signatory failing which te nder shall be treated as unresponsive

- **3.5** The application should be submitted in English Language. The authenticated copies of the doc uments in support of the applicant's claims must be submitted in **English language**.
- **3.6** All financial standing data (Balance sheet and Profit & Loss Statements for the year of 2020-20 21, 2021-2022 and 2022-2023 etc.) should be certified by certified accountants' e.g. Chartered Accountants (CA).
- **3.7** Decision on Finalization of tender will be taken based on the documents submitted along with th e tender. All documents must be submitted as per tender requirement failing which offers will be lia ble for rejection and no further correspondence will be made/ entertained for clarification after opening of the tender.
- **3.8** Bidder firm shall submit the copy of PAN & GST Registration Certificate.

- d) An entity whose beneficial owner is situated in such a country; or
- e) An Indian (or other) agent of such an entity; or
- f) A natural person who is a citizen of such a country; or
- g) A consortium or joint venture where any member of the consortium or joint venture falls under an y of the above.
- (v) The beneficial owner for the purpose of (III) above will be as under:
- a) In case of a company or Limited Liability Partnership, the beneficial owner is the natural person(s), who, whether acting alone or together, or through one or more judicial person, has a controlling ow

nership interest or who exercise control through other means.

- b) Explanation:
- (1) "Controlling ownership interest" means ownership of or entitlement to more than twenty-five per cent of shares or capital or profits of the company.
- (2) In case of a partnership firm, the beneficial owner is the natural person(s) who, whether acting al one or together, or through one or more juridical person, has ownership of entitlement to more than fifteen percent of Capital or profits of the partnership.
- (3) In case of an unincorporated association or body of individuals, the beneficial owner is the natura I person(s), who, whether acting alone or together, or through one or more juridical person, has own ership of or entitlement to more than fifteen percent of the property or capital or profits of such asso ciation or body of individuals;
- (4) Where no natural person is identified under (1) or (2) or (3) above, the beneficial owner is the rel evant natural person who holds the position of senior managing official.
- (5) In case of a trust, the identification of beneficial owner(s) shall include identification of the author of the trust, the trustee, the beneficiaries with fifteen percent or more interest in the trust and any o ther natural person exercising ultimate effective control over the trust through a chain of control or ownership.
