A. Qualification/ Eligibility Criteria

1. Experience and past performance: The bidder should have experience of having successfully com pleted similar kind of services for the value at least Rs.6,49,594/- in any one of the last five years ending on '31.03.2023'.

Note: Start-ups and Micro and small Enterprises are exempted from Experience and Past Performance criteria. In case any bidder is seeking exemption from Experience and Past Performance criteria, the su pporting documents to prove his eligibility for exemption must be submitted for evaluation.

2. Capability:-The bidder must have capability to provide the relevant service and should have at least

2 vehicles in the name of firm with valid Transport/Tour & Travel Registration.

3. Financial Standing:

a) The average annual turnover of the bidder during the last three years, ending on 31.03.2023 should be at least Rs.6,49,594/- as per the annual report (Audited Balance sheet and Profit & Loss Account sh all be submitted for evaluation) of Financial Year 2020-2021, 2021-2022 & 2022-2023, duly authentica ted by a chartered Accountant/Cost Accountant in India or equivalent in relevant countries.

Note: The Average Annual Turnover criteria are exempted for Start-ups and Micro and Small Enterpris es. In case any bidder is seeking exemption from Turnover criteria, the supporting documents to prove his eligibility for exemption must be submitted for evaluation.

b) The bidder should not have suffered any financial loss for more than one year during the last three years, ending on '31.03.2023'.

(i) The net worth of the Bidder should not be negative on '31.03.2023' and also

(ii) Should not have eroded by more than 30% in the last three years, ending on '31.03.2023'.

4. Applicability in Special Cases

a) Applicability to 'Make in India': Bidders (manufacturer or principal of authorised representative) If the product is being manufactured in India under a license from a foreign manufacturer who holds in tellectual property rights and where there is a technology collaboration agreement/ transfer of technol ogy agreement for indigenous manufacture of a product developed abroad with clear phased increase in local content, and who while meeting all other criteria above, except for any or more of sub-criteria i n Experience and Past Performance above, would also be considered to be qualified provided: i) their f oreign manufacturer who holds intellectual property rights, meets all the criteria above without exemp tion, and ii) the Bidder submits appropriate documentary proof for technology collaboration agreement / transfer of technology agreement for indigenous manufacture of a product developed abroad with cle ar phased increase in local content. iii) the bidder (manufacturer or principal of authorised representati ve) furnishes along with the bid a legally enforceable undertaking jointly executed by himself and such foreign Manufacturer for satisfactory manufacture, Supply (and erection, commissioning if applicable) and performance of 'The Product' offered including all warranty obligations as per the general and spe cial conditions of contract.

b) Authorized Representatives: Bids of bidders quoting as authorised representative of a principal manufacturer would also be considered to be qualified, provided: i) their principal manufacturer meets all the criteria above without exemption, and ii) the principal manufacturer furnishes a legally enforcea

ble tender-specific authorisation in the prescribed form assuring full guarantee and warranty obligation s as per the general and special conditions of contract; and iii) the bidder himself should have been ass ociated, as authorised representative of the same or other Principal Manufacturer for same set of servi ces as in present bid (supply, installation, satisfactorily commissioning, after sales service as the case may be) for same or similar 'Product' for past three years ending on '31.01.2023.

c) For Existing successful Past Suppliers: In case the bidder (manufacturer or principal of authoris ed representative) who is a successful past supplier of 'The Product' in at least one of the recent past t hree procurements, who do not meet any or more of requirements above, would also be considered to be qualified in view of their proven credentials, for the maximum quantity supplied by him in such rec ent past. (This clause is not applicable for Security Items as notified by Government of India from time to time.)

d) Joint Ventures and Holding Companies: Credentials of the partners of Joint ventures cannot (re peat cannot) be clubbed for the purpose of compliance of PQC in supply of Goods/Equipment, and eac h partner must comply with all the PQC criteria independently However, for the purpose of qualifying t he Financial Standing Criteria, the Financial Standing credentials of a Holding Company can be clubbed with only one of the fully owned subsidiary bidding company, with appropriate legal documents provin g such ownership.

e) Development/ insufficient market capacity or Exceptional One- Off Cases: These are those items which are either being newly developed where vendors are yet to be developed or for new/ exist ing items where the capacity available in market is inadequate compared to our annual requirements. Exceptional one-off cases are such items/ Plant & Machinery which are procured infrequently (say onc e in 3 years or longer periods). a. The application should be submitted in English Language. The authenticated copies of the docum ents in support of the applicant's claims must be submitted in English language.

b. The bidder shall indicate/ certify that authorized signatory is competent and legally authorized to submit the tender and/ or to enter into legally binding contract.

c. Blacklisting: The bidder firm should submit declaration that the firm has not been blacklisted/ deb arred by any government agency / Public Sector Unit/ Reputed organization.

d. Agree to withdraw all deviations: The declaration that "We agree to withdraw all the deviations, if any, unconditionally and accept all the terms and conditions of the tender document including the Sc ope of Work, Service Level Agreement and Payment Terms".
