1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
2. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of

quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.

3. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

4. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

5. Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non - Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and small enterprises will be allowed to participate .The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023.

6. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25%(selected by Buyer) percentage of total QUANTITY. Buyer Added text based ATC clauses

**A. MINIMUM QUALIFICATION CRITERIA****1. Experience and past performance:** The experience and Past performance Criteria is exempted.

**Note:** This tender is for development of vendors for "Synthetic Resin Adhesive (Permanent Type)", hence already developed firms or firms who have already received development orders for the item (with whatever results) should not be considered in such tenders.

**2. Capability, equipment and manufacturing facilities:-**

- a) The bidder must have an annual capacity to manufacture and supply at least 4,000 Kg of "Synthetic Resin Adhesive".
- b) The bidder has to submit the following details along with the bid:
  - i) Name of the machine utilized to supply the quoted product.
  - ii) The number of machines being utilized for the production and the capacity of each machine.
  - iii) Total Annual capacity of Manufacturer
  - iv) Supply orders in hand and proportionate capacity to supply quoted amount

**Note:**

**i.** At the discretion of the purchaser, the Capacity / Capability Assessment / Verification of bidder / manufacturer firm(s) might be undertaken by a Committee or through a third party Technical Consultancy / Inspection agencies to ensure that the firm is/are identified and capable to supply the machine/item/material/product as required.

**ii.** During capacity/capability assessment, firm has to manufacture sample as per ISP's Bid Specification. T

he sample (at least 10 Kg) shall be collected by the nominated committee and machine trial shall be conducted at ISP, Nashik and capability assessment shall be finalized after machine trial.

### 3. Financial Standing:

a) The average annual financial turnover of the bidder during the last three years, ending on '31.03.2023', should be at least Rs.7,78,800/- as per the annual (audited balance sheet and profit & loss account of relevant Financial Year shall be submitted for evaluation) of Financial Year 2020-2021, 2021-2022 & 2022-2023, duly authenticated by a Chartered Accountant/Cost Accountant in India or equivalent in relevant countries.

**Note:** The Average Annual Turnover criteria are exempted for Start-ups and Micro and Small Enterprises. In case any bidder is seeking exemption from Turnover criteria, the supporting documents to prove his eligibility for exemption must be submitted for evaluation.

b) The bidder should not have suffered any financial loss for more than one year during the last three years, ending on '31.03.2023'.

(i) The net worth of the Bidder should not be negative on '31.03.2023' and also

(ii) Should not have eroded by more than 30% in the last three years, ending on '31.03.2023'.

### 4. Applicability in Special Cases

**a) Applicability to 'Make in India':** Bidders (manufacturer or principal of authorized representative) If the product is being manufactured in India under a license from a foreign manufacturer who holds intellectual property rights and where there is a technology collaboration agreement/ transfer of technology agreement for indigenous manufacture of a product developed abroad with clear phased increase in local content, and who while meeting all other criteria above, except for any or more of sub-criteria in Experience and Past Performance above, would also be considered to be qualified provided: i) their foreign manufacturer who holds intellectual property rights, meets all the criteria above without exemption, and ii) the Bidder submits appropriate documentary proof for technology collaboration agreement/ transfer of technology agreement for indigenous manufacture of a product developed abroad with clear phased increase in local content. iii) the bidder (manufacturer or principal of authorized representative) furnishes along with the bid a legally enforceable undertaking jointly executed by himself and such foreign Manufacturer for satisfactory manufacture, Supply (and erection, commissioning if applicable) and performance of 'The Product' offered including all warranty obligations as per the general and special conditions of contract.

**b) Authorized Representatives:** Bids of bidders quoting as authorized representative of a principal manufacturer would also be considered to be qualified, provided: i) their principal manufacturer meets all the criteria above without exemption, and ii) the principal manufacturer furnishes a legally enforceable tender-specific authorization in the prescribed form assuring full guarantee and warranty obligations as per the general and special conditions of contract; and iii) the bidder himself should have been associated, as authorized representative of the same or other Principal Manufacturer for same set of services as in present bid (supply, installation, satisfactorily commissioning, after sales service as the case may be) for same or similar 'Product' for past three years ending on '31.01.2023'.

**c) Joint Ventures and Holding Companies:** Credentials of the partners of Joint ventures cannot (repeat cannot) be clubbed for the purpose of compliance of PQC in supply of Goods/Equipment, and each partner must comply with all the PQC criteria independently. However, for the purpose of qualifying the Financial Standing Criteria, the Financial Standing credentials of a Holding Company can be clubbed with only one of the fully owned subsidiary bidding company, with appropriate legal documents proving such ownership.

**d) Start-up Enterprises:** Requirements of prior experience and turnover would be relaxed for Start-up enterprises as recognized by Department for Promotion of Industry and Internal Trade (DPIIT), subject to their meeting the quality and technical specifications. Such Start-ups may be either MSE or otherwise.

### 5. The Bidder shall give following undertakings on their Letter Head regarding this requirement.

i) **Non Blacklisting:** We M/s.<Name of the bidder firm> has not been blacklisted/ debarred by any government agency / Public Sector Unit/ Reputed organization.

ii) **Agree to withdraw all deviations:** We M/s.<Name of the bidder firm> agree to withdraw all the deviations, if any, unconditionally and accept all the terms and conditions of the tender document including the technical specifications".

### 6. Manufacturer's Authorization Letter: In case the bidder firm/ bidder offers to supply 'Synthetic Resin Adhesive(Permanent Type)', which are manufactured by some other firm, the bidder has to be duly authorized

zed by the manufacturer of the stated material to quote for and supply the same to India Security Press, a unit of SPMCIL. The bidder shall submit the manufacturer's authorization letter to this effect as per the standard form provided in "buyer uploaded ATC Uploaded document".

**Note:** One manufacturer can participate through one authorized agent or one agent can participate on behalf of one Principal Manufacturer only.

**B. TECHNICAL SPECIFICATIONS (To be submitted on firm's Letter Head as a token of acceptance) : Technical Specifications are attached under Buyer Specification Document.**

**C. Pre-Production Sample, Delivery Schedule & Quality Control Requirement:- (To be submitted on firm's Letter Head as a token of acceptance)**

**1) Pre-Production Sample:-** The successful bidder(s) shall supply 1<sup>st</sup> lot of 50 Kgs of Synthetic Adhesive (Permanent Type) within 15 days from the date of issue of GeM Contract, as a pre-production sample. The successful firm will be given three (03) chances to make the improvements, in a transparent and equitable manner. Such chances shall be given with a reasonable timeframe and it should not be left open ended. The failure of sample of one bidder shall be shared with all bidders while hiding the identity (without violating any intellectual Property Rights (IPR) involved) of the bidder of failed sample.

**2) Delivery Schedule:-**Detailed delivery schedule for remaining quantity is as follows:

- i. 2<sup>st</sup> lot of 950 Kg within 40 days of award of GeM Contract as a pre-production sample shall be supplied by bidder.
- ii. 3<sup>rd</sup> lot of 2000 Kg within 70 days of award of GeM Contract
- iii. 4<sup>th</sup> lot of 2000 Kg within 100 days of award of GeM Contract
- iv. 5<sup>th</sup> lot of 2000 Kg within 130 days of award of GeM Contract
- v. 6<sup>th</sup> lot of 3000 Kg within 160 days of award of GeM Contract

**3)** Each of the above delivery shall be proportionally placed as per parallel contract/bid splitting condition.

**4) Quality Control Requirement:-**

The material supplied by the successful bidder will be accepted on the basis of trial carried out on the machine and other technical requirement mentioned in section VII along with Test Certificate to be sent to purchaser along with each consignment from a recognized Govt. Laboratory/ NABL Accredited Lab.

If any defects observed or the material found unsuitable, then the same will be returned to the supplier for free replacement upto India Security Press, Nashik.

**D. Special Conditions of Contract (SCC):- (To be submitted on firm's Letter Head as a token of acceptance)**

**1) Bid Splitting/Parallel Contract:** India Security Press, Nashik reserves its rights to conclude Bid Splitting/Parallel Contract with more than one bidder (maximum upto Three bidders for the same tender) without any prejudice to the capacity of the L1 bidder. In case of splitting in Three, the ratio of 50:30:20 will be used.

**2) Transportation of Goods:** The transportation of goods to be procured will be done by the supplier on FOR ISP Basis. The total cost of the transportation should be indicated in the price bid of the item to be procured.

**3) Insurance:** Since Indigenous bidder has to deliver the material on FOR ISP Nashik basis therefore the cost of the insurance will also be the part of the cost of the material borne by the supplier. A specific insurance cover for each consignment/supply is to be given by firm, as applicable.

**4) Distribution of Dispatch Documents for Clearance/Receipt of Goods:** The supplier shall send all the relevant dispatch documents well in time to ISP Nashik to enable ISP Nashik to clear or receive (as the case may be) the goods in terms of the contract.

**5) Taxes and Duties:** Supplier shall be entirely responsible for all taxes, duties, fees, levies etc. incurred until delivery of the contracted goods to SPMCIL. If the tenderer fails to include taxes and duties as per law of the land in the tender, no claim thereof will be considered by purchaser at a later stage.

**6) Terms and Mode of Payment:** 100% payment will be released within ten (10) days of issue of consignee receipt-cum-acceptance certificate (CRAC) and on-line submission of bills. The payment will be done through online mode only. Therefore, the suppliers have to produce all the Bank details such as Name of Bank, Account No., IFSC Code No., MICR No. along with the Tender document. TDS, if any, will be deducted as applicable.

**7) Liquidated Damages:** Being a Development Tender, the Liquidated Damages clause is not applicable. However, the successful firm(s) shall supply the material as per delivery schedule given the Tender/ Purchase Order(s).

**8) NOTE:**

2. All experience, past performance and capacity/ capability related/ data should be certified by the authorized signatory of the bidder firm.
3. Decision on Finalization of tender will be taken based on the documents submitted along with the tender. All documents must be submitted as per tender requirement failing which offers will be liable for rejection.
4. All the pages submitted are to be sealed & signed by Authorized Signatory failing which tender shall be treated as unresponsive.

**9) Ministry of Finance, Department of Expenditure, Public Procurement Division, Order s (Public Procurement 1,2 and 3) F. No. 6/18/2019-PPD dated 23rd/ 24th July 2020 (or any further amendments thereof) regarding eligibility of bidders from specified countries shall be applicable to this tender. - a) An entity incorporated, established or registered in such a country; or
- b) A subsidiary of an entity incorporated, established or registered in such a country; or

- e) An Indian (or other) agent of such an entity; or
- f) A natural person who is a citizen of such a country; or
- g) A consortium or joint venture where any member of the consortium or joint venture falls under any of the above.

(v) The beneficial owner for the purpose of (III) above will be as under:

a) In case of a company or Limited Liability Partnership, the beneficial owner is the natural person(s), who, whether acting alone or together, or through one or more juridical person, has a controlling ownership interest or who exercise control through other means.

b) Explanation:

(1) "Controlling ownership interest" means ownership of or entitlement to more than twenty-five per cent of shares or capital or profits of the company.

(2) In case of a partnership firm, the beneficial owner is the natural person(s) who, whether acting alone or together, or through one or more juridical person, has ownership of or entitlement to more than fifteen percent of Capital or profits of the partnership.

(3) In case of an unincorporated association or body of individuals, the beneficial owner is the natural person(s), who, whether acting alone or together, or through one or more juridical person, has ownership of or entitlement to more than fifteen percent of the property or capital or profits of s

uch association or body of individuals;

(4) Where no natural person is identified under (1) or (2) or (3) above, the beneficial owner is the relevant natural person who holds the position of senior managing official.

(5) In case of a trust, the identification of beneficial owner(s) shall include identification of the author of the trust, the trustee, the beneficiaries with fifteen percent or more interest in the trust and any other natural person exercising ultimate effective control over the trust through a chain of control or ownership.

(vi) An Agent is a person employed to do any act for another, or to represent another in dealings with third person.
