#### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

## **Buyer Added Bid Specific ATC**

The Bidder firm should meet following eligibility criteria to qualify in the Techno Commercial Bid:-

**I) Experience and Past Performance:-** The bidder (manufacturer or principal of authorized representative) shall be a manufacturer that has regularly for at least three years manufactured, supplied, erected, commissioned similar type of 'Guillotine control system- Electrical and electronic system for guillotine machine' with the same or higher specification of at least one number in any one of the last five years ending on 31.03.2023.

#### Note:

i)Copies of PO's and completion/Experience certificates issued by customers to be provided in support of above.

ii)Startups and Micro and Small Enterprises are exempted from Experience and Past Performance criteria. In case an y bidder is seeking exemption from Experience and Past Performance Criteria, the supporting documents to prove h is eligibility for exemption must be submitted for evaluation. In case of MSE the firm should be manufacturer of simil ar type of 'Guillotine control system- Electrical and electronic system for guillotine machine' for exemption, otherwis e will not be considered for exemption.

**II) Capability:-** The bidder must have an annual capacity to manufacture and supply at least one no. of similar type of 'Guillotine control system- Electrical and electronic system for guillotine machine'.

Note: At the discretion of the purchaser, the capacity/capability Assessment/ Verification of bidder/ manufacturer fir m(s) might be undertaken by Committee or through a third party Technical consultancy/ Inspection agencies to ensure that the firm is/are identified and capable to supply the item/material/product as required.

## III) Financial Standing:-

a) The Average annual financial turnover of the bidder during the last three years, ending on 31.03.2023 should be at least Rs.5,11,648/- as per the annual report (audited balance sheet and profit & loss account of FY 2020-21, 2021 -22 and 2022-23) of the relevant period, duly authenticated by a Chartered Accountant/Cost Accountant in India or e quivalent in relevant countries.

Note: The Average Annual Turnover Criteria is exempted for Startups and Micro and Small Enterprises.

- b) The bidder should not have suffered any financial loss for more than one year during the last three years, ending on 31.03.2023
- c) The net worth of the Bidder should not be negative on 31.03.2023 and should not have eroded by more than 30% in the last three years, ending on 31.03.2023.
- **IV)** For Existing successful Past Suppliers: In case the bidder (manufacturer or principal of authorized represen tative) who is a successful past supplier of 'The Product' in at least one of the recent past three procurements, who do not meet any or more of requirements above, would also be considered to be qualified in view of their proven cr edentials, for the maximum quantity supplied by him in such recent past. (This clause is not applicable for Security I tems as notified by Government of India from time to time.)
- **V) Joint Ventures and Holding Companies:** Credentials of the partners of Joint ventures cannot (repeat cannot) be clubbed for the purpose of compliance of PQC in supply of Goods/Equipment, and each partner must comply with all the PQC criteria independently However, for the purpose of qualifying the Financial Standing Criteria, the Financial Standing credentials of a Holding Company can be clubbed with only one of the fully owned subsidiary bidding company, with appropriate legal documents proving such ownership.
- **VI) Start Up Enterprises:** Requirements of prior experience and turnover would be relaxed for Startup enterprise s as recognized by Department for Promotion of Industry and Internal Trade (DPIIT), subject to their meeting the quality and technical specifications. Such Start-Ups maybe either MSE or otherwise.
- **VII) Manufacturer's Authorisation Letter:** In case the bidder firm/bidder offers to supply of similar type of 'Guill otine control system- Electrical and electronic system for guillotine machine', which is manufactured by some other firm, the bidder has to be duly authorized by manufacturer of the stated material to quote for and supply the same to India Security Press, A unit of SPMCIL. The bidder shall submit the manufacturer's authorization letter to this effect as per the standard form provided with the bid document.
- **VIII) PAN:** The Bidder should be registered with the Income tax. Relevant proof in support shall be submitted.
- **IX) Goods & Service Tax Registration (GST):** The Bidder should be registered with Goods & Service Tax (GST). R elevant proof of registration Certificate shall be submitted.

#### X) Undertaking:-

- a) "We M/s has not been blacklisted by Government of India in the past.

#### XI) Note:

- a) The Indian agent on behalf of the Principal/OEM or principal/OEM itself can bid but both cannot bid simultaneousl y for the same item/ product in the same Bid. If an agent submits bid on behalf of the Principal/OEM, the same age nt shall not submit a bid on behalf of another Principal/OEM in the same Bid for the same item.
- b) Interested firms are requested to submit the above required documents sealed and signed on al I pages along wit h Bid.
- c) No further correspondence will be made with the bidders for shortfall of documents, if any; such offers with partial submission of documents will be summarily rejected.
- d) The Bid should be completed in all the respect including submission of all the required documents so that further clarification may not be called for.
- **XII) Delivery Schedule: -** The total supply including Installation Testing Commissioning shall be done within 90 days from the date of issue of Contract.

- XIII) Warranty: The firm will have to give one year warranty of the offered material and workmanship.
- **XIV) Quantum of LD:-** If the Seller/Service Provider fails to deliver any or all of the Goods/Services within the original/re-fixed delivery period(s) specified in the contract, the Buyer will be entitled to deduct/recover the Liquidated Damages for the delay, unless covered under Force Majeure conditions aforesaid, @ 0.5% of the contract value of delayed quantity per week or part of the week of delayed period as pre-estimated damages not exceeding 10% of the contract value of delayed quantity without any controversy/dispute of any sort whatsoever.
- **XV) Payment Terms: -** The Payment terms are 100% after successful Supply Installation Testing Commissioning, t rail run and handover of system to ISP along with satisfactory report of user and maintenance personnel within 30 d ays.

### XVI) Note regarding MSE and MII purchase preference:

#### **For MSE Purchase Preference:**

Instant bid is non-splitable / non-dividable in nature. Therefore, in case L1 is non-MSE then MSE firm quoting price wi thin L1+15% band will be awarded full tendered quantity subject to matching the L1 prices.

#### For MII Purchase Preference:

For goods and works where the requirements are not divisible in nature

- a) Among all qualified bids, the lowest bid will be termed as L1. If L1 is 'Class-I local supplier', the contract will be aw arded to L1.
- b) If L1 is not 'Class-I local supplier' the lowest bidder among the 'Class –I local supplier', will be invited to match the L1 price subject to Class-I local supplier's quoted price falling within the margin of purchase preference i.e. L1+20% band, and the contract shall be awarded to such 'Class-I local supplier' subject to matching the L1 price.

- 1. In case of a company or Limited Liability Partnership, the beneficial owner is the natural person(s), who, whether action alone or together, or through one or more juridical person, has a controlling ownership interest or who exerci ses control through means.

Explanation. "Controlling ownership interest" means ownership of or entitlement to more than twenty-five per cent. Of shares or capital or profits of the company;

- b. "Control" shall include the right to appoint majority of the directors or to control the management or policy decisi ons including by virtue of their shareholding or management rights or shareholders agreements or voting agreements;
- 2. In case of a partnership firm, the beneficial owner is the natural person(s) who, whether acting alone or together, or through one or more juridical person, has ownership of entitlement to more than fifteen percent of capital or profits of the partnership;
- 3. In case of an unincorporated association or body of individuals, the beneficial owner is the natural person(s), who, whether acting alone or together, or through one or more juridical person, has ownership of or entitlement to more than fifteen percent of the property or capital or profits of such association or body of individuals;
- 4. Where no natural person is identified under (1) or (2) or (3) above, the beneficial owner is the relevant natural per son who holds the position of senior managing official;
- 5. In case of a trust, the identification of beneficial owner(s) shall include identification of the author of the trust, the trustee, the beneficiaries with fifteen percent or more interest in the trust and any other natural person exercising u ltimate effective control over the trust through chain of control or ownership.
- 5. An agent is a person employed to do any act for another, or to represent another in dealings with third person.
- 6. [To be inserted in tenders for Work contracts, including Turnkey contracts] The successful bidder shall not be allo wed to sub-contract works to any contractor from a country which shares a land border with India unless such contractor is registered with the Competent Authority.
- 7. The registration shall be valid at the time of submission of bid and at the time of acceptance of bid.
- 8. If the bidder was validly registered at the time of acceptance/placement of order, registration shall be a relevant consideration during contract execution.
