bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.

2. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
3. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the

completed financial years after the date of constitution shall be taken into account for this criteria. 4. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU / Public Listed Company for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.

5. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non - Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and small enterprises will be allowed to participate. The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023 <u>OM No.1 4 2021 PPD dated 18.05.2023</u> for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017.

6. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have guoted price within L-1+ 15% (Selected by Buyer)of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total QUANTITY. The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. 7. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 40% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU / Public Listed Company. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Forms of EMD and PBG

Bidders can also submit the EMD with Account Payee Demand Draft in favour of

India Security Press, a unit of SPMCIL payable at Nashik Road

Bidder has to upload scanned copy / proof of the DD along with bid and has to ensure delivery of hardcopy to the Buyer within 5 days of Bid End date / Bid Opening date.

3. Forms of EMD and PBG

Bidders can also submit the EMD with Fixed Deposit Receipt made out or pledged in the name of A/C (Name of the Buyer). The bank should certify on it that the deposit can be withdrawn only on the demand or with the sanction of the pledgee. For release of EMD, the FDR will be released in the favour of the bidder by the Buyer after making endorsement on the back of the FDR duly signed and stamped along with covering letter. Bidder has to upload scanned copy/ proof of the FDR along with bid and has to ensure delivery of hardcopy to the Buyer within 5 days of Bid End date/ Bid Opening date

Peel Strength Test Equipment:

1. Equipment will be used to determine the peel strength between different layer used in machine readabl e passport/ Inlay.

2. Equipment should have Pressure and Cycle (minimum 1000 cycles) setting arrangement.

3. The equipment should have measuring load range of 0 N to 500 N and peel stroke of 150 mm maximum

- 4. Equipment should be provided with display showing pressure and number of cycle.
- 5. Working manual should be provided in English
- 6. NABL accredited calibration certificate should be provided.

7. Equipment should comply with the National/International standard of machine readable travelling docu ment testing ISO/IEC 10373, ISO/IEC 18745-1.

8. Training regarding working principle at the time of commissioning and installation should be provided

The Firm shall be the minimum eligibility criteria for selection of bidders technically:-.

1. **Experience and past performance:** The bidder should have manufactured and/or supplied Peel Str ength Test Equipment or similar or higher specification equipment of at least worth Rs.1,99,892/- to any fi rm in the last Five year ending with 31st March 2023.

Note: In proof of having fully adhered to minimum criteria attested copy of experience certificate/ Supply O rder/ Purchase Order issued by the parties to whom the material / service has been supplied /rendered.

Note: "MSEs and Startup firms are exempted for Experience and Past experience criteria".

2. **Capability:** The bidder or its Principal manufacturer must have an annual capacity to manufacture and / or supply Peel Strength Test Equipment of similar or higher specification equipment of at least Rs. 1,99,8 92/-. Undertaking regarding this requirement shall be submitted by the bidder on their Letter Head.

Note: At the discretion of the purchaser ,the Capacity / Capability Assessment / Verification of bidder / man ufacturer firm(s) might be undertaken by a Committee or through a third party Technical Consultancy / In spection agencies to ensure that the firm is /are identified and capable to supply the machine/item/mate rial /product as required.

3. Undertaking:

(i). The firm should give undertaking that, "We have not been black-listed/ debarred for dealing wit h any Gov. Organization in the past".

(ii). The firm should give undertaking that, "We agree to withdraw all the deviations, if any, uncond itionally and accept all the terms and conditions of the tender document including the technical spe cifications".

4. Applicability in Special Cases

a) For Existing successful Past Suppliers: In case the bidder (manufacturer or principa I of authorised representative) who is a successful past supplier of 'The Product' in at least one of the recent past three procurements, who do not meet any or more of requirements above, would also be considered to be qualified in view of their proven credentials, for the maximum quantity supplied by him in such recent past. (This clause is not applicable for S ecurity Items as notified by Government of India from time to time.)

b) Joint Ventures and Holding Companies: Credentials of the partners of Joint ventures cannot (repeat cannot) be clubbed for the purpose of compliance of PQC in supply of Good s/Equipment, and each partner must comply with all the PQC criteria independently Howev er, for the purpose of qualifying the Financial Standing Criteria, the Financial Standing cred entials of a Holding Company can be clubbed with only one of the fully owned subsidiary bi dding company, with appropriate legal documents proving such ownership.

c) Start-up Enterprises: Requirements of prior experience and turnover would be relaxe d for Start-up enterprises as recognised by Department for Promotion of Industry and Inter nal Trade (DPIIT), subject to their meeting the quality and technical specifications. Such St art-ups maybe either MSE or otherwise.

Liquidated Damages: If the Seller/Service Provider fails to deliver any or all of the Goods/Services wit hin the original/re-fixed delivery period(s) specified in the contract, the Buyer will be entitled to deduct/rec over the Liquidated Damages for the delay, unless covered under Force Majeure conditions aforesaid, @ 0. 5% of the contract value of delayed quantity per week or part of the week of delayed period as pre-estimat ed damages not exceeding 10% of the contract value of delayed quantity without any controversy/dispute of any sort whatsoever.

7. **Payment Terms:** 100% payment will be released within ten (10) days of issue of consignee receipt-cu m-acceptance certificate (CRAC) and submission of bills unless otherwise specified in STC/ATC.
