1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1. Terms and Mode of Payment:- The payment will be made after successful completion of the work

2. Delivery Schedule: - within 15 (fifteen) days from the date of issue of Contract.

3. Financial Document: - The firm has to submit Financial Documents for price break up as per a ttached Excel format.

4. The bidder for should meet following eligibility criteria to qualify in the Techno Com mercial Bid

(i) Experience and past performance: The bidder should have experience of having successfull y completed similar kind of services for the value at least Rs. 1,18,582.92/- in any one of the last fi ve years ending on 31.03.2023.

Note: The 'Experience and Past experience criteria' is exempted for Startups and Micro and Small Enterprises.

(ii) Capability-The bidder must have capability to provide the relevant services.

Applicability in Special Cases

1) For Existing successful Past Suppliers: In case the bidder who is a successful past supplier of 'The Product' in at least one of the recent past three procurements, who do not meet any or mo re of requirements above, would also be considered to be qualified in view of their proven credenti als, for the maximum quantity supplied by him in such recent past. (This clause is not applicable f or Security Items as notified by Government of India from time to time.)

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
