- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
- 2. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
- 3. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU / Public Listed Company for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.

- 4. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and small enterprises will be allowed to participate. The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017.
- 5. Procurement under this bid is reserved for purchase from Micro and Small Enterprises whose credentials are validated online through Udyog Aadhaar for that product category. If the bidder wants to avail the reservation benefit, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service.
- 6. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 40% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU / Public Listed Company. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

## 1. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

### A. MINIMUM QUALIFICATION CRITERIA

**1. Experience and Past Performance:** The bidder firm should have manufactured / supplied at least 600 Nos. of similar type of Adhesive Tape in any one year during last five years i.e. from 01st April 2018 to 31st March 2023.

Note: Start-ups and Micro and small Enterprises are exempted from Experience and Past Performance cr iteria. In case any bidder is seeking exemption from Experience and Past Performance criteria, the supp orting documents to prove his eligibility for exemption must be submitted for evaluation.

**2. Capability, equipment and manufacturing facilities:-**The Bidder firm must have an annual cap acity to manufacture / supply at least 600 Nos. of similar type of Adhesive Tape. Undertaking regarding this requirement shall be submitted by the bidder on their Letter Head.

### 3. Applicability in Special Cases

- a) For Existing successful Past Suppliers: In case the bidder who is a successful past supplier of 'The Product' in at least one of the recent past three procurements, who do not meet any or mo re of requirements above, would also be considered to be qualified in view of their proven credentials, for the maximum quantity supplied by him in such recent past.
- **5. Certificate of MSE:** The firm must have a valid registration certificate as MSE issued by NSIC, DGS &D or any authorized body by Ministry of MSME for Manufacturing of the tendered item and the same s hall be submitted by the firm along with tender/bid.
- 4. The Bidder shall give following undertakings on their Letter Head regarding this require ment.
  - i) The firm should give a declaration that, We M/s.<Name of the bidder firm> have not been black-lis ted/debarred for dealing by Government of India/PSU/Reputed Organization in the Past.
  - **ii)** Agree to withdraw all deviations: The declaration that "We M/s.<Name of the bidder firm> agree to withdraw all the deviations, if any, unconditionally and accept all the terms and conditions of the tender document including the technical specifications"

# SPECIFICATIONS OF HAND TEARABLE-PRINTED-SPECIAL SURFACE ADHESIVE TAPES (BOPP) With SPMCIL Logo.

- a. Colour of the Tape:-Light Pink (Base Colour)
- b. Width:-72 mm
- c. Length:-65 Meters
- d. Thickness of Film with Adhesive:-60 Micron + 2
- e. Thickness of Film:-30 Micron +2
- f. Tensile Strength of Basic Film:-250 Kgf / cm 2
- g. Breaking Strength and Elongation at break of basic Film:-50%
- h. Adhesion Strength to Metal (IS-8402-1977):-250 gms-cm/Width
- i. Anchorage Test:-For the purpose of this standard the definition given in IS-8402-1977 shall apply.
- j. Stability Test (IS-8402-1977):-Stability is determined by finding the adhesion strength of the tape aft er ageing at  $50 \pm 1^{\circ}$ C for one week.
- k. Durability Test (IS-8402-1977):-It should be capable of maintaining a temperature of  $70 \pm 1^{\circ}$ C, and h umidity control.
- I. Internal Diameter of the Core:-75 mm
- m. Printing:- Text to be printed in single Colour Black & SPMCIL Logo design to be printed in Dark Brow n, White & Black which will be provided to successful tenderer.
- n. General: Tape is required for edge joint/sealing of corrugated box having printed material up to 80 K g. Adhesivity should be of very good tack that should be in position to resist the load/weight and trans port hazards.

# C. Pre-Dispatch Sample and Delivery Schedule & Quality Control Requirement:-

- 1) Pre-Dispatch Sample:- 2 Rolls of Special Surface Adhesive Tape as a Pre-Production to be supplied within 15 days from the date of issue GeM Contract at free of cost. Sample suitability will be conveyed within 10 days from the date of receipt of sample.
- **2) Delivery Schedule:- Bulk Supply**: After sample suitability, the firm has to supply entire quantity in one lot within 55 days from the date of issue of GeM Contract.
- 3) Quality Control Requirement:-
- (i) The material supplied by the successful bidder will be accepted on all parameters as per specificati

on provided in the Bid Document. The purchaser reserves the right to get the material supplied tested from in-house laboratory or any other laboratory of repute and in case the material is found not meetin g the specification, the purchaser shall be entitled to cancel the contract, and if so desired, purchase o r otherwise the purchase of the stores at the risk and cost of the contractor.

(ii) After receipt of goods, the goods will be inspected/ tested at ISP. If any defect/variation is noticed t hen the same will be replaced free of cost by the supplier/seller up to India Security Press, Nashik Roa d, failing which equivalent amount of defective material will be deducted in the subsequent bills or fro m any amount due to them.

## D. Special Conditions of Contract (SCC)

- **1) Transportation of Goods:** The transportation of goods to be procured will be done by the supplie r on FOR ISP Basis. The total cost of the transportation should be indicated in the price bid of the item t o be procured.
- **2) Insurance:** Since Indigenous bidder has to deliver the material on FOR ISP Nashik basis therefore t he cost of the insurance will also the part of the cost of the material borne by the supplier. A specific in surance cover for each consignment/supply is to be given by firm, as applicable.
- **3) Distribution of Dispatch Documents for Clearance/Receipt of Goods:** The supplier shall sen d all the relevant dispatch documents well in time to ISP Nashik to enable ISP Nashik to clear or receiv e (as the case may be) the goods in terms of the contract.
- **4) Taxes and Duties:** Supplier shall be entirely responsible for all taxes, duties, fees, levies etc. incur red until delivery of the contracted goods to SPMCIL. If the tenderer fails to include taxes and duties as per law of the land in the tender, no claim thereof will be considered by purchaser at a later stage.
- **5) Terms and Mode of Payment:** 100% payment will be released within ten (10) days of issue of consignee receipt-cum-acceptance certificate (CRAC) and on-line submission of bills. The payment will be done through online mode only. Therefore, the suppliers have to produce all the Bank details such as Name of Bank, Account No., IFSC Code No., MICR No. along with the Tender document. TDS, if any, will be deducted as applicable.

### 6) NOTE:

Bidders are bound to accept the orders accordingly.

# Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. Any clause(s) incorporated by the Buyer regarding following shall be treated as null and void and would not be considered as part of bid:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
