- 1. 1. Generic

- (b) The bidder should not have suffered any financial loss for more than one year during the last three year s, ending on 31.03.2023.
- (c) The net worth of the bidder should not be negative as on 31.03.2023 and also not have eroded by more than 30% in the last three years, ending on 31.03.2023.

Applicability in Special Cases

III. Payment Terms: -

- 1. The payment due to the bidder will be released on quarterly basis. For this the firm will have to submit the Tax Invoice and Attendance Record, EPF Subscription Paid Receipts, ESIC Subscription Paid Receipt and Service Report regarding works performed. The same will be scrutinised and verified by the user section and accordingly the work completion cum suitability report will be send to the Accounts section for releasing the payment due on actual basis.
- The payment will be sent directly to bidder's bank account as per bank details given by the firm.
- 2. The payment due to the bidder shall be at actual basis and in case of shortfall in the attendance the penalty will be deducted proportionately for the 'NO MAN' period during the billing period. In c ase of non- satisfactory work/service performance by the bidder an additional penalty/deduction w ill be made applicable as finalised by the committee appointed by ISP and the decision of the com

mittee will be final & binding on the successful bidder.

- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

This Bid is governed by the <u>General Terms and Conditions/सामान्य</u> नियम और शर्तें, conditions stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace.
