The details are as under:

- 9. TECHNICAL REQUIREMENTS FOR "EMPANELMENT OF VENDORS FOR EXECUTION OF VARIOUS CIVIL REPAIR WORKS":

A) CARPENTRY WORKS (Wood work, aluminium work, etc.):-

- i) Repairs to door, window shutters.
- ii) Repairs, replacement of defective door frame.
- iii) Replacement of broken glass panes.
- iv) Repairs, replacement of wooden railing, partition, weather sheds, wicket gate, roof rafter, battens, eaves boards, vertical supports etc.
- v) Fixing of SS/Nylon mosquito mesh to windows, doors, etc.
- vi) Replacement of defective roof gutter, AC sheets.
- vii) Replacement of defective door, window fittings like Aldrop, tower bolts, hinges, handles, stoppers, eye hooks, etc.
- viii) Fixing of GI sheet, plywood to railings, partitions.
- ix) Repairs replacement of defective plain cement sheet false ceiling. Replacement of defective wooden beading of false ceiling, door, windows frames, etc.
- x) Replacement of broken/defective north light glass of roof.
- xi) Sealing joints of cracked roofing sheets.



- xii) Making various types of industrial furniture like wooden table, chairs, cupboards, racks, file racks as per requirement & fixing of its fittings.
- xiii) Making of wooden cabins, partitions, display stands, trolley boards, trays, wooden strips for separating paper rims.
- xiv) Repairs to existing furniture items & its fittings.
- xv) Replacement of defective furniture fittings like hinges, tower bolts, door closers, door stoppers, etc. as per its requirement.
- xvi) Repairs to aluminium cabins, false ceiling, aluminium doors, replacing its defective fittings, particle boards, etc.
- xvii) Making & fixing display boards of various size as per requirement.

B) MASONRY WORKS:-

- i) Repairs to damaged cemented floor, concrete floor.
- ii) Repairs/making internal, external wall plaster.
- iii) Uprooting of wild plants grown over walls, roof of building with necessary civil repair work.
- iv) Construction of new chambers, repairs to chambers of sewer, water supply, storm water drain networks.
- v) Making foundation pits for compound wall, sheds, gate post, equipments & casting the same for erection of it.
- vi) Removing of defective door frames, fixing of door frames with necessary civil repair work.
- vii) Replacement of broken/defective squatting (Indian or European) urinal pot, kitchen kadappa, sink etc.
- viii) Replacement broken defective floor/wall tiles of rooms, toilets etc.
- ix) Providing & fixing partitions of urinals.
- x) Arresting roof leakages, from roof & roof gutter, seepages from toilet, bathroom etc.
- xi) Repair, reconstruction of compound wall, repairs to stone wall pointing, coping, plastering etc.
- xii) Replacement of defective down take pipe of WC, bath, rainwater etc.
- xiii) Fixing of drain covers over storm water drain, sewer drain line chamber, gully chambers, etc.
- xiv) Breaking concrete floor, excavation of earth for repairs of underground water supply, drain line, chambers, etc. Carrying out its necessary civil repair work after repairs of pipe line/chamber.
- xv) Cleaning of accumulated tree leaves from roof, roof gutter, cleaning of downtake pipes.

C) PLUMBING WORKS:-

- i) Providing new water supply connection pipe line as per site requirement.
- ii) Replacement of defective underground or open water supply pipe line G.I., UPVC, CPVC, C.I. with its necessary fittings, C.I. mechanical joints, etc.
- iii) Replacement of defective or providing and fixing wash basin, flush tank, EWC Seat Cover, urinal pot, etc.
- iv) Replacement of defective fittings & providing plumbing fitting like pillar cock, bib cock, stop cock, waste coupling, angle cock, health faucet, ball cocks, ball valves, etc. as per site requirement.
- v) Replacement of defective Gunmetal valve, CI sluice valve, NR Valves, water meters, foot valve, etc.
- vi) Replacing defective or providing new PVC water storage tank with necessary plumbing inlet, outlet pipeline work.
- vii) Providing plumbing pipeline & its connections to AHU's, machines etc. as per site requirement.

D) PAINTING WORK:-

- i) Painting of new or old M.S., wooden, various items.
- ii) Making Surface preparation and carrying out Painting of various sections, corridors, quarters, buildings as per requirement.
- iii) Dusting, cleaning and removing cobwebs before painting of section.
- iv) Painting of boards, name boards indicators of UGC, ESR as per requirement.

E) DRAINAGE ATTENDANT

- i) Removing of choke-up of gully chamber, sewer drain line chamber.
- ii) Removing accumulated silt, soil from gully chamber, sewer drain line chamber.



- iii) Making rodding for removing of choke-up of main sewer drain line, branch line, etc.
- iv) Desilting removing accumulated soil, silt, garbage from storm water drain, its chambers for cleaning of stormwater drain, downtake pipe.
- v) Periodical checking and cleaning of toilets, urinals, canteens, various storm water outlet points.

F) BLACKSMITHY WORKS:-

- i) Making new MS doors, window grills, partitions, railing, brackets, weather sheds as per site requirement.
- ii) Removing of old MS cabins, frames, partitions, doors, windows, fencing, railings etc. as per site requirement.
- iii) Making MS trays, tables frames, trolley cages, platform, ladders, chamber covers, trench covers & various articles, etc. as per site requirement.
- iv) Repairs to existing MS door, windows, railing, partitions, aldrop, towerbolt, locking arrangement.
- v) Oiling & making free sliding doors of various sections.
- vi) Cutting of security plates, items for its disposal as per requirement.
- vii) Repairs/Replacement of M.S. roof gutters, downtake pipes, etc.

10. Pre-Qualification Criteria:

- (a) The intending bidders shall submit all technical details, capabilities, and experience for execution of similar type of "CIVIL REPAIR WORKS".
- (b) The intending bidders shall also submit duly filled Annexure attached with the EOI document.

11. Short Listing of the Bidders:

The Bidder shall be evaluated for short listing, inter-alia, based on their past experience of providing technology solutions in similar context, financial strength, technical capabilities etc. Each bidder will be assigned scores based on marks to each of the criteria in EOI. The bidders who secure the minimum required marks shall be shortlisted and empanelled.
