1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
2. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
3. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
4. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU / Public Listed Company for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.
5. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25%(selected by Buyer) percentage of total QUANTITY. 6. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
7. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 40% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU / Public Listed Company. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

A. Minimum Qualification Criteria:

1. **Experience & past performance:** The bidder should have manufactured and supplied Personal Prote

ctive Equipments of Rs. 99,951/- in anyone of the last five years ending on "31.03.2023".

Note: The 'Experience and Past Performance Criteria' is exempted for Startups and Micro and Small Enterprises. In case of any bidder is seeking exemption from Experience and Past Performance criteria, the supporting documents to prove his eligibility for exemption must be submitted for evaluation.

2. Capability, equipments and manufacturing facilities: The bidder or its Principal Manufacturer must have an annual capacity to manufacture and supply Personal Protective Equipments of at least Rs. 99,951/-. Undertaking regarding this requirement shall be submitted by the bidder on their Letter Head.

Note: At the discretion of the purchaser, the Capacity / Capability Assessment / Verification of bidder / manufacturer firm (s) might be undertaken by a committee or third party Technical Consultancy / Inspection agencies to ensure that the firm is / are identified and capable to supply the machine / item / material / product as required.

3. Financial Standing:

a) The average annual financial turnover of the bidder during the last three years, ending on '31.03.2023', should be at least Rs. 99,951/- as per the annual report (audited balance sheet and profit & loss account of relevant Financial Year shall be submitted for evaluation) of Financial Year 2020-21, 2021-22 & 2022-23 duly authenticated by a Chartered Accountant / Cost Accountant in India or equivalent in relevant countries.

Note: The Average Annual Turnover criteria are exempted for Start-ups and Micro and Small Enterprises. In case any bidder is seeking exemption from Turnover criteria, the supporting documents to prove his eligibility for exemption must be submitted for evaluation.

b) The bidder should not have suffered any financial loss for more than one year during the last three years ending on '31.03.2023'.

i) The net worth of the bidder should not be negative on 31.03.2023 and also

ii) Should not have eroded by more than 30% in the last three years, ending on '31.03.2023'.

4. Applicability of Special Cases

a) Authorized Representative: Bids of bidders quoting as authorised representative of a principal manufacturer would also be considered to be qualified, provided : i) their principal manufacturer meets all the criteria above without exemption, and ii) the principal manufacturer furnishes a legally enforceable tender specific authorisation in the prescribed form assuring full guarantee and warranty obligations as per the general and special conditions of contract: and iii) the bidder himself should have been associated , as authorised representative of the same or other Principal Manufacturer for same set of services as in present bid (supply, installation satisfactorily commissioning, after sales services as the case may be) for same or similar 'Product' for past three years.

b) For Existing successful Past Suppliers: In case the bidder (Manufacturer or principal of authorised representative) who is a successful past supplier of 'The Product' in at least one of the recent past three procurements, who do not meet any or more of requirements above would also be considered to be qualified in view of their proven credentials, for the maximum quantity supplied by him in such recent past . (this clause is not applicable for Security items as notified by Government of India from time to time).

c) Start-up Enterprises: Requirements of prior experience and turnover would be relaxed for Start-up enterprises as recognised by Department for Promotion of Industry and Internal Trade (DPIIT), subject to their meeting the quality and technical specifications. Such Start-ups may be either MSE or otherwise.

5. The Bidder shall give following undertakings on their Letter Head regarding this requirement.

i) Blacklisting: We <name of the firm> has not been blacklisted / debarred by any government agency / Public Sector Unit / Reputed organization.

ii) Agree to withdraw all deviations: "We <name of the firm> agree to withdraw all the deviations, if any, unconditionally and accept all the terms and conditions of the tender document including the technical specifications".

6. Liquidated Damages: If the Seller/Service Provider fails to deliver any or all of the Goods/Services within the original/re-fixed delivery period(s) specified in the contract, the Buyer will be entitled to deduct/recover the Liquidated Damages for the delay, unless covered under Force Majeure conditions aforesaid, @ 0.5 % of the contract value of delayed quantity per week or part of the week of delayed period as pre-estimate

d damages not exceeding 10% of the contract value of delayed quantity without any controversy/dispute of any sort whatsoever.

7. Payment Terms: 100% payment will be released within ten (10) days of issue of consignee receipt-cum-acceptance certificate (CRAC) and submission of bills unless otherwise specified in STC/ATC.

8. Manufacturer's Authorization Letter: In case the bidder firm/ bidder offers to supply Personal Protective Equipment which is manufactured by some other firm, the bidder has to be duly authorized by the manufacturer of the stated material to quote for and supply the same to India Security Press, a unit of SPMCL.
