- 1. 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

- 3. Qualification and eligibility criteria of Bid
- i) **Experience & Past performance:-** The Bidder should have experience of having successfully supplied the manpower services of 1498 man-days or should have supplied 05 Nos. of Unskilled Labours in any one of the last five years ending on 31st March 2023

Note: The 'Experience and Past experience criteria' is exempted for Startups and Micro and Small Enterprises.

- ii) **Capability:-** The bidder must have capability to provide the relevant services.
- iii) Financial standing:-
- a) The average annual financial turnover of the bidder during the last three years, ending on 31 ^t March 2023, should be at least Rs. 14 lakhs (or equivalent in foreign currency at exchange rate prevalent on 31st March 2023) as per the annual report (audited balance sheet and profit & loss account) of the relev ant period, duly authenticated by a Chartered Accountant/ Cost Accountant in India or equivalent in releva nt countries.

Note: The 'Average Annual Turnover criteria' is exempted for Startups and Micro and Small Enterprises.

- b) The bidder should not have suffered any financial loss for more than one year during the last three years, ending on 31st March 2023.
- c) (i) The net worth of the Bidder should not be negative on 31 st March 2023 and also should n ot have eroded by more than 30% in the last three years, ending on 31st March 2023..

Applicability in Special Cases

- i) Authorized Representatives: Bids of bidders quoting as authorised representative of a principal man ufacturer would also be considered to be qualified, provided: i) their principal manufacturer meets all the c riteria above without exemption, and ii) the principal manufacturer furnishes a legally enforceable tender-s pecific authorisation in the prescribed form assuring full guarantee and warranty obligations as per the ge neral and special conditions of contract; and iii) the bidder himself should have been associated, as authori sed representative of the same or other Principal Manufacturer for same set of services as in present bid (s upply, installation, satisfactorily commissioning, after sales service as the case may be) for same or similar 'Product' for past three years ending on '31.03.2021'.
- **ii)** For Existing successful Past Suppliers: In case the bidder (manufacturer or principal of authorised r epresentative) who is a successful past supplier of 'The Product' in at least one of the recent past three pr ocurements, who do not meet any or more of requirements above, would also be considered to be qualified in view of their proven credentials, for the maximum quantity supplied by him in such recent past. (This clause is not applicable for Security Items as notified by Government of India from time to time.)

- **iii) Joint Ventures and Holding Companies:** Credentials of the partners of Joint ventures cannot (repeat cannot) be clubbed for the purpose of compliance of PQC in supply of Goods/Equipment, and each partner must comply with all the PQC criteria independently However, for the purpose of qualifying the Financial Standing Criteria, the Financial Standing credentials of a Holding Company can be clubbed with only one of the fully owned subsidiary bidding company, with appropriate legal documents proving such ownership.
- 4. **Quantum of LD**:- If the Seller/Service Provider fails to deliver any or all of the Goods/Services within th e original/re-fixed delivery period(s) specified in the contract, the Buyer will be entitled to deduct/recover the Liquidated Damages for the delay, unless covered under Force Majeure conditions aforesaid, @ 0.5% of the contract value of delayed quantity per week or part of the week of delayed period as pre-estimated damages not exceeding 10% of the contract value of delayed quantity without any controversy/dispute of any sort whatsoever.

3. Certificates

- 3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
