- 1. OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

- (3) In case of an unincorporated association or body of individuals, the beneficial owner is the natural pers on(s), who, whether acting alone or together, or through one or more juridical person, has ownership of or entitlement to more than fifteen percent of the property or capital or profits of such association or body of individuals;
- (4) Where no natural person is identified under (1) or (2) or (3) above, the beneficial owner is the relevant natural person who holds the position of senior managing official.
- (5) In case of a trust, the identification of beneficial owner(s) shall include identification of the author of the trust, the trustee, the beneficiaries with fifteen percent or more interest in the trust and any other natural person exercising ultimate effective control over the trust through a chain of control or ownership
- (vi)An Agent is a person employed to do any act for another, or to represent another in dealings with third person.

XVIII) Quality Control Requirement

1. The Pre Delivery Inspection (PDI) of 160 KVA DG Set will carried out at manufacturer's facility, unless wa ived by the user section, by three representative of the ISP and the expenditure involved in their travelling , lodging & boarding will borne by the ISP.

- 2. During PDI, the DG Set will be inspected & tested by the representative of ISP and if any drawback/defici encies/shortfall/damages/nonconformity to relevant standards/non conformity to tender specifications etc. is/are pointed out, and then the same shall be rectified before dispatch to ISP and confirmed to ISP.
- 3. The other materials will be accepted on arrival at ISP based on quality inspection and manufacturers tes t reports to be submitted in triplicate along with the materials.
- 4. The guarantee terms in respect of all major materials shall be compulsorily mentioned in the technical b id and same shall be minimum Two year or as offered by the respective OEM, whichever is higher against t he design defects, manufacturing defects & bad workmanship as applicable.
- 6. On site O&M training shall be given to the operating & maintenance crew at free cost.
