- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
- 2. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
- 3. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant /

Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

- 4. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU / Public Listed Company for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.
- 5. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer)of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 100%(selected by Buyer) percentage of total QUANTITY. The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. 6. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 40% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU / Public Listed Company. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

A. Minimum Qualification Criteria

1. Experience & Past Performance:

The Bidder (manufacturer or principal of authorized representative-hereinafter referred simply as 'The Bid der') shall be a manufacturer that has regularly for at least the last Three (03) years manufactured and sup plied Commercial Heavy duty Food Gravy/Grinder Machine (Wet & Dry) with the same or higher specificati ons of at least one (01) number in last five (05) years ending on "31st March 2023". At least one (01) num ber of the product offered for supply should be in successful operation for at least one (01) year on the dat e of bid opening.

Note:

- i) Copies of PO's (before 31 March 2023) and completion/experience certificates issued by custom ers to be provided in support of above.
- **ii)** Start-ups and Micro and small Enterprises are exempted from Experience and Past Performance criteria. In case any bidder is seeking exemption from Experience and Past Performance criteria, the supporting documents to prove his eligibility for exemption must be submitted for evaluation.

2. Capability, equipment and manufacturing facilities:-

The Bidder firm must have an annual capacity to manufacture and supply at least (01) Number of Commer cial Heavy duty Food Gravy/Grinder Machine (Wet & Dry). The self-attested details shall be submitted alon g with bid.

Note: At the discretion of the purchaser, the Capacity / Capability Assessment / Verification of bidder / ma nufacturer firm(s) might be undertaken by a Committee or through a third-party Technical Consultancy / I nspection agencies to ensure that the firm is/are identified and capable to supply the machine/item/materi al/product as required.

3. Financial Standing:

a) The average annual financial turnover of the bidder during the last three years, ending on '31.03.2023', should be at least Rs. 30,562/- as per the annual report (audited balance sheet and profit & loss account) of Financial Year 2020-2021, 2021-2022 & 2022-2023 duly authenticated by a Chartered Accountant/Cost A countant in India or equivalent in relevant countries.

Note: The Average Annual Turnover criteria are exempted for Start-ups and Micro and Small Enterprises. In case any bidder is seeking exemption from Turnover criteria, the supporting documents to prove his eligibility for exemption must be submitted for evaluation.

- **b)** The bidder should not have suffered any financial loss for more than one year during the last three year s, ending on '31.03.2023''.
- i) The net worth of the Bidder should not be negative on '31.03.2023' and also
- ii) Should not have eroded by more than 30% in the last three years, ending on '31.03.2023'.

4. Applicability in Special Cases

a) Applicability to 'Make in India': Bidders (manufacturer or principal of authorized representative) If t

he product is being manufactured in India under a license from a foreign manufacturer who holds intellect ual property rights and where there is a technology collaboration agreement/ transfer of technology agree ment for indigenous manufacture of a product developed abroad with clear phased increase in local conte nt, and who while meeting allother criteria above, except for any or more of sub-criteria in Experience and Past Performance above, would also be considered to be qualified provided: i) their foreign manufacturer who holds intellectual property rights, meets all the criteria above without exemption, and ii) the Bidder su bmits appropriate documentary proof for technology collaboration agreement/ transfer of technology agreement for indigenous manufacture of a product developed abroad with clear phased increase in local content. iii) the bidder (manufacturer or principal of authorized representative) furnishes along with the bid a legally enforceable undertaking jointly executed by himself and such foreign Manufacturer for satisfactory manufacture, Supply (and erection, commissioning if applicable) and performance of 'The Product' offered including all warranty obligations as per the general and special conditions of contract.

- **b) Authorized Representatives:** Bids of bidders quoting as authorized representative of a principal man ufacturer would also be considered to be qualified, provided: i) their principal manufacturer meets all the c riteria above without exemption, and ii) the principal manufacturer furnishes a legally enforceable tender-s pecific authorization in the prescribed formassuring full guarantee and warranty obligations as per the gen eral and special conditions of contract; and iii) the bidder himself should have been associated, as authoriz ed representative of the same or other Principal Manufacturer for same set of services as in present bid (su pply, installation, satisfactorily commissioning, after sales service as the case may be) for same or similar 'Product' for past three years ending on '31.01.2023.
- c) For Existing successful Past Suppliers: In case the bidder (manufacturer or principal of authorized r epresentative) who is a successful past supplier of 'The Product' in at leastone of the recent past three pro curements, who do not meet any or more of requirementsabove, would also be considered to be qualified in view of their proven credentials, for themaximum quantity supplied by him in such recent past. (This clause is not applicable for Security Items as notified by Government of India from time to time.)
- **d) Joint Ventures and Holding Companies:** Credentials of the partners of Joint venturescannot (repeat cannot) be clubbed for the purpose of compliance of PQC in supply of Goods/Equipment, and each partner must comply with all the PQC criteria independently However, for the purpose of qualifying the Financial St anding Criteria, the Financial Standing credentials of a Holding Company can be clubbed with only one of the fully owned subsidiary bidding company, with appropriate legal documents proving such ownership.
- **e) Development/ insufficient market capacity or Exceptional One- Off Cases:** These are those ite ms which are either being newly developed where vendors are yet to be developed or for new/ existing ite ms where the capacity available in market is inadequate compared to our annual requirements. Exception al one-off cases are such items/ Plant & Machinery which are procured infrequently (say once in 3 years or longer periods). In such cases PQC should be Decided with the approval of CFA in individual cases.
- **f) Start-up Enterprises:** Requirements of prior experience and turnover would be relaxed for Start-up ent erprises as recognized by Department for Promotion of Industry and Internal Trade (DPIIT), subject to their meeting the quality and technical specifications. Such Start-ups maybe either MSE or otherwise.
- 5. The Bidder shall give following undertakings on their Letter Head regarding this requireme nt.
- i) The bidder firm should submit declaration that, "We <u>M/s. Name of the bidder firm</u> declare that the firm has not been blacklisted/ debarred by any government agency / Public Sector Unit/ Reput ed organization."
- ii) The bidder firm should submit declaration that, "We <u>M/s. Name of the bidder firm</u> agree to withdr aw all the deviations, if any, unconditionally and accept all the terms and conditions of the ten der document including the technical specifications".
- iii) The bidder has to provide the undertaking that "We <u>M/s. Name of the bidder firm</u> have read and a ccept all the terms & conditions of GIT & GCC of the Bid document".

6. Manufacturer's Authorization Letter and Original Equipment Manufacturer Letter: In case the bidder firm/ bidder offers to supply 'Commercial Heavy duty Food Gravy/Grinder Machine (Wet & Dry)', wh ich is manufactured by some other firm, the bidder has to be duly authorized by the manufacturer of the st ated material to quote for and supply the same to India Security Press, a unit of SPMCIL. The bidder shall s ubmit the manufacturer's authorization letter to this effect as per the standard form provided in "Buyer u ploaded ATC Document".

Note: One manufacturer can participate through one authorized agent or one agent can participat e on behalf of one Principal Manufacturer only. The Bidder has to supply OEM certificate with the following details wherever Authorized Bidder is submitting the bid, Authorization Form / Certificate with OEM/Original Service Provider details such as name, designation, address, e-mail Id and Phon e No. required to be furnished along with the bid.

B. Delivery Schedule & Quality Control Requirement (To be submitted on firm's Letter Head as a token of acceptance):-

1) **Delivery Schedule:-** The Successful bidder has to Supply the material at ISP within 2 months from the date of issue of Contract on FOR, ISP basis.

2) Quality Control Requirement:-

- i. The material supplied by the successful bidder will be accepted on manufacturer's conforming to all par ameters as per Technical Specification. The machine will be accepted on manufacturers guarantee certific ate to be sent to purchaser. If any defects observed or the machine is found unsuitable, then the same will be returned to the supplier for free replacement upto India Security Press, Nashik or the purchaser shall be entitled to cancel the contract, and if so desired, purchase or authorize purchase of the stores at the risk a nd cost of the contractor.
- ii. After receipt of goods, the goods will be inspected/tested at ISP. If any defect/variation is noticed then th e same will be replaced free of cost by the supplier/seller up to India Security Press, Nashik Road, failing w hich equivalent amount of defective material will be deducted in the subsequent bills or from any amount due to them.

<u>C. Special Conditions of Contract (SCC) (To be submitted on firm's Letter Head as a token of ac ceptance)</u>

- **1) Transportation of Goods:** The transportation of goods to be procured will be done by the supplier on FOR ISP Basis. The total cost of the transportation should be indicated in the price bid of the item to be procured.
- **2) Taxes and Duties:** Supplier shall be entirely responsible for all taxes, duties, fees, levies etc. incurred until delivery of the contracted goods to SPMCIL. If the tenderer fails to include taxes and duties as per law of the land in the tender, no claim thereof will be considered by purchaser at a later stage.
- **3) Terms and Mode of Payment:** 100% payment will be released within ten (10) days of issue of consig nee receipt-cum-acceptance certificate (CRAC) and on-line submission of bills. The payment will be done th rough online mode only. Therefore, the suppliers have to produce all the Bank details such as Name of Bank, Account No., IFSC Code No., MICR No. along with the Tender document. TDS, if any, will be deducted as applicable.

4) NOTE:

- 1. All experience, past performance and capacity/ capability related/ data should be certified by the author ized signatory of the bidder firm.
- 2. Decision on Finalization of tender will be taken based on the documents submitted along with the tende

- r. All documents must be submitted as per tender requirement failing which offers will be liable for rejectio n.
- 3. All the pages submitted are to be sealed & signed by Authorized Signatory failing which tender shall be treated as unresponsive.

- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
