Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.

5. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

6. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Buyer Added Bid Specific ATC

- ii. The bidder should not have suffered any financial loss for more than one year during the last three years, ending on 31.03.2023
- iii. The net worth of the Bidder should not be negative on 31.03.2023 and should not have eroded by more than 30% in the last three years, ending on 31.03.2023.

A) Authorized Representatives: Bids of bidders quoting as authorised representative of a principal man ufacturer would also be considered to be qualified, provided: i) their principal manufacturer meets all the c riteria above without exemption, and ii) the principal manufacturer furnishes a legally enforceable tender-s pecific authorization in the prescribed form assuring full guarantee and warranty obligations as per the ge neral and special conditions of contract; and iii) the bidder himself should have been associated, as authori zed representative of the same or other Principal Manufacturer for same set of services as in present bid (s upply, installation, satisfactorily commissioning, after sales service as the case may be) for same or similar 'Product' for past three years ending on '31.03.2023'.

C) Joint Ventures and Holding Companies: Credentials of the partners of Joint ventures cannot (repeat cannot) be clubbed for the purpose of compliance of PQC in supply of Goods/Equipment, and each partner must comply with all the PQC criteria independently However, for the purpose of qualifying the Financial St anding Criteria, the Financial Standing credentials of a Holding Company can be clubbed with only one of t he fully owned subsidiary bidding company, with appropriate legal documents proving such ownership.

2. **Delivery Schedule**: - Within 60 days from the date of issue of Contract.

6. Ministry of Finance, Department of Expenditure, Public Procurement Division, Orders (Public Procurement 1,2,3 and 4) F. No. 7/10/2021-PPD(1) dated 23.02.2023 (or any further amendme nts thereof) regarding eligibility of bidders from specified countries shall be applicable to this tender. Bidders are required submit the appropriate undertaking in this regard. Salient featur es of this are:

I. (c) An entity substantially controlled through entities incorporated, established or registered in such a country; or

(d) An entity whose beneficial owner is situated in such a country ; or

(e) An Indian (or other)agent or such an entity; or

(f) A natural person who is citizen of such a country; or

(g) A consortium or joint venture where any member of the consortium or joint venture fall un der any of the above.

IV. The beneficial owner for the purpose of (iii) above will be as under:

1. In case of a company or Limited Liability Partnership, the beneficial owner is the natural pe rson(s), who, whether action alone or together, or through one or more juridical person, has a controlling ownership interest or who exercises control through means.

Explanation-

a. " Controlling ownership interest" means ownership of or entitlement to more than twenty-f ive per cent. Of shares or capital or profits of the company;

b. "Control" shall include the right to appoint majority of the directors or to control the manag ement or policy decisions including by virtue of their shareholding or management rights or sh areholders agreements or voting agreements;

2. In case of a partnership firm, the beneficial owner is the natural person(s) who, whether ac ting alone or together, or through one or more juridical person, has ownership of entitlement t o more than fifteen percent of capital or profits of the partnership;

3. In case of an unincorporated association or body of individuals, the beneficial owner is the natural person(s), who, whether acting alone or together, or through one or more juridical per son, has ownership of or entitlement to more than fifteen percent of the property or capital or profits of such association or body of individuals;

4. Where no natural person is identified under (1) or (2) or (3) above, the beneficial owner is th e relevant natural person who holds the position of senior managing official;

5. In case of a trust, the identification of beneficial owner(s) shall include identification of the author of the trust, the trustee, the beneficiaries with fifteen percent or more interest in the trust and any other natural person exercising ultimate effective control over the trust throug h chain of control or ownership.

V. An agent is a person employed to do any act for another, or to represent another in dealin gs with third person.

VI. [To be inserted in tenders for Work contracts, including Turnkey contracts] The successful

bidder shall not be allowed to sub-contract works to any contractor from a country which shar es a land border with India unless such contractor is registered with the Competent Authority.

VII. The registration shall be valid at the time of submission of bid and at the time of acceptan ce of bid.

VIII. If the bidder was validly registered at the time of acceptance/placement of order, regist ration shall be a relevant consideration during contract execution.

3. Certificates

OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. Details of Service Centres near consignee destinations are to be uploaded along with the bid.

5. Generic

1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of
