- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
- 2. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria,

the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.

3. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

- 4. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU / Public Listed Company for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.
- 5. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer)of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25%(selected by Buyer) percentage of total QUANTITY. The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. 6. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 40% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU / Public Listed Company. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

Technical Specification:

- 1. Handheld Anilox proofer system comprising of
 - a. 02 nos. of easily exchangeable Ceramic made engraved Anilox roller with Hexagonal Cell struct ure having 160 lines/cm or 400 lpi, and approx. Cell volume of 7.5 cm3/m2
 - b. Rubber roller suitable for transfer of UV varnish/ ink
 - c. Suitable weight/spring loaded frame with handle
 - d. Doctor Blade assembly with minimum 5 nos. spare blades
- 2. The proofer system should be suitable for application of coating thickness of less than 2.5 GSM on paper substrate.
- 3. The proofer system should have minimum coating width of 70 mm.
- 4. Firm shall provide Screen count/lpi count certificate along with the equipment.
- 5. Firm shall provide suitable storage rack, storage case etc. for proper handling and storing of component s.

General Requirements:

- 1. Bidder shall produce a "Specification compliance certificate" for the equipment on a separate letterhead . The bidder shall clearly state deviations with respect to each of the technical specifications in tender doc ument, if any. If deviation is found out of scope of the tender, the firm shall be disqualified.
- 2. Equipment must be quoted with all the accessories including spares, tools, and consumables required fo r operation and troubleshooting of the system.
- 3. Full detailed specifications duly supported with pamphlets, detailed literatures etc. of the offered equip ment shall be enclosed with the technical bid.
- 4. Set of two copies of Operating manual in English language should be provided during the time of installation.
- 5. The display/ instructions of the equipment should be in English.
- 6. Reference list of customers to whom similar equipment is supplied shall be enclosed.

- 7. The address / contact details of the office / authorized dealers who will be responsible for after sales, ser vice / maintenance shall be clearly mentioned.
- 8. The bidder has to submit an undertaking for providing required spares and service for the next 10 years from date of FAC.
- 9. Scope of Supply for all Items shall include:
 - i) Equipment
 - ii) Installation, Commissioning & Testing
 - iii) Training
 - iv) Incidental services
 - v) Accessories required for sample preparation
 - vi) Other accessories considered necessary to make the proposal self- contained and complete for installation, commissioning & testing
- 10. Installation, commissioning and training should be carried out by an engineer who is certified by the manufacturer of the equipment to carry out the installation, commissioning & training of the equipment.
- 11. Successful Bidder has to prove that the equipment is fully complying with the technical specification of the equipment mentioned as in Section VII. It is the responsibility of the bidder to bring all the required tes t materials, consumables (if any) & standards to prove the performance of the equipment.
- 12. Repeatability, Reliability & reproducibility of the equipment should be proved by the successful bidder as per standard.
- 13. Successful Bidder has to demonstrate that the equipment is suitable for carrying out the tests using printing

Inks/coatings/other materials (as the case may be).

- 14. Installation, commissioning & training charges should be clearly specified separately and not included in the equipment cost.
- 15. Delivery & supply within 90 days from date of issue of the Purchase Order. The installation, commissio ning & training shall be

Completed within 10 days from the date of receipt of the equipment at Stores, India Security Press, Nashik Road for Corporate

R&D Centre. Nashik.

16. Minimum 1 year of warranty for the equipment should be provided from the date of issuing Final Acceptance Certificate by

Corporate R&D Centre.

The Firm shall be the minimum eligibility criteria for selection of bidders technically:-.

1. **Experience and past performance:** The bidder should have supplied Anilox Proofer or similar equipment or equipment with higher specification of at least worth Rs.1,19,200 /- to any firm in the last Five year ending with 31st March 2023.

Note: In proof of having fully adhered to minimum criteria attested copy of experience certificate/ Supply O rder/ Purchase Order issued by the parties to whom the material / service has been supplied /rendered.

Note: "MSEs and Startup firms are exempted for Experience and Past experience criteria".

2. **Capability:** The Bidder firm must have an annual capacity to supply Anilox Proofer or similar equipment or equipment with higher specification of at least Rs. 1,19,200/-. Undertaking regarding this requirement shall be submitted by the bidder on their Letter Head.

3. Financial standing:

(i) Average Annual Turnover of the Bidder firm during last three financial years i.e. 2020-2021, 2021-2022, and 2022-2023 should be atleast Rs.1,19,200/- as per the audited balance sheet and profit & loss account of the last three financial years i.e. 2020-2021, 2021-2022, and 2022-2023, duly authenticated by a Charte red Accountant/Cost accountant in India.

Note: "MSEs and Startup firms are exempted for Average Annual Turnover criteria".

- (ii) The bidder should not have suffered any financial loss for more than one year during the last three year s i.e. 2020-2021, 2021-2022 and 2022-2023.
 - a. The net worth of the bidder should not be negative on 31st March 2023.
 - b. The net worth should not have eroded by more than 30% in the last three years i.e., 2020-2021, 2021-2022, and 2022-2023.

4. Undertaking:

- (i). The firm should give undertaking that, "We have not been black-listed/ debarred for dealing wit h any Gov. Organization in the past".
- (ii). The firm should give undertaking that, "We agree to withdraw all the deviations, if any, uncond itionally and accept all the terms and conditions of the tender document including the technical spe cifications".
- 5. The terms and conditions, guidelines of SPMCIL Procurement Manual Version 2.0 will be applicable to thi s bid at any stage to avoid any conflict at later stage. Kindly refer GIT & GCC of SPMCIL Procurement Manual Version 2.0 for additional terms and conditions as per the links given below:

- 6. **Liquidated Damages**: If the Seller/Service Provider fails to deliver any or all of the Goods/Services wit hin the original/re-fixed delivery period(s) specified in the contract, the Buyer will be entitled to deduct/rec over the Liquidated Damages for the delay, unless covered under Force Majeure conditions aforesaid, @ 0. 5% of the contract value of delayed quantity per week or part of the week of delayed period as pre-estimat ed damages not exceeding 10% of the contract value of delayed quantity without any controversy/dispute of any sort whatsoever.
- 7. **Payment Terms:** 100% payment will be released within ten (10) days of issue of consignee receipt-cu m-acceptance certificate (CRAC) and submission of bills unless otherwise specified in STC/ATC.

8. Warranty

Warranty period of the supplied products shall be 1 years from the date of final acceptance of goods or aft er completion of installation, commissioning & testing of goods (if included in the scope of supply), at consi

gnee location. OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. Details of Service Centers near consignee destinations are to be uploaded along with the bid.

9. Applicability in Special Cases:

- i) **Authorized Representatives**: Bids of bidders quoting as authorized representative of a principal manu facturer would also be considered to be qualified, provided: i) their principal manufacturer meets all the cri teria above without exemption, and ii) the principal manufacturer furnishes a legally enforceable tender-sp ecific authorization in the prescribed form assuring full guarantee and warranty obligations as per the gen eral and special conditions of contract; and iii) the bidder himself should have been associated, as authoriz ed representative of the same or other Principal Manufacturer for same set of services as in present bid (su pply, installation, satisfactorily commissioning, after sales service as the case may be) for same or similar 'Product' for past three years ending on '31.03.2023'.
- ii) **For Existing successful Past Suppliers:** In case the bidder (manufacturer or principal of authorized r epresentative) who is a successful past supplier of 'The Product' in at least one of the recent past three pr ocurements, who do not meet any or more of requirements above, would also be considered to be qualified in view of their proven credentials, for the maximum quantity supplied by him in such recent past. (This clause is not applicable for Security Items as notified by Government of India from time to time.)
- iii) **Joint Ventures and Holding Companies:** Credentials of the partners of Joint ventures 5 / 8 cannot (r epeat cannot) be clubbed for the purpose of compliance of PQC in supply of Goods/Equipment, and each p artner must comply with all the PQC criteria independently However, for the purpose of qualifying the Fina ncial Standing Criteria, the Financial Standing credentials of a Holding Company can be clubbed with only one of the fully owned subsidiary bidding company, with appropriate legal documents proving such owners hip.
- 11. Manufacturer's Authorization Letter: In case the bidder firm/ bidder offers to supply 'Anilox Proof er', which are manufactured by some other firm, the bidder has to be duly authorized by the manufacturer of the stated material to quote for and supply the same to India Security Press, a unit of SPMCIL. The bidd er shall submit the manufacturer's authorization letter to this effect as per the standard form provided in "buyer uploaded ATC Uploaded document".

Note: One manufacturer can participate through one authorized agent or one agent can participate on beh alf of one Principal Manufacturer only.

- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process.
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
