- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band defined in relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.

i) Experience & Past performance:- The Bidder should have experience of having successfully complet ed similar kind of services for the value at least Rs. 12,40,000/- in any one of the last five years ending on 31st March 2023

Note: The 'Experience and Past experience criteria' is exempted for Startups and Micro and Small Enterprises.

ii) Capability:- The bidder must have capability to provide the relevant services.

Note: Bidder's capacity and capability may be verified (if necessary) by ISP.

iii) Financial standing:

(a) Average Annual Turnover of the bidder during the last three years, ending on 31.03.2023, should be at least Rs. 12,40,000/- as per the annual report (audited balance sheet and profit & loss account for FY 2020 -21, 2021-22 and 2022-23) of the relevant period, duly authenticated by a Chartered Accountant/Cost Accountant. Note: The 'Average Annual Turnover criteria' is exempted for Startups and Micro & Small Enterpri

ses.

Note: For MSEs and Start-ups (registered for the tendered item) all financial criteria shall be exempted.

- ii) The net worth of the Bidder should not be negative on 31.03.2023 and also
- iii) should not have eroded by more than 30% in the last three years, ending on 31.03.2023.
- Note 1: To ascertain this criteria net worth of initial and last financial year should be compared.

Note 2: The criteria for Capability, Equipment and Manufacturing facilities shall be applicable to all the bid der firms including MSEs and Startup Firms.

Applicability in Special Cases

- i) For Existing successful Past Suppliers: In case the bidder who is a successful past supplier of 'The P roduct' in at least one of the recent past three procurements, who do not meet any or more of requirements above, would also be considered to be qualified in view of their proven credentials, for the maximum quantity supplied by him in such recent past. - 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

This Bid is governed by the <u>General Terms and Conditions/सामान्य नियम और शर्ते</u>, conditions stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace.
