If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

The Bidder firm should meet following eligibility criteria to qualify in the Techno Commercial Bid:-

- **I)** For MSE/Start-up firm: Capability Equipment & Manufacturing Facilities: The bidder firm sh ould have capability to manufacture and supply Door Frame Metal Detector (DFMD) gates.
- **II) For other firm Experience and past performance:** The bidder firm may be Manufacturer/ Proven supplier/Authorized dealer or distributor of Door Frame Metal Detector (DFMD) gates or bid der may participate with manufacturing authorization form (issued by manufacturer of tendered it em).

III) Other Eligibility Criteria:

- a) Bidder must have full-fledged service network in Nashik, Maharashtra. Company to provide Contact Details (mobile no. and Company E-mail Ids) of service engineers employed for DFMD in Nashik. Proof of document to be attached viz. trade license etc. Bidder must have permanent Service Engineer in Nashik Branch area.
- b) Bidder or OEM must have Quality, Environment, Occupational Health & Safety Policy i.e. ISO 9001, ISO 14001 and ISO 450001. Supporting documents must be attached.
- c) Bidders should confirm availability of after sales service and spare parts for 7 years. All bidders should give an undertaking that they would render after sale service and supply of spares throughout the declared life of the equipment.

- d) Bidder has to Supply, Install, test, commissioning and handing over of the complete system to Indi a Security Press, Nashik as per delivery schedule.
 - **IV) For Existing successful Past Suppliers:** In case the bidder (manufacturer or principal of au thorized representative) who is a successful past supplier of 'The Product' in at least one of the recent past three procurements, who do not meet any or more of requirements above, would also be considered to be qualified in view of their proven credentials, for the maximum quantity supplied by him in such recent past. (This clause is not applicable for Security Items as notified by Government of India from time to time.)
 - **V) PAN:** The Bidder should be registered with the Income tax. Relevant proof in support shall be s ubmitted.
 - **VI) Goods & Service Tax Registration (GST):** The Bidder should be registered with Goods & Service Tax (GST). Relevant proof of registration Certificate shall be submitted.

VII) Undertaking:-

- a) The bidder has to provide the undertaking that "We M/s. <Name of the firm> have not been blacklisted by Government of India in the past".

- **VIII) Pre-Delivery Inspection:** The bidder will have to arrange for pre-delivery inspection for all t he DFMDs within 21 days from the date of issue of GeM Contract. The Pre-Delivery Inspection (PDI) will be carried out at manufacturer's facility (OEM) by one representative of the ISP and the expenditure involved in their travelling, lodging & boarding will borne by the ISP.
- **IX) Delivery Schedule: -** All the three DFMD must be delivered within 14 days from the date of c ompletion of PDI at OEM / manufacturer's site. Its installation must be completed within 7 days from the date of receipt of DFMD at ISP Store.
- **X) Warranty: -** Firm should provide on-site warranty for 03 years.

XI) Manufacturer's Authorization Letter:

- a) In case, the bidder is not a Manufacturer/Proven supplier/Authorized dealer or distributor of the offered material, then bidder has to submit the Manufacturing Authorization Form (issued by Manufacturer of tendered item).
- b) The bidder shall submit the manufacturer's authorization letter to this effect as per the standar

XII) Training: The bidder will have to arrange for two days detailed operation and maintenance training to the CISF and ISP officials of the user section at the premises of ISP free of cost.

XIII) Quantum of LD:- If the Seller/Service Provider fails to deliver any or all of the Goods/Service s within the original/re-fixed delivery period(s) specified in the contract, the Buyer will be entitled to deduct/recover the Liquidated Damages for the delay, unless covered under Force Majeure conditions aforesaid, @ 0.5% of the contract value of delayed quantity per week or part of the week of delayed period as pre-estimated damages not exceeding 10% of the contract value of delayed quantity without any controversy/dispute of any sort whatsoever.

XIV) Payment Terms: - The payment terms are 100% within 30 days after successful supply and installation of the item and acceptance of the same by ISP.

XV) Ministry of Finance, Department of Expenditure, Public Procurement Division, Orde rs (Public Procurement 1,2 and 3) F. No. 6/18/2019-PPD dated 23 rd/ 24th July 2020 (or a ny further amendments thereof) regarding eligibility of bidders from specified countries shall be applicable to this tender. Bidders are required submit the appropriate undertaking in this regard. Salient features of this are:

- (3) In case of an unincorporated association or body of individuals, the beneficial owner is the natural person(s), who, whether acting alone or together, or through one or more juridical person, has ownership of or entitlement to more than fifteen percent of the property or capital or profits of such association or body of individuals;
- (4) Where no natural person is identified under (1) or (2) or (3) above, the beneficial owner is the r elevant natural person who holds the position of senior managing official.
- (5) In case of a trust, the identification of beneficial owner(s) shall include identification of the auth or of the trust, the trustee, the beneficiaries with fifteen percent or more interest in the trust and a ny other natural person exercising ultimate effective control over the trust through a chain of cont rol or ownership
- (vi)An Agent is a person employed to do any act for another, or to represent another in dealings w ith third person.

- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of

this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
