#### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

#### 2. Buyer Added Bid Specific ATC

## **Buyer Added Bid Specific ATC**

The Bidder firm should meet following eligibility criteria to qualify in the Techno Commercial Bid:-

**I)** For MSE/Start-up firm: Capability - Equipment & Manufacturing Facilities: The bidder firm sh ould have capability to manufacture and supply of Signage Boards.

**II)** For other firm - Experience and past performance: The bidder firm may be Manufacturer/ Proven supplier/Authorized dealer or distributor of Signage Boards or bidder may participate with manufacturing authorization form (issued by manufacturer of tendered item).

Note:

i. Participating bidder needs to submit all related documents along with the bid. In case, t he bidder is a Manufacturer/Proven supplier/Authorized dealer or distributor of the offer ed material, bidder has to submit relevant documents for the same. In case, the bidder is not a Manufacturer/Proven supplier/Authorized dealer or distributor of the offered ma terial, then bidder has to submit the Manufacturing Authorization Form (issued by Manufacturer of tendered item).

**III)** For Existing successful Past Suppliers: In case the bidder (manufacturer or principal of au thorized representative) who is a successful past supplier of 'The Product' in at least one of the recent past three procurements, who do not meet any or more of requirements above, would also be considered to be qualified in view of their proven credentials, for the maximum quantity supplied by him in such recent past. (This clause is not applicable for Security Items as notified by Gover nment of India from time to time.)

IV) PAN: The Bidder should be registered with the Income tax. Relevant proof in support shall be

submitted.

**V) Goods & Service Tax Registration (GST):** The Bidder should be registered with Goods & Service Tax (GST). Relevant proof of registration Certificate shall be submitted.

#### VI) Undertaking:-

- a) The bidder has to provide the undertaking that "We M/s. <*Name of the firm*> have not been blacklisted by Government of India in the past".

VII) Delivery Schedule: - Within 30 days from the date of issue of GeM Contract.

VIII) Warranty: - Warranty for the period of one year.

**IX) Quantum of LD:-** If the Seller/Service Provider fails to deliver any or all of the Goods/Services within the original/re-fixed delivery period(s) specified in the contract, the Buyer will be entitled to deduct/recover the Liquidated Damages for the delay, unless covered under Force Majeure conditi ons aforesaid, @ 0.5% of the contract value of delayed quantity per week or part of the week of d elayed period as pre-estimated damages not exceeding 10% of the contract value of delayed quantity without any controversy/dispute of any sort whatsoever.

**X)** Payment Terms: - The payment terms are 100% within 30 days after successful supply and i nstallation of the item and acceptance of the same by ISP.

#### XI) Note regarding MSE and MII purchase preference:

#### For MSE Purchase Preference:

Instant bid is non- splitable / non-dividable in nature. Therefore, in case L1 is non-MSE then MSE fi rm quoting price within L1+15% band will be awarded full tendered quantity subject to matching t he L1 prices.

#### For MII Purchase Preference:

For goods and works where the requirements are not divisible in nature

a) Among all qualified bids, the lowest bid will be termed as L1. If L1 is 'Class-I local supplier', the c ontract will be awarded to L1.

b) If L1 is not 'Class-I local supplier' the lowest bidder among the 'Class –I local supplier', will be in vited to match the L1 price subject to Class-I local supplier's quoted price falling within the margin of purchase preference i.e. L1+20% band, and the contract shall be awarded to such 'Class-I local supplier' subject to matching the L1 price.

c) In case such lowest eligible 'Class-I local supplier' fails to match the L1 price, the 'Class-I local s upplier' with the next higher bid within the margin of purchase preference i.e. L1+20% shall be inv ited to match the L1 price and so on and contract shall be awarded accordingly. In case none of th e 'Class-I local supplier' within the margin of purchase preference matches the L1 price, the contra ct may be awarded to the L1 bidder.
