- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
- 2. Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Forms of EMD and PBG

Bidders can also submit the EMD with Account Payee Demand Draft in favour of

The system (set of system) should be capable of performing alternating magnetic field test and resonance frequency test as per following procedure:

Alternating Magnetic Field Test as per ISO /IEC 10373-6:2020 (E) and ISO / IEC 14443-1:2018, 4.4

The procedure is as follows:

- In accordance with the PICC class, adjust the RF Power delivered by the signal generator to the Test PCD antenna to a field strength of 1.5 A/m to 7.5 A/m (both are rms values) and peak should go up to 12 A/m.
- Place the PICC under test in the DUT position and re-adjust immediately the RF drive into the Test PCD a ntenna to the required field strength if necessary.
- c) After 5 min, remove the PICC from the DUT position for at least 5 s.
- In accordance with the PICC class, adjust the RF power delivered by the signal generator to the Test PCD d) antenna to field strength of the maximum level as specified above (refer point a) as measured by the calib ration coil.
- Place the PICC under test in the DUT position and re-adjust immediately the RF drive into the Test PCD A ntenna to the required field strength if necessary.

- f) Apply for 5 min an ASK 100% modulation to this field with the following duty cycle:
 - 5 s at 0 A/m (rms)
 - ii) 25 s at the maximum level as specified above (refer point a).
 - 2. Instrument should be provided with:
 - i) Calibration Certificate
 - ii) Minimum 3 years warranty certificate
 - iii) Training at the time of installation at ISP
 - iv) Operational Manual
 - **II)** Experience and Past Performance: The bidder (manufacturer or principal of authorized representati ve hereinafter referred simply as 'The Bidder') shall be a manufacturer that has regularly for at least the I ast three years manufactured, supplied, erected and commissioned System to perform Alternating Magnet ic Field test and Resonance Frequency Test with same or higher specification of at least one (01) nos. in an y one of the last five years ending on 31st March 2023. At least one number of the product offered for sup ply should be in successful operation for at least one year on the date of bid opening.

VIII) Delivery Schedule: Within 15 days from date of issue of GeM Contract.

IX) Warranty: Firm should provide 3 years warranty on the system procured for performing MFT and RFT.

X) Applicability in Special Cases:

- i) Authorized Representatives: Bids of bidders quoting as authorized representative of a principal manufac turer would also be considered to be qualified, provided: i) their principal manufacturer meets all the criter ia above without exemption, and ii) the principal manufacturer furnishes a legally enforceable tender-speci fic authorization in the prescribed form assuring full guarantee and warranty obligations as per the general and special conditions of contract; and iii) the bidder himself should have been associated, as authorized r epresentative of the same or other Principal Manufacturer for same set of services as in present bid (suppl y, installation, satisfactorily commissioning, after sales service as the case may be) for same or similar 'Pro duct' for past three years ending on '31st March 2023'.

- (1) "Controlling ownership interest" means ownership of or entitlement to more than twenty-five per cent of shares or capital or profits of the company.
- (2) In case of a partnership firm, the beneficial owner is the natural person(s) who, whether acting alone or together, or through one or more juridical person, has ownership of entitlement to more than fifteen percent of Capital or profits of the partnership.
- (3) In case of an unincorporated association or body of individuals, the beneficial owner is the natural pers on(s), who, whether acting alone or together, or through one or more juridical person, has ownership of or entitlement to more than fifteen percent of the property or capital or profits of such association or body of individuals;
- (4) Where no natural person is identified under (1) or (2) or (3) above, the beneficial owner is the relevant natural person who holds the position of senior managing official.
- (5) In case of a trust, the identification of beneficial owner(s) shall include identification of the author of the trust, the trustee, the beneficiaries with fifteen percent or more interest in the trust and any other natural person exercising ultimate effective control over the trust through a chain of control or ownership (vi)An Agent is a person employed to do any act for another, or to represent another in dealings with third person.

- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
