**VIII) Warranty:** - Firm should give 1 year warranty for the offered product.

**IX) Quantum of LD:-** If the Seller/Service Provider fails to deliver any or all of the Goods/Services within the original/re-fixed delivery period(s) specified in the contract, the Buyer will be entitled to deduct/recover the Liquidated Damages for the delay, unless covered under Force Majeure conditions aforesaid, @ 0.5% of the contract value of delayed quantity per week or part of the week of delayed period as pre-estimated damages not exceeding 10% of the contract value of delayed quantity without any controversy/dispute of any sort whatsoever.

**Description of the Item :**

Digital Photo Polymer plates for CTOP water washable plant for Security Printing on Dry offset high speed machines.

4. The Plate shall consist of light sensitive photopolymer plastic firmly pasted to base material.

7. Developing time shall not exceed more than 15 minutes.

**General Conditions :**

8. To examine the Digital Photo Polymer plates during developing, the proper visibility is essential to differentiate the relief area and base of the plate.
9. After drying and post exposure, the plates shall have very good resistance to the wear & tear and breaking to ensure maximum number of impressions.
10. The Digital Photo Polymer Plates shall be suitable for use in Dry Offset printing machines for printing in high speed with sharp image and long run.
11. Packing : Plates shall be properly packed with suitable with suitable light - proof / water- proof covering material containing 10 Nos. of Plates per box.

While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws./जेम की सामान्य शर्तों के खंड 26 के संदर्भ में भारत के साथ भूमि सीमा साझा करने वाले देश के बिडर से खरीद पर प्रतिबंध के संबंध में भारत के साथ भूमि सीमा साझा करने वाले देश का कोई भी बिडर इस निविदा में बिड देने के लिए तभी पात्र होगा जब वह बिड देने वाला सक्षम प्राधिकारी के पास पंजीकृत हो। बिड में भाग लेते समय बिडर को इसका अनुपालन करना होगा और कोई भी गलत घोषणा किए जाने व इसका अनुपालन न करने पर अनुबंध को तत्काल समाप्त करने और कानून के अनुसार आगे की कानूनी कार्रवाई का आधार होगा।
