#### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

#### 2. Forms of EMD and PBG

Bidders can also submit the EMD with Account Payee Demand Draft in favour of

At least one number of t he product offered for supply should be in successful operation for at least one year on the date of bid opening.

- ii) Start-ups and Micro and small Enterprises are exempted from Experience and Past Performance criteria. In case any bidder is seeking exemption from Experience and Past Performance criteria, the supporting documents to prove his eligibility for exemption must be submitted for evaluation.

#### 2. Capability, Equipment & Manufacturing Facilities:

The bidder firm have an annual capacity to supply at least 1 No. of New Wired Addressable Fire detection and Alarm System of the requirement.

# 3. Financial Standing:

- i) The average annual financial turnover of the bidder firm (manufacturer of principal of authorized dealer) during the last three years, ending on 31<sup>st</sup> March 2023, should be at Rs.44,98,1 00/- as per the annual report (audited balance sheet and profit & loss account) of the relevant period duly authenticated by a Chartered Accountant/ Cost Accountant in India.
- ii) The net worth of the firm should:
  - a) not be negative on 31st March 2023 and
  - b) Not have eroded by more than 30% in the last three years, ending on 31st March 2023.

#### Note:

- 1: To ascertain this criteria net worth of initial and last financial year shall be compared.
- 2: For MSEs and Start-ups (registered for the tendered item) all financial criteria shall be exe mpted. However, its capacity and capability may be verified (if necessary) by the ISP.

#### 4. Applicability in Special Cases:

- a) Applicability to 'Make in India': (manufacturer or principal of authorised representa tive) If the product is being manufactured in India under a license from a foreign manuf acturer who holds intellectual property rights and where there is a technology collabora tion agreement/ transfer of technology agreement for indigenous manufacture of a pro duct developed abroad with clear phased increase in local content, and who while mee ting all other criteria above, except for any or more of sub-criteria in Experience and Pa st Performance above, would also be considered to be qualified provided: i) their foreig n manufacturer who holds intellectual property rights, meets all the criteria above with out exemption, and ii) the Bidder submits appropriate documentary proof for technolog y collaboration agreement/ transfer of technology agreement for indigenous manufactu re of a product developed abroad with clear phased increase in local content. Iii) the bi dder (manufacturer or principal of authorised representative) furnishes along with the bid a legally enforceable undertaking jointly executed by himself and such foreign Man ufacturer for satisfactory manufacture, Supply (and erection, commissioning if applicab le) and performance of 'The Product' offered including all warranty obligations as per th e general and special conditions of contract.
- b) **Authorized Representatives**: Bids of bidders quoting as authorised representative of a principal manufacturer would also be considered to be qualified, provided: i) their principal manufacturer meets all the criteria above without exemption, and ii) the principal manufacturer furnishes a legally enforceable tender-specific authorisation in the prescribed form assuring full guarantee and warranty obligations as per the general and special conditions of contract; and iii) the bidder himself should have been associated, as authorised representative of the same or other Principal Manufacturer for same set of services as in present bid (supply, installation, satisfactorily commissioning, after sales service as the case may be) for same or similar 'Product' for past three years ending on 31.03.2023..

- d) **Joint Ventures and Holding Companies**: Credentials of the partners of Joint venture s cannot (repeat cannot) be clubbed for the purpose of compliance of PQC in supply of Goods/Equipment, and each partner must comply with all the PQC criteria independently However, for the purpose of qualifying the Financial Standing Criteria, the Financial Standing credentials of a Holding Company can be clubbed with only one of the fully own ed subsidiary bidding company, with appropriate legal documents proving such owners hip.
- e) **Start-up Enterprises**: Requirements of prior experience and turnover would be relax ed for Start-up enterprises as recognised by Department for Promotion of Industry and Internal Trade (DPIIT), subject to their meeting the quality and technical specifications. #### 5. Other Eligibility requirements for the Bidders:

- **5.1** The bidder shall submit Local Content details as per clause No. 9; Verification of Local cont ent, of Public procurement (Preference to make in India) order 2017 No. P-45021/2/2017-PP(BE-II) & as per section X; Tender form clause no. 2. Make in India Status; it is requested to provide a certificate from statutory auditor or cost auditor of your company.
- **5.2** The bidder has to submit Power of Attorney/ Authorization indicating that authorized signa tory is competent and legally authorized to submit the tender and / or enter into legally binding c ontract.

#### **5.3** Manufacturer's Authorisation Letter :

- a) Wherever Authorised Distributors/service providers are submitting the bid, Authorisation Form /Certificate with OEM/Original Service Provider details such as name, designation, address, e-mail Id and Phone No. required to be furnished along with the bid.

- **6.1 Delivery Schedule: -** The successful bidder shall dismantle the existing wireless fire Alarm s ystem and supply, install, test and commission & training shall be completed within 150 days from the date of award of contract.
- 6.2 Mode of Delivery: FOR ISP, Nashik Road, Nashik (Maharashtra) duly unloading at Site.

# **6.3 Pre Dispatch Inspection:**

- (1) The PDI of all the components of Fire Detection and Alarm System will be carried out at manuf acturers or OEM facility by three authorized representatives of ISP and the expenditure incurred in travelling, boarding and lodging will be borne by ISP.
- (2) During PDI, if any deviation, damage and non-conformity to the relevant standards, nonconfor mity to tender specification etc. is/are pointed out, then the same shall be rectified with confirmati on before dispatch to ISP.
- **7. Quantum of LD:-** If the Seller/Service Provider fails to deliver any or all of the Goods/Services within the original/re-fixed delivery period(s) specified in the contract, the Buyer will be entitled to deduct/recover the Liquidated Damages for the delay, unless covered under Force Majeure conditi ons aforesaid, @ 0.5% of the contract value of delayed quantity per week or part of the week of d elayed period as pre-estimated damages not exceeding 10% of the contract value of delayed quantity without any controversy/dispute of any sort whatsoever.
- 8. General Condition of Contract (GCC):
- **8.1 Packing and Marking**: As per Technical Specifications of the tender document.

- **8.2 Transportation of Goods:** The transportation of goods to be procured will be done by th e supplier on FOR ISP Basis. The total cost of the transportation should be indicated in the price bid of the item to be procured.
- **8.3 Inspection and Quality Control**: As per Technical Specification.
- a) The entire fire alarm system will be field tested in accordance with the applicable standards in p resence of the representatives of ISP. Contractor has to inform to ISP regarding successful installat ion of entire Fire alarm system.
- b) FAT will be started after the successful SITC of Fire Alarm System for minimum 10 working days to check scope of work, technical specifications as per P.O, compliance with National and Internati onal Standards including Directorate of Maharashtra Fire Services in presence of ISP representatives & Contractor representatives and its performance will be recorded in a report.
- c) All test equipment, instruments, tools and labour required during the FAT shall be provided by the contractor.
- d) At least one half of the all tests shall be performed on battery standby power.
- e) During FAT Trial, if performance of Fire Alarm System found unsatisfactory, then the firm has to do necessary modifications to make the Fire Alarm system working in healthy condition without an y extra cost to ISP. Again-retrial, from starting will be carried out. Based on the performance of Fir e Alarm system during FAT trial suitability will be given.
- f) After the successful FAT, the firm will hand over the system with necessary training to ISP & CISF Fire Wing Personnel's.
- g) The supplier shall provide at least 10 working days free of cost training regarding operation & maintenance to personnel of ISP and CISF Fire Wing after acceptance (FAT) of SITC of New Wired Addressable Fire Detection & Alarm System.

# 9. Payment Terms: -

ral person(s), who, whether acting alone or together, or through one or more juridical person, has ownership of or entitlement to more than fifteen percent of the property or capital or profits of such association or body of individuals;

- (4) Where no natural person is identified under (1) or (2) or (3) above, the beneficial owner is the r elevant natural person who holds the position of senior managing official.
- (5) In case of a trust, the identification of beneficial owner(s) shall include identification of the auth or of the trust, the trustee, the beneficiaries with fifteen percent or more interest in the trust and a ny other natural person exercising ultimate effective control over the trust through a chain of cont rol or ownership
- (vi)An Agent is a person employed to do any act for another, or to represent another in dealings w ith third person.
