TECHNICAL REQUIREMENTS FOR AC INFRASTRUCTURE FOR NEW E PASSPORT LINE IN NEW WING

- i. Supply & installation of 2 Nos AHUs of 22000 CFM; 61TR capacity.
- ii. Supply & Installation of Ducting (supply & return) approximate 15000 Sq.Ft.
- iii. Supply & Installation of chilled water piping with supports (supply & return) 10"Dia x 94 Mtr Length.
- iv. Supply & Installation of Diffusers, Dampers, valves.
- v. Supply & Installation of Electrical panel, power cables & control cables from the 700 TR Plant to new AHUs.
- vi. Electrical panel unity Power Factor with harmonics control and arrangement of Display and Recording data of Power consumption
- vii. Electrical panel should be equipped with proper cooling arrangement.
- viii. All bus bar and cables shall be copper.
- ix. Electrical motors: IE3 and above

The intending bidders shall submit all technical details, capabilities, and experience for Design, Supply, Installation, Testing and Commissioning of similar type of Air Handling Units (AHUs).

(c) The firm should confirm their annual installed capacity for supply of "SITC of Air Handling Units (AHUs)".
