- 1. #### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

#### 2. Buyer Added Bid Specific ATC

#### **Buyer Added Bid Specific ATC**

The Bidder firm should meet following eligibility criteria to qualify in the Techno Commercial Bid:-

- I) For MSE/Start-up firm: Capability Equipment & Manufacturing Facilities: The bidder firm should ha ve capability to manufacture and supply of similar spares such as AC Drive Unwinder, AC Drive Infeeder, AC Drive Main Motor, AC Drive TTNV feeder, Encoder card, IO card, Power Supply, Inverter Drive.

- **III) For Existing successful Past Suppliers:** In case the bidder (manufacturer or principal of authorized representative) who is a successful past supplier of 'The Product' in at least one of the recent past three pr ocurements, who do not meet any or more of requirements above, would also be considered to be qualified in view of their proven credentials, for the maximum quantity supplied by him in such recent past. - **V) Goods & Service Tax Registration (GST):** The Bidder should be registered with Goods & Service Tax (GST). Relevant proof of registration Certificate shall be submitted.

#### IX) Undertaking:-

- **XI) Delivery Schedule: -** The Supply and Installation shall be completed within 84 days from the date of i ssue of GeM Contract.
- XII) Warranty: Warranty for the period of one year.

**XIII)Quantum of LD:-** If the Seller/Service Provider fails to deliver any or all of the Goods/Services within the original/re-fixed delivery period(s) specified in the contract, the Buyer will be entitled to deduct/recove r the Liquidated Damages for the delay, unless covered under Force Majeure conditions aforesaid, @ 0.5% of the contract value of delayed quantity per week or part of the week of delayed period as pre-estimated damages not exceeding 10% of the contract value of delayed quantity without any controversy/dispute of any sort whatsoever.

**XIV) Payment Terms: -** The payment terms are 100% within 30 days after successful supply and installat ion of the item and acceptance of the same by ISP.

#### XV) Note regarding MSE and MII purchase preference:

#### **For MSE Purchase Preference:**

Instant bid is non-splitable / non-dividable in nature. Therefore, in case L1 is non-MSE then MSE firm quotin g price within L1+15% band will be awarded full tendered quantity subject to matching the L1 prices.

#### For MII Purchase Preference:

For goods and works where the requirements are not divisible in nature

- a) Among all qualified bids, the lowest bid will be termed as L1. If L1 is 'Class-I local supplier', the contract will be awarded to L1.
- b) If L1 is not 'Class-I local supplier' the lowest bidder among the 'Class -I local supplier', will be invited to match the L1 price subject to Class-I local supplier's quoted price falling within the margin of purchase pre ference i.e. L1+20% band, and the contract shall be awarded to such 'Class-I local supplier' subject to mat ching the L1 price.
- c) In case such lowest eligible 'Class-I local supplier' fails to match the L1 price, the 'Class-I local supplier' with the next higher bid within the margin of purchase preference i.e. L1+20% shall be invited to match the L1 price and so on and contract shall be awarded accordingly. - (4) Where no natural person is identified under (1) or (2) or (3) above, the beneficial owner is the relevant natural person who holds the position of senior managing official.
- (5) In case of a trust, the identification of beneficial owner(s) shall include identification of the author of the trust, the trustee, the beneficiaries with fifteen percent or more interest in the trust and any other natural person exercising ultimate effective control over the trust through a chain of control or ownership
- (vi)An Agent is a person employed to do any act for another, or to represent another in dealings with third person.
